1. Introduction

Petroleum, the major feedstock into the petrochemical industry is a depleting natural resource. The rapid growth in world population, coupled with the increasing standard of living means that the petroleum reserves, which although they appear vast (Cheschire & Pavitt, 1978), are still limited and fast running out. Secondly, petroleum is the main source of fuel for the increasing number of automobiles, with the effect that the greenhouse gases generated have already exceeded threshold values. The continuous exploitation of petroleum has led to immense degradation of the environment as is observed in oil spills, and erosion in oil producing areas. There is the need to look for alternative sources of fuel and petrochemical feedstock.

Another problem associated with the increasing world population is the need to grow more food to match the population growth. This need gives rise to increased agricultural activities and food processing which result in the generation and accumulation of large amounts of organic wastes in the form of biomass residues, and consequently, municipal refuse which exacerbates environmental degradation. Appropriate disposal of these wastes is a major problem that requires urgent and long lasting solutions.

Over the years, land filling and incineration have been used to dispose of municipal and agricultural wastes. These methods did not raise any major concerns in the past because of the extremely low rates of waste generation at the time. Today, the large amounts of the greenhouse gases, particularly CO and CO₂ from incineration, and ground water contamination from landfills can no longer be ignored.

These problems are best solved by applying modern waste management techniques. Good management practices aim at reducing the rate of exhaustion of the resource base, rather than increase or even sustain the rate of consumption (Mitchell, 1995). These waste management techniques entail that, waste generation is avoided as much as possible by either reusing waste, combustion to heat energy, and then disposing of the resulting residue by the least environmentally damaging methods.

Studies have shown that the biomass component in waste, predominantly of cellulosic materials, is a heavy energy carrier. For example, Ngomo (2004) estimated that in

Cameroon, 1,148.77 PJ of energy, equivalent to 41,325 million kWh of electricity could be harvested annually from the theoretical harvestable biomass wastes arising from agricultural waste, forest residue, and livestock dung.

As early as 1917, the need to obtain chemicals from cellulosic materials had already been eminent. For example, Palmer & Cloukey (1918) in producing alcohol from various species of hardwoods studied the effect of moisture content in the wood on alcohol yield. By destructively distilling beech, yellow birch and maple that had been subjected to seasoning for between 4 and 18 months they observed that beech gave high alcohol yields when the moisture content was high, while excess moisture lowered the yields for yellow birch and maple.

Palmer (1918) used phosphoric acid to catalyse the destructive distillation of hardwoods. Working at both atmospheric pressure, and at elevated pressures of 412 – 712 kN/m², they saw that phosphoric acid increased the yields of alcohol at atmospheric pressure. Hawley (1922) continued the work of Palmer by studying the effect of various chemicals as catalyst. Working at atmospheric conditions, he found phosphoric acid to be unstable; and that promising yields of alcohol were obtained by using sodium carbonate, sodium silicate, and calcium carbonate. In an attempt to produce liquid fuels from cellulose, Fierze-David (1925) arrived at the following results and conclusions: hydrogen had no effect on the dry distillation of wood even under high pressure and that it acted just as an inert gas improving on the mechanism of the reaction; copper hydroxide, iron hydroxide and nickel hydroxide catalysed the distillation of cotton cellulose at 450 - 470°C and 150 - 245 atm. to give a distillate consisting of aldehydes, ketones, phenols, cyclic glycols, and fatty acids.

As reported in Henze et al (1942), Bowen et al (1925) re-iterated the importance of catalyst in the liquefaction of cellulose by concluding that cotton yarn did not undergo any appreciable reduction when treated with hydrogen at 440°C and 12,360 - 13,390 kN/m². However, when impregnated with nickel salts, almost the whole material was converted to liquids and gases under the same pressure and temperature conditions. The liquid produced was an opaque viscous tar, containing carboxylic acids, phenols and neutral oils. Frolich et al (1928) also observed that high temperature, high pressure and catalyst were necessary for converting sulphite pulp to liquid and gases. The liquid products consisted of phenols, saturated and unsaturated hydrocarbons.

From all these historical works, and the more recent one by Boocock et al (1980), we can deduce that:

- Cellulosic materials can be converted to a mixture of chemicals consisting of gases, liquids and solids;
- High pressure and high temperature in the presence of catalyst are essential for the conversion and the yield. In addition, the actual liquid yield depends on the extent of pressurizing, heating and the type of catalyst;
- The liquid mixture consists of a variety of substances, which can be used for the production of other chemicals.

Other more recent works applied high temperature and high pressure, but not the use of catalyst, to give the same types of products (El-Saied, 1977; Kaufmann and Weiss, 1975).

Cellulosic materials can be converted to oils and other chemicals by the methods of gasification, pyrolysis, hydrogenation, and hydrolysis and fermentation. Gasification converts the cellulosic materials to syngas (synthetic gas), which is a mixture of CO, H_2 , CO_2 and CH_4 . The reaction takes place at high temperatures of over $700^{\circ}C$ without combustion, and under a controlled amount of oxygen and/or steam. Gasification has the advantages that the syngas produced is a more efficient fuel than the original cellulosic material because it can be combusted at a higher temperature; syngas can be combusted directly in fuel cells and gas engines, and it can be used to produce methanol.

In pyrolysis, the cellulosics undergo an irreversible chemical change caused by heat in the absence of oxygen to give char, organic liquids and water. The reaction is endothermic. The heating value of the pyrolysis products is the sum of the heating value of original cellulosic material and net energy added during the pyrolysis process. In hydrolysis/fermentation, the pre-treated cellulosic material is first hydrolysed to glucose. The product is then converted to a mixture containing alcohols by fermentation, followed by distillation to obtain purer alcohols. The process of hydrogenation converts cellulosic materials to gaseous, liquid and solid products. The cellulosic material suspended in a slurry fluid, and in the presence of hydrogen is subjected to high pressure and heated to obtain the hydrogenation products.

The objectives of this work are to:

- convert cellulosic wastes to chemicals by the process of hydrogenation;
- deduce the mechanism for cellulose hydrogenation;
- deduce a rate expression for the process;
- assess the feasibility of the hydrogenation process by doing an energy economy analysis.

Cellulose, a high molecular weight polymer, with the formula $(C_6H_{10}O_5)_n$ is a structural polysaccharide derived from beta-glucose (Updegraff, 1969). It is the primary structural component in the cell wall of plants and trees. In plants, it is highly imbedded in lignin, which prevents it from being easily accessible.

Cellulose is insoluble in water and in neutral solvents such as gasoline, benzene, alcohol, ether and carbon tetrachloride. It is almost insoluble in dilute acids. In the presence of mineral acids of moderate strength, it degrades into glucose (Cheremisinoff, 1980). Oxygen is removed from cellulose as H_2O and CO_2 in the presence of high reducing agents such as H_2 and CO (Boocock et al, 1979). The close association of cellulose and lignin in plant biomass requires the use of drastic reaction conditions such as pressures above 100 atmospheres and temperatures of 250 – 400°C for their processing (Cheremisinoff and Morresi, 1977).

In batch systems, the reducing agents are generated in-situ by adding a little amount of water. Under the reaction conditions, the cellulose rings are cleaved by the reducing agents. Edewor (1980) represented the liquefaction reaction of cellulose broadly as involving the following steps:

Initiation: this is the shift reaction in which water reacts with a little amount of cellulose to give H_2 and CO_2 . This is followed by the generation of free radicals.

In the liquefaction step, the remaining cellulose is cleaved by the free radicals obtained from the H_2 and CO_2 to give a variety of products.

A deduction of the detailed reaction mechanism will be given in the kinetics part below (Section 4).

The major difference between hydrogenation and gasification or pyrolysis is that hydrogenation takes place in a liquid medium. The liquid used is called **slurry fluid**. The slurry fluid is used because, it minimises the charring of the cellulosic materials in favour of its conversion to liquid products. That is, the slurry fluid tends to shift the equilibrium towards the formation of liquid products, thereby reducing the amount of char produced. According to Kaufman and Weiss (1975), a slurry fluid should be thermally stable, have low vapour pressure, and good solvent activity. It should also be cheap and readily available. Water is not a good slurry fluid despite its cheapness and ready availability because it generates excessive steam pressures at high temperatures.

To illustrate the production of bituminous oils from cellulosic wastes, we report the experimentation procedures in the studies of Anagho et al (2004, and 2010) and Edewor (1980).

2. Experimental

2.1 Equipment

- Autoclave: half-litre, high pressure, magnetically-driven, and heated from the exterior by a 1,600 watt heater.
- Infrared spectrophotometer: Model Acculab 10, using NaCl discs.
- Gas chromatograph: Hittachi GC model Carle GC 9700 (Shimadzu, Kyoto, Japan).
- Product separation was obtained using a high temperature hydrocarbon column, Chromosorb G, AW, maintained at 180°C.
- The carrier gas was nitrogen flowing at 40 ml/min, and detection was by flame ionization.

2.2 Chemicals and materials

- The cellulosic materials included leaves, grass, cow dung, and municipal refuse. They were dried and pulverized.
- Gasoil was used as the slurry fluid.
- Hydrogen gas, supplied from a cylinder was used along with water to initiate the reaction.

2.3 Experimental procedure

2.3.1 Liquefaction

Each run used 100 g of slurry fluid, 20 g of dry pulverized cellulosic material, 1.2 g of water sealed into the autoclave, and pressurized to 30 kg/cm² by hydrogen. Heating was carried out for 3 hours. During heating, temperature and pressure were recorded over some time

intervals. After cooling down to room temperature, the reactor was opened and the masses of solids (char) and liquid determined by carrying out a material balance on the reactor.

2.3.2 Distillation and analyses of products

The freshly produced hydrogenation product was fractionated into five main fractions as shown in Table 1.

The freshly prepared hydrogenation product (Sample A) and the distillation fractions were analysed using infrared spectroscopy and gas chromatography to determine the types of chemicals generated from the liquefaction.

The Lassaigne's sodium fusion test was also carried out on all the product samples. It is a qualitative test used to show the presence of oxygen, nitrogen, sulphur and halogens in organic molecules. In this test, the element to be identified is first converted into an inorganic ionisable form which can be readily identified by inorganic tests.

In this study, a little quantity of sodium metal was put into a test tube containing a sample of synthetic fuel and heated to red hot to produce the ionisable compounds.

A representative equation for the test is:

The cyanide was analysed using iron (II) sulphate, while the hydroxide was by anhydrous copper sulphate (Anagho et al, 2010).

3. Results

3.1 Products yield

The masses of the different streams and for the various cellulosic materials are presented in Table 2 below.

The table shows that on the average, 40 per cent by mass of the dry cellulose is converted to synthetic oils by hydrogenation. Also, the amount of solid left for disposal is less than 50 per cent by weight of the dry cellulosic material.

3.2 Temperature and pressure evolution during heating

During heating, the temperature rose rapidly from room temperature to about 250°C, and this took about 75 minutes. As heating was continued, the temperature rose slowly to a value of between 300 and 325°C. It then remained constant with further heating.

The pressure in the reactor also increased with time of heating, but in a slightly different manner. Three sections could be identified (Anagho, 2004). The first section corresponded to the first 75 minutes, where there was very little increase in pressure. The increase in pressure may be attributed to pressure-temperature change at constant volume only. This period is regarded as the heat-up time. The second section was the period of rapid rise in pressure and was regarded as the reaction period, and it lasted 100 minutes on the average. The third was asymptotic. The rapid increase in pressure during the reaction period indicates that reaction is by free radical mechanism.

From the reaction time, the reaction rate for each cellulosic material was calculated. The heat-up time, the reaction time and the reaction rate are presented in Table 3 below. The rate of conversion of cellulose was calculated as the ratio of the amount of cellulose converted in gmol cellulose/m³ solution to the reaction time. (The molar mass of cellulose was taken as 162 g/mol.).

3.3 Analysis of hydrogenation products

IR spectroscopy analyses of the raw cellulose samples showed the presence of the O-H, C-C, C-O and C-N bonds for all the samples. The newly produced substances did not contain O

and N as they lacked the characteristic O-H and C-O bands between 3600 and 3100 cm $^{-1}$ and 1300 and 1000 cm $^{-1}$ respectively. This indicates that hydrogenation removes the oxygen from cellulose.

The presence of the saturated C=C bond and aromatics as depicted by the IR bands at 1600 and 1400 cm⁻¹, coupled with the GC analysis suggest that many types of compounds, such as aromatics, saturated and unsaturated hydrocarbons, both straight chained and cyclic were produced. When stored under light for some time, sediments formed in the originally homogeneous mixture, while oxygen and nitrogen reappeared to show that the hydrogenation products were unstable (Anagho et al, 2004).

The implication of these observations is that the hydrogenation of cellulose leads to the cleavage of the cellulose ring, followed by the removal of the oxygen in it. Hydrogenation also gives rise to unstable hydrocarbons, which when stored for some time regain oxygen to give saturated and unsaturated oxygenated compounds.

4. Kinetics of cellulose hydrogenation

4.1 Mechanism of the hydrogenation process and justification of the products type

As stated above, the cleavage of the cellulose ring during the hydrogenation process leads to the removal of oxygen, followed by the production of a mixture of products consisting of straight chain, branched chain and cyclic hydrocarbon compounds, some of which are saturated and others unsaturated. The process of hydrogenation takes place under high temperature and pressure, and leads to the cleavage of the cellulose ring to give products which are later rearranged to aromatic, naphthenic and unsaturated hydrocarbon compounds. This suggests that cellulose hydrogenation takes place through a free radical mechanism (Anagho, 1987). The cellulose ring is cleaved by the free radicals CO-, O- and H- obtained from CO₂ and H₂ generated in-situ from water and cellulose by the water gas shift reaction (Macrae, 1966a). These processes are shown by Equations 1 to 4 as follows:

The cleaved ring in Equation (4) further breaks down in various ways into a number of radicals (Equations 5 to 7):

Other radicals likely to have been generated are \dot{C}_2H_5 , \dot{C}_3H_7 , \dot{C}_4H_9 and \dot{C}_6H_5 .

During the termination reaction, the radicals recombine in diverse ways to give the many products identified by the infrared and GC analyses. For example, the small sized radicals combine to give H_2 , H_2O , CH_4 , and C_6H_6 as follows:

Aldehydes, ketones and alcohols are also formed as shown by Equations 9 to 11.

This is followed by the elimination of the OH group to form aliphatic compounds (Equations 12 and 13).

It is the elimination of the OH group from these oxygenated compounds that explains why the IR analyses on the freshly produced oils show the absence of oxygen. The saturated hydrocarbons, cyclo-hydrocarbons and aromatics can be formed when alkyl radicals combine as shown below in Equations 14, 15 and 16 respectively.

These equations show that the hydrogenation process can be likened to the processes of catalytic cracking and reforming of petroleum in which a variety of saturated, unsaturated, aromatic and naphthenic compounds are produced [Macrae, 1966b].

On storing for some time, the original hydrogenation product (Sample A) and fractions obtained from the atmospheric distillation of Sample A (Samples B to E) were seen to be unstable. They became darker in appearance and sediments were formed at the bottom of their containers. The heavier fractions obtained from the atmospheric distillation of the hydrogenation products exhibited these characteristics the most because it was noticed that the rate of darkening of the products and the formation of sediments appeared faster with the heavier fractions.

IR analyses of these samples led to the following observations:

All samples contained aromatics, with the heavier samples exhibiting more of this characteristic.

The heavier oils and bitumen fractions now contained O-H and C-O bonds to show the presence of oxygenated compounds. These groups were initially absent from the oils when they were just produced, to show that the bituminous oils were unstable and consequently very reactive. They picked up oxygen from the atmosphere during storage. The lighter oil fractions still did not contain oxygen.

The functional groups identified suggest the presence of substances such as benzene, anthracene, phenanthrene, alkenes and other saturated and unsaturated compounds. These compounds are olefins, aromatics and paraffins, which are all essential chemicals, used for the production of many bulk chemicals in the synthesis industry (Macrae, 1966b).

The above observations, that the oils are very reactive and contain substances similar to the essential chemicals used for synthesizing bulk chemicals suggest that the bituminous oils from cellulose or biomass hydrogenation can be used as precursors or feedstock into the petrochemical industries. They can be used as a major substitute or supplement for petroleum whose reserves are continuously being depleted.

The presence of unsaturated and aromatic compounds indicate that the severe reaction conditions for the hydrogenation process [Anagho et al., 2004] led to further breakdown and re-arrangement of the oils produced. This process could be likened to the processes of catalytic cracking and reforming.

4.2 Rate expression for cellulose hydrogenation

As stated earlier, the diverse nature of the products obtained from cellulose hydrogenation coupled with the uncontrollable rise in reactor pressure during the reaction period suggests that cellulose hydrogenation is by free-radical mechanism. In this section we deduce a mechanism for the reaction, from which a rate expression will be obtained. To determine the mechanism, the following assumptions are made:

 a. The initiation reaction is the generation of free radicals from CO₂ and H₂ obtained from the in-situ reaction of water and cellulose. The equations for the reactions are equations (2) and (3):

Since the bond energy of the C-O bond in CO_2 is 745 kJ/mol, and that for the H-H bond in H_2 is 436 kJ/mol (Arylward and Findlay, 1974), reaction 3 is considered the only initiation reaction.

b. The cleavage of the cellulose ring can take place at any of the C-C or C-O bonds. Although the C-C bond energy of 348 kJ/mol is lower than 358 kJ/mol for the C-O bond, the cleavage takes place at the C-O bond, because the values are quite comparable in magnitude, and the hydrogen has a higher affinity for oxygen than for

carbon. So if A is taken as a cellulose ring or molecule, and B^{\bullet} the radical after the removal of O, then,

c. The cleavage of the cellulose ring is the rate determining step, and our interest is in this step. Therefore, the radical B^{\bullet} does not undergo any further bond breakage into smaller radicals. Instead, the only other propagation reactions are those in which the radical B^{\bullet} sequentially gains H^{\bullet} radicals.

From these assumptions, the following mechanism is deduced.

Since $[H^{\bullet}]$ is much greater than $[BH_{2}^{\bullet}]$, the addition of H^{\bullet} radicals to BH_{2}^{\bullet} radicals occur faster than the addition of BH_{2}^{\bullet} radical onto itself. This means that k_{6} is negligible before k_{4} . From this, we have that,

After the cleavage of the cellulose ring, the termination reaction becomes dominant, and hence, k_1 becomes negligible before k_7 ; so the denominator of Equation (39) reduces to k_7 . Also, hydrogen pressure in the reactor is considered large and hence constant.

Therefore,

Equation (40) shows that cellulose hydrogenation is first order with respect to cellulose concentration. The reactor pressure increases as the cellulose reacts, to signify that the pressure in the reactor, P is proportional to the concentration of cellulose decomposed.

Equation (41) shows that the rate of cellulose hydrogenation is first order with respect to the total reactor pressure.

5. Economics of cellulose hydrogenation

In the former sections, we established that cellulosic wastes can be upgraded to synthetic fuels by hydrogenation. In this section we will be establishing that such a process is economically feasible. This will be done by carrying out an energy economy analysis. In an energy economy analysis, every cost incurred during a manufacturing process is converted to energy equivalent units.

5.1 Unit cost of production

Benn et al (1980) in an energy economy study considered that the unit cost on the production of synthetic oils was dependent on the three components energy, capital and labour.

Where X_fP_f = energy cost; X_cP_c = capital cost and X_IP_I = labour cost.

In this expression,

C = Total cost per unit of product,

 X_f = quantity of fuel (i.e. energy) needed per unit of product obtained,

 P_f = price per unit of energy,

 X_c = quantity of capital per unit of product,

 X_1 = quantity of labour per unit of product, and

 P_1 = price per unit of labour.

In the plant for cellulosic waste hydrogenation, labour cost, X_1P_1 includes the cost of transporting the wastes to the plant and the labour in the other aspects in the plant.

 X_fP_f is actually the on-site cost of the net energy requirement (NER). NER is part of the gross energy requirement (GER) of the process needed to give the required product less the calorific value (CV) of the product. That is,

The calorific value is the intrinsic energy of the product from the process. The ratio, NER/CV is the fraction of the product oil (in energy equivalents) that is used up during the conversion process. That is,

Hence, the net energy fraction recoverable from the process is $1 - X_f$.

As a first approximation, the cost of fuel for the process is equal to the total cost of producing the synthetic fuel. This is because more than 85% of the required fuel for the plant is generated locally. That is, $C \approx P_f$

Hence,

The equation shows that the cost per unit of product is the ratio of the nonfuel costs to the net energy yield. The equation also shows that no fuel is brought in from out of the plant, and that fuel inputs can be costed at the on-site value.

The values of X_f and C are determined from the energy equivalents of equipment and inputs into the plant. These components include capital equipment, electricity, chemicals, furnace, boiler and hydrogen plants, organic wastes and waste collection.

When the cost of a plant of a given capacity is known, then the cost of another of a different capacity can be found by using the seven-tenths rule given as:

The subscript, 1 stands for the reference plant, while subscript 2 stands for the new plant.

5.2 Energy requirements of plant and inputs

In the manufacture of the components of the capital equipment and chemicals, many processes are involved, each of which requires an energy input. The cost of the component depends on the total energy cost incurred during its manufacture. Edewor (1979) reported that Casper et al carried out an evaluation of the ratio of the input energy to the pound sterling for a number of products from manufacturing processes. This ratio is called the energy intensity of the product, and it is a measure of the cost of the equipment. They gave the energy intensity of heavy engineering products as 106.28 MJ/£ (1968), and for chemicals as 339.13 MJ/£ (1968). These figures are upgraded to 2011 costs by using cost indices as follows:

The energy equivalent, also called the energy requirement of any capital equipment is then obtained by multiplying the energy intensity by the cost.

The energy equivalents or energy requirements for the components of a 1000 tonne per day plant for cellulose hydrogenation are presented in the table below.

5.3 Process energy factor and thermal efficiencies

Although the main objective in the hydrogenation of cellulose is to produce oil products, three product streams are obtained: oils, gases and char. The gas yield is only 15% of the cellulose fed, while that of char is significant. The gases produced are consumed completely in the plant. This means that the process produces only oil and char. Hence, the GER into the process is shared between oils and char. If D is the fraction of the GER that goes to produce oils only, then,

D = (Energy output from process through oil)/ (Total process energy output)

That is,

$$D = \frac{M_o(CV_o)}{M_o(CV_o) + M_c(CV_c)} \tag{47}$$

Where, M_o and M_c are the masses of oils and char respectively, while CV_o and CV_c are their calorific values.

For a unit mass of oil produced,

The process energy factor is

 X_f is a very significant quantity in the energy economy analyses. It is a measure of the ratio of the total energy demand for the process to the total energy yield from it.

For $X_f \ge 0.6$, the process is considered to be energy demanding, and hence, heavily dependent on energy. It is therefore an expensive process, and may not be economically feasible. Conversely, for $X_f \le 0.4$, the process is energy rewarding, and consequently, inexpensive.

The thermal efficiency of the process with respect to the oils is defined as the ratio of the energy output of the process through the oil product to the gross energy requirement.

By considering the char also, the efficiency becomes

Table 5 gives the values of GER, NER, X_f, and thermal efficiencies for the 1000 tonne per day cellulose hydrogenation plant. The plant was designed by Anagho (1987) for the treatment

of municipal waste in Lagos. The design was based on the Kaufmann and Weiss (1975) 36 tonne per day plant that was used to recycle municipal waste in Manchester, UK.

The energy factor for the plant is X_f = 0.439. Although this value is smaller than 0.60, it is slightly greater than the maximum value for the plant to be economically feasible, it could still be considered as such. The value will get smaller, and the process more competitive when the present petroleum prices get higher.

6. Conclusions

Cellulose hydrogenation is a complex process in that it takes place under very drastic conditions of high temperature and high pressure, producing a mixture of chemical products. This study shows that the complex reaction can be modelled as a first order rate process with respect to the total reactor pressure. That is,

$$-r_A = kP \tag{41}$$

The hydrogenation generates liquid products at a yield of almost 35% by the mass of the dry pulverised cellulose feed. The products obtained are a mixture of saturated, unsaturated paraffinic and aromatic hydrocarbons, which exhibit instability on storage. An energy economic evaluation of a prototype cellulose hydrogenation process shows that it is an economically feasible process.

The high yield of liquid products, the reactivity of the liquid products and the feasibility of the hydrogenation process suggest that we now have a bioresource substitute for petroleum.

Unfortunately, the technology for obtaining chemicals from cellulose is not well developed. Consequently, it is not widely used to meet the objectives of supplementing petroleum and reducing environmental pollution. The feed into the process comes from so diversified sources of cellulose that the design of plants to process them is difficult.

Future research will look at obtaining alcohols as the main chemicals from bioresource and then using them as the feedstock into petrochemical industries. This will be done by

thermally breaking down the lignin surrounding the cellulose, followed by hydrolysing and fermenting the resulting sugars into alcohol. This will call for research into the growing of fast growing crops that have no particular food values to human beings. In addition to being fast growing, these crops should not compete for agricultural lands.

A Possibility to Use a Batch of Ashless Additives for Production of Commercial Transmission and Motor Oil

1. Introduction

The aim of the present chapter is to study the possibility to use PSA synthesized by the authors for production of commercial transmission and motor oil.

The practically used compounds are usually surfactants, which must be soluble in a medium of non-polar petroleum hydrocarbons. This required the optimal length of the hydrocarbon radical of the main hydrocarbon chain guarantees property. The polar group of the additive, which determines its main function, has certain electron effect. As a result, significant static and dynamic dipole moments are generated, as it has been discussed in the previous chapters. These effects stipulate the affinity of the additives to different border surfaces, especially in their intermolecular interactions when used within a batch [2].

In our previous investigations, the methods for synthesis of PSA by sulphonation, nitration and oxidation have been reported [3, 4,5].

2. Experimental

Taking into account our earlier studies [6,7] on the optimization of the composition of the additives synthesized by us, a batch of petroleum soluble additives was composed on the basis of an oil component and the most effective of them was found to be the composition containing PSA-SK-N-H: PSA-SK-S-U: PSA-SK-O-U = 10:50:40 referred to further as batch P-1. The denotations and the most important values for additives preparation have been published earlier [6]. With the selected batch of additives, the possibility to prepare operation-conserving lubricants of transmission and motor type was investigated. For this purpose, basic lubricant mixtures were taken from fractions of the corresponding class of viscosity and the batch P-1 was added to them. The standard physicochemical and performance properties of the alloyed lubricants were then determined to estimate their performance quality. The results obtained from the analysis are presented in Table 1.




Fig. 1. Depositions of acidic products in lubricant samples depending on the oxidation time at three temperature regimes.

Table 2 shows the general technical characteristics of the transmission lubricants after the tests carried out. Tests were performed also by the method PPA-2 [8] for fuller assessment of the protective coatings formed by the transmission lubricant. The tests were carried out in

presence of copper disks (alloy M-5) since, as it is well known, this metal catalyzes the oxidation of petroleum hydrocarbons especially in presence of air and at higher temperature. Fig.1 illustrates the depositions of acidic products in lubricant samples depending on the oxidation time at three temperature regimes (100, 200 and 300 $^{\circ}$ C).




Fig. 2. The intensity of the adsorption band at 1720 cm⁻¹ in the IR spectra of their 10% solutions in tetra chloromethane.

During the proved optimal induction period of oxidation (4 hours), the processes giving acidic products depending on experiment temperature were studied (Fig.2). Simultaneously, the accumulation of carbonyl containing compounds in the oxidized lubricants was

established by the intensity of the absorption band at 1720 cm⁻¹ in the IR spectra of their 10% solutions in tetrachloromethane.




Fig. 3. Quantity of metal dissolved in the exhaust lubricant as a result of their interaction with the products obtained from their oxidation.

To find the quantity of metal dissolved in the exhaust lubricant as a result of their interaction with the products obtained from their oxidation, analyses of their composition were carried out by atomic absorption spectroscopy (Fig.3).

As can be seen from Table 1, the use of the batch P-1 in the optimal concentration established to be 0,005 %, the requirements of the Bulgarian national standard can be fulfilled by the transmission lubricant at performance level TM-5. According to BSS 14368-

02, this lubricant can be used to lubricate gears and its properties are like these of the commercial product "Ulita ER". The studies showed that the lubricant obtained has very good anticorrosion and antiwearing properties. As general conclusion it can be stated that the batch of ashless PSA gives the lubricant alloyed polyfunctional properties. The antioxidative stability of the alloyed lubricant is especially important since the transmission oils in the process of operation are subjected to intense stirring under atmospheric medium and in presence of ferrous and non-ferrous metals and alloys. The surfactant properties of he additive affect the amount of foam formed and its stability. The presence of air in the lubricants did not enhance the accumulation of oxidized products in them, All the physicochemical and performance properties measured at the recommended concentration of the additive showed that the transmission lubricant obtained is of the operation-conserving type and possessed enhanced resistance to oxidation. At the same time, it did not change significantly its performance properties during the experiments carried out (table 2).

The studies carried out showed (Fig.1) that the presence of the additive P-1 did not have significant effect on the duration of the induction period of oxidation of the experimental samples. The positive effect observed after the fourth hour of operation was that the intensity of the oxidation processes decreased and the accumulation of acidic products in the exhausted lubricants was almost constant. This resulted from the exhaustion of the easily oxidizable hydrocarbons and, probably, the antioxidative effect of some of the products obtained. Positive effect on the antioxidative protection of the hydrocarbons in the lubricants studied had also the chemiadsorption properties of the ashless PSA participating in the composition of P-1 towards the metal surfaces. When adsorbed on the metal surface, they could impede the catalytic effect they have on the oxidation of the petroleum products.

As can be seen from Fig.2, the most intense oxidation processes were observed at temperatures up to 200 °C. Above this temperature, the acid number remained almost the same. The use of the additive P-1 slowed down the acid number increase rate and limited the accumulation of acidic products (Fig.3).

The studies carried out showed that, without the additive, processes of corrosion-mechanical wearing of all the metals contacting with the lubricant actively occur during the tests according to the PPA-2 method. In the presence of the additive P-1 these processes almost stopped after the fourth hour of operation. Probably, the additive formed chemiadsorption compounds on the metal surfaces which protect them from the interaction with the corrosion aggressive products. As a result, the concentration of metals in the exhausted lubricant sharply decreased and remained almost the same after the induction period.

After 2 months of operation of the lubricant with P-1 and the commercial additive, it was found that probably strong enough chemiadsorption film was formed on the metal surface, which decreased the intensity of their corrosion-mechanical wearing. This effect is much more pronounced with the batch of ashless PSA P-1 at low concentration, compared to the metal containing additives of the previous generation. Due to the good lubricating characteristics of the more viscous lubricant usually used only in summer, the results on the corrosion-mechanical wearing were worse and the protection of the lubricated surfaces was better. (Figs.4 - 7).




Fig. 4. The wearing of the parts of the piston-cylinder system was monitored by measuring the concentrations of iron.




Fig. 5. The wearing of the parts of the piston-cylinder system was monitored by measuring the concentrations of aluminium.




Fig. 6. The wearing of the parts of the piston-cylinder system was monitored by measuring the concentrations of tin.




Fig. 7. The wearing of the parts of the piston-cylinder system was monitored by measuring the concentrations of lead.




Fig. 8. The results on the relative wearing of the first segment of the pistons of the individual cylinders of the motor "Ch 10.5/13".




Fig. 9. The results on the relative wearing of the first segment of the pistons of the individual cylinders of the motor "Ch 10.5/13".

The results illustrated in figs.8 and 9 confirmed the higher effectiveness with regard to the anti-wearing properties possessed by the ashless additives included in the combined batch P-1. The wearing in the individual cylinders of the motor was found to be different. Probably, in this case, the liquid film formed in the combustion chamber due to the over-fractioning of the fuel during the formation of the fuel-air mixture in the cylinders exerted some influence. In the middle cylinders (II) and (III) the wearing was slightly more intense.

It is well known that this type of wearing in presence of a liquid film is of the so called type "corrosion mechanical wearing". The main reason for its occurrence is the washing out of the lubricating film and disturbance of the laws of hydrodynamic friction, as well as decrease of the lubricating film thickness. Nevertheless, this effect of wearing in the presence of the batch P-1 was significantly weaker.

The experiments carried out showed that the nature of the compounds from which the PSA were prepared gives them surface active properties and improve the protective and other properties of the fuels and lubricants alloyed with them. This is especially important for the use of fuels with high sulphur content used more widely for ship engines. In this case, an important problem arises since the sulphur containing compounds and the products of their combustion accelerate the corrosion-mechanical wearing of the aggregates and, of course, have adverse effect on the environment. In this respect, it appeared to be interesting to study the anti-wearing properties of the motor oils M 6W 8 C₂/D₁ and M 16 D₂/E₁ alloyed with the batch additive P-1. Simultaneously, experiments were carried out also with the magnesium-containing additives synthesized by the authors and implements in the industry in the prescribed concentration of 6% [5]. The experiments were carried out with four-cycle four-cylinder motor "Ch 10,5/13" mounted in many lightweight sea vessels. These motors use ship diesel fuel LK produced according to Bulgarian national standard BSS 12833-82 and contains up to 1.4% sulphur. The wearing of the parts of the piston-cylinder system was monitored by measuring the concentrations of iron, aluminium, tin and lead found in the lubricant according to BSS ISO 9778-00 and BSS ISO 15430-02. These are the main metals used to manufacture the parts of the motors. This method is widely used practically both for determination of the moment to replace the lubricants and oils and establishing of emergency cases of accelerated wearing of some units in the motors. The results obtained from the studies of the operation-conserving lubricants are shown in Figs.4-7.

Figs.8 and 9 show the results on the relative wearing of the first segment of the pistons of the individual cylinders of the motor "Ch 10,5/13" determined by their weight after 1 year service using different lubricants.

3. Conclusion

The studies on the use of the batch of ashless petroleum soluble additives P-1 for the production of transmission lubricant carried out showed that the addition of 0.005% P-1 to basic lubricant mixtures gave transmission lubricant complying with BDS 14368-02. The transmission lubricant obtained can be used to lubricate gears and is fully comparable to the commercial product "Ulita ER". The results obtained from the physicochemical analyses showed that the operation-conserving motor lubricants alloyed with the batch mentioned above fully comply with the requirements of BSS 15021 and BSS 9797. It was found that the optimal concentration of the batch P-1 is 0.010%. The ashless PSA included in the batch impart depressing and very good protective properties of the alloyed lubricants.

1. Introduction

The principal technological element of the industrial plants and the chemical reactions is the chemical reactor. In this chapter, it is considered that the chemical reactor is an apparatus in which the chemical process can be effectuated to obtain certain substances in technological process. The automatic control systems by their dynamic bring those processes to a point where the profile is optimal, a fact which imposes several methods to achieve the desired performances. This chapter proposes a hierarchical configuration of control which treats aspects related to the primary processing of data, processes identification, control and the robustness analysis under some conditions of the operating regime for representative plants in the chemical and petrochemical industry. It is a design of numerical control laws in a pyrolysis reactor in order to achieve an efficient regime of operation that allows as much as possible to optimize the concentration of produced ethylene by the chemical reactions (Popescu et al., 2006a; Landau & Zito, 2006).

2. Technologic overview of the plant

2.1 Technical description and operating conditions




Fig. 1. Integration of Pyrolysis reactor into a petrochemical plant

The pyrolysis reactor as shown in figure (1) is planted in petrochemical plants and is intended to obtain ethylene, the combination of a quantity of gas with water under certain operative conditions can produce a chemical reaction, which has the ethylene as a result among the reaction products (Popescu et al., 2006b).

The block diagram shown in figure (1) describes the chemical transformations selected from a petrochemical plant whose pyrolysis took a large space. The kinetic parameters of reactions are determined by the mathematical adjustment to the experimental results obtained in several scientific resources in the combined model in the simplification of the oil and on its derivatives (Mellol, 2004).

2.2 Automation solutions of the reactor

Gas and steam are introduced to the plant of two access roads at a constant flow, but the amount of the necessary heat for the reaction is obtained from a heating system which uses




Fig. 2. Controller loops that govern the pyrolysis reactor.

a straight fuel powered methane gas (Harriott, 2002). For the insurance of the desired operation of the reactor, it is necessary to achieve an automation mechanism that provides a measurement system, automatic control and supervision of the parameters I/O, the automation solution is shown in figure (2), which there are implemented the four controllers:

Data were recorded using an acquisition card connected to a computer (Azzouzi, 2008). Variables are limited in technological point of view such as:

x1: flow of primary matter (oil) (1000 to 1600 Nm³/h)

x2: flow of steam (430-540 Nm³/h)

x3: working pressure (3.2-4.5 atm)

x4: working temperature (820-860°C)

y (%): the concentration of the useful product (ethylene) at the reactor output

2.2.1 Flow control

Automatic systems of flow control structure are made of simple adjustment depending on the error, such a structure is used only to maintain a flow to a specified value or as a secondary loop in a control structure that changes in cascade the flow with the level or concentration (Borne et al., 1993).




Fig. 3. Flow controller




Fig. 4. Oil flow controller.




Fig. 5. (A) Step reponse, (B) Time response, (C) Bode diagram and (D) Nyquist diagram.




Fig. 6. Control of steam flow.




Fig. 7. (A) Step reponse, (B) Time response, (C) Bode diagram and (D) Nyquist diagram.

2.2.2 Control of the reaction pressure




Fig. 8. Pressure control




Fig. 9. Nyquist diagram and poles in closed loop.

To maximize the natural frequency and the damping factor, it should be considered initially that in tracking w_0 =0.35 rad/s and xi=0.9 then for the regulation w_0 =0.4 rad/s and xi=0.85. Figure (9) shows the Nyquist diagram with the shift of the poles from a proposed system P1 to a robust P4 after the change of the tracking and control polynomials.

Robustness margins are respectively shown in table (1), the goal here is to approach the margins form known robustness margins. A slow change in parameter values and further regulation and traking may increase the system robustness in closed loop (Oustaloup, 1994).




Fig. 10. Sentivity fucntion for the system robustification.

The robustness test is important to identify the operating factors which are not necessarily considered in the development phase of the method, but could influence the results, and therefore to anticipate problems that may occur during the application of the chosen method. A series of curves to the robust sensitivity function analyzed by using WinReg is shown in figure (10). The new polynomials of the controller and the reference model are given as follows:




Fig. 11. Step response under and without disturbance.

The introduction of an input signal step type in closed-loop system, with a delay of 10s and an amplitude of 1%, by adding a perturbation amplitude of 3.5 * 10-3% applied at time 40s, results a small attenuation of response at the same time of its application, Figure (11), shows the step response and the effect of disturbance on this response, which demonstrates that the tracking and control performances are provided (Azzouzi & Popescu, 2008).

2.2.3 Reaction temperature control




Fig. 12. Temperature control

The temperature is a parameter representative for the chemical and petrochemical processes, with the transfer of heat, in temperature control systems, the mathematical model will be calculated for heat transfer of the product which will be heated or cooled, the structure of an SRA for temperature is given in figure (12) (Ben Abdennour, 2001).




Fig. 13. Nyquist diagram and closed-loop poles.

The Nyquist diagram with the location of poles in closed loop of figure (13) are taken in two different cases of treatment, they show the difference between a controller without prespecification of performance given above, and a robust controller that is given later by adding a few performances (Ogata, 2001).




Fig. 14. Step response under and without distanrbance.

To simulate the behavior of the controller, the given step response of the reference model must be used by considering the existence of a disturbance step type, with amplitude of 2.5 * 10-3%, applied at time 40s, a graphical representation of the step response with and without disturbance is shown in figure (14), in which the assurance of performance in tracking and control can be observed.

3. Conclusion

The realized study case on the pyrolysis reactor validates the research developed in this chapter and provides a guarantee for the successful implementation of the control solutions proposed for such plants (Azzouzi, 2009a). On one hand, there are analyzed the theoretical and practical resources offered by modern Automatic Control in order to achieve the effective solutions for the control of this chemical process, and on the other hand, there are presented mechanisms related to the design and to the implementation of systems for data acquisition, identification, control and robustness (Azzouzi, 2008).

Modeling and Simulation of Water Gas Shift Reactor: An Industrial Case

1. Introduction

Recently, refineries finished products hydro treatment became critical due to changes in fuel regulations. These changes are related to the specification of more clean fuels with special focus in sulfur content reduction. In order to achieve these goals more hydro treatment is needed. Hydrogen is the main raw material to hydro treatment units.

In refining plants, a hydrogen generation unit usually is necessary to supply the hydrogen demand to all demanding processes.

The process known as steam reform unit is the most widely adopted technology. In large scale, it has the highest energetic efficiency and the best cost-benefit ratio (Borges, 2009).

In this process the hydrogen conversion is carried out in two reactors in series. The first one, the steam reform reactor converts steam and a hydrocarbon (naphtha or natural gas) into *syngas*. In the sequence, a reactor known as water gas shift reactor (WGSR) converts the carbon monoxide present in *syngas* into carbon dioxide and more hydrogen is generated.

Consequently, the WGSR, an intermediate step of hydrogen generation process, plays a key role in a petrochemical plant due to hydrogen increasing demand.

1.1 Hydrogen generation unit

The hydrogen generation unit, based on the steam reform technology, is responsible for approximately 95% of generated hydrogen (Borges, 2009).




Fig. 1.1.1. Hydrogen generation unit – process block diagram.

A simplified unit block diagram is showed in figure 1.1.1.

First, sulfur is removed from the hydrocarbon stream (usually natural gas), in order to prevent catalyst poisoning and deactivation with the use of a guard bed. Steam is mixed in the main stream in a fixed steam to carbon molar basis. The steam reform reactor (SRR) is a multitubular catalyst filled furnace reactor where the hydrocarbon plus steam are converted into syngas at high temperatures (700°C - 850°C) according to the following reaction:

The reaction (1) is endothermic and reaction (2) is moderately exothermic. Both are reversible reactions. In the SRR, (1) is the main reaction and generates most of the hydrogen. The reaction (2) due to its endothermic nature occurs in a lower extension in the SRR. The syngas stream composition is CO and H_2 , in this process CO_2 and H_2O are also present in gas state. The main purpose of the water gas shift reactor (WGSR) is to carry out the reaction (2) reducing the CO fraction and increasing the hydrogen yield. Finally, the WGSR stream is conducted to a purification section, where hydrogen purity is increased according to the process needs.

2. The water gas shift reaction

2.1 kinetic rate expression

The water gas shift reaction (reaction 2) is a heterogeneous reaction (gas/solid).

According to (Smith et al., 2010) in this kind of application, there are two options in the WGSR step. Using a high temperature shift (HTS) catalyst based reactor or a series of HTS followed by a low temperature shift catalyst based reactor (LTS) with intercooling stage to increase the overall conversion and high purity hydrogen is needed (Newsome, 1980).

The chapter focuses on a HTS ferrochrome catalyst industrial reactor modeling.

The HTS usually is an iron oxide – chromium oxide based catalyst. Also reaction promoters such as Cu may be present in catalyst composition. Operational temperatures vary from 310°C to 450°C. Inlet temperatures are usually kept at 350°C to prevent the catalyst bed temperature from damage. Exit CO concentrations are in the order of 2% to 4%. Industrial reactors can operate from atmospheric pressure to 8375 kPa. Sulfur is a poison for Fe-Cr catalysts.

LTS reactors are copper based catalyst. Typical compositions include Cu, Zn, Cr and Al oxides.

Recent catalysts can be operated at medium temperatures around 300°C. Copper is more sensitive to catalyst thermal sintering and should not be operated at higher temperatures. Sulfur is also a poison to LTS reactors. Typical exit concentration is of 0,1% of CO.

The reaction is operated adiabatically in industrial scale, where the temperature increases along the length of the reactor.

According to Arrhenius law of kinetics, increasing temperature increases the reaction rate. By the other side, the thermodynamic of equilibrium or Le Châtelier principle states that increasing the temperature of an exothermic reaction shifts the reaction to reactants side decreasing its equilibrium conversion. Therefore the water gas shift reaction is a balance between these effects and the reactor optimal operational point takes into account the tradeoff between kinetics and equilibrium driving forces.

In (Chen et al., 2008) experimental data indicates that increasing temperature in HTS will promote the performance of WGSR. For the LTS, the reaction is not excited if the reaction is bellow 200°C. Once the temperature reaches 200 °C the reaction occurs, but the CO conversion decreases with increasing temperature. This fact reveals that that the water gas shift reactions with the HTS and the LTS are governed by chemical kinetics and thermodynamic equilibrium, respectively in industrial conditions.

(Smith et al., 2010) classifies the reaction kinetic models in microkinetic approach and the empirical method.

Basically, the micro kinetic approach explores the detailed chemistry of the reaction. On the other hand, the empirical models are based on the experimental results and are typically expressed in the Arrhenius model and provide an easy and computationally lighter way to predict the rate of reaction. The main disadvantage is the fact that the adjusted model cannot be extrapolated to different composition and types of catalysts.

Many empirical expressions have been reported in literature for HTS. (Newsome, 1980) and (Smith et al., 2010).

An empirical rate expression successfully used to describe the WGSR in ferrochrome catalysts is a power law type: (Newsome, 1980)

In industrial reactors, catalysts are loaded in pellets. Therefore, intrinsic rate expressions cannot be used in pseudo-homogeneous models without some type of compensation to account for diffusion effects.

According to (Newsome, 1980) two different methods can be applied to model industrial reactors as pseudo-homogeneous reactions. The first was proposed by Bohlbro and Jorgensen consists of estimating the empirical rate expression in laboratory using commercial size catalysts. The diffusion effects remain implicit in the rate expression. First and second rows of Table 2.1.1 illustrate this method. The catalyst in the first row was grounded to avoid diffusion effects. In the second row the same catalyst was used in commercial pellet size. It can be noted slight differences between l, m, n e q parameters. The disadvantage of this method is that the rate expression can model successfully only a reactor with this specific type and size of catalyst.

(Hla et al., 2009) estimates the intrinsic rate parameters for two commercial catalysts as can be seen in rows three and four.

(Adams & Barton, 2009) also model a WGSR reactor using a heterogeneous modeling approach. The intrinsic rate expression is from Hla et al. previous article. The parameters are result for the best fit estimation.

The second approach of pseudo-homogeneous rate modeling consists of using correction factors to compensate for the pore diffusion phenomena in the catalyst, catalyst age,

operating pressure and hydrogen sulfide concentration with intrinsic rate expressions. (Singh and Saraf, 1977) is a good example of this method.

2.2 Mathematical modeling

In this section, mathematical expressions for the fixed bed adiabatic catalytic WGSR fundamental principles (conservation equations) are developed.

A basic ideal flow steady state one-dimensional model is presented.

The differential molar balance simplified to a fixed bed reactor can be expressed as equation 5: (Froment and Bischoff, 1990)

The ideal model assumes that concentration and temperature gradients only occur in the axial direction. The only transport mechanism operating in this direction is the overall flow itself, and is considered to be of the plug flow type.

In case of a reactor bed with a fixed cross sectional area (S), the differential molar balance can be rewritten as a function of the reactor differential length as can be seen in equation 6:




Fig. 2.2.1. Reactor differential volume representation.

The aim of the next topics is to develop this set of equations to model an industrial high temperature WGSR.

2.3 Some design aspects

When designing WGSR (Chen et al, 2008), it is known that a proper selection on certain parameters is of the most importance because the reaction result depends strongly on the combination of these parameters. Typically, the important parameters include the catalyst type, residence time of reactants in a catalyst bed, reaction temperature and feeding reactants ratio or CO/steam ratio.

2.3.1 Types of catalysts

According to the reaction temperature (Chen et al, 2008), the WGSR falls into two categories: high-temperature shift catalyst (HTC) and low-temperature shift catalyst (LTC). The catalyst commonly used in the former is an iron-chromium-based catalyst, whereas a copper-zinc-based catalyst is frequently adopted in the latter.

2.3.2 Residence time

It is known that the catalyst amount in a reactor is highly related to the overall project cost. In other words, if a reaction can be developed with least catalyst, both the operation (or catalyst) cost and the facility (or space) cost can be reduced effectively. The least catalyst amount can be evaluated by determining the residence time of reactants in a catalyst bed.

For both categories of reaction, a residence time of 0.09 s is long enough to establish an appropriate WGSR (Chen et al, 2008), a design factor can be used to compensate deactivation during the catalyst life.

2.3.3 Reaction temperature

The reaction temperature on the design of the WGSR, varies according with the type of catalyst used (Chen et al, 2008), For HTC, increasing reaction temperature, the concentration of CO declines with respect to the temperature, thus the conversion of WGSR increases, but between 400° C and 500° C the change in this propriety is small, so temperatures between 350° C and 400° C the major reaction occur.

In the case of LTC reaction, for temperatures below 150° C, no reaction take place, increasing to 200° C the conversion rise to above 90%. If temperature is increased further the conversion begins to fall. So, an optimal reaction, for the WGSR with the LTC is obtained in temperatures around 200° C.

The WGSR is an exothermic reaction in nature, from thermodynamics it is known that an increase in reaction temperature will impede the forward reaction for H2 production in the WGSR. Because the behavior, it is realized that the WGSR with the LTC catalyst is governed by chemical equilibrium.

In contrast, for the HTC catalyst, the CO conversion is highly sensitive to the reaction temperature and an increase in temperature is conducive to the hydrogen generation. It follows that the reactions with the HTC are controlled by chemical kinetics (i.e. Arrhenius law).

2.3.4 CO/steam ratio

For both kind of catalysts when the CO/steam ratio is large than 1/4, the performance of the WGSR is sensitive the variation of the ratio. Alternatively, if the ratio is smaller than 1/4, varying the ratio merely has a slight influence on the performance (Chen et al, 2008).

3. Experimental data

Experimental data of an industrial shift reactor of REPAR/PETROBRAS were used for the modeling studies. The reactor performs CO oxidation to CO2 using industrial steam. The reaction occurs in a fixed bed filled with a Fe-Cr-based catalyst, which is shown in Figure 3.1.




Fig. 3.2. Temperature measurement positioning.

The historical data set comprises 4 years of operation. More specifically, samples withdrawn from feed and exist streams were analyzed by chromatography, following the technical standard norm (NBR-14903, 2002). Temperature measurements are performed using K type thermocouples connected to Honneywell STT3000 transmitters positioned according to Figure 3.2. Finally, it is important to mention that feed flow rate measurements were performed using orifice plates connected to a Honeywell STD900 differential pressure

transmitter and the reactor pressure drop was measured using manometric pressure coupled to Honeywell STD900 transmitters.




Fig. 3.3. Normalized experimental CO conversion.

Experimental data of CO conversion are presented in Figure 3.3. These data were normalized by dividing the experimental value by the reactor design conversion value. It is important to state that all experimental data were normalized to the design values in order to avoid numerical convergence issues along the modeling and parameter estimation tasks.

The modeling work will focus on CO conversion, however this variable is not directly measured, but actually obtained from chromatographic analysis using Eq. (10), which considers the measurement of CO, CO2 and CH4 in the feed and exit streams.

However, it is important to estimate the experimental uncertainty (i) of CO conversion the measurement, i.e., an estimate of the CO conversion variance. This calculation can be done by applying an error propagation approach to Eq. (10), more specifically, an estimate can be obtained by Eq. (11), which considers the variance of CO, CO₂ and CH₄ concentration measurements, while covariance was considered zero. The variance of each measurement was calculated according to the technical standard norm NBR-14903. This analysis yielded an average standard deviation of 1% of the CO measurement.

4. Model parameter estimation and validation

Based on the kinetic expressions, the development of a fundamental model to describe the shift reactor behavior represents an important tool for in-depth studies and performance optimization.

For modeling purposes, the experimental data set was firstly modeled considering a model with a reasonable amount of simplifying hypothesis and literature reported parameters. Afterwards, some of the hypotheses need to be disregarded, allowing an increase in model complexity, leading to further parameter estimation. Different hypotheses were disregarded until the model could successfully describe the experimental data set behavior. Only steady-state analysis was performed.

Parameter estimation was performed using a simplex-based method (Himmelblau et al., 2002) focusing on minimizing the classical least square objective function based on the difference between experimental and predicted CO conversion values. The experimental industrial data set was divided into two groups, the first for parameter estimation and the second for model validation.

Despite the relaxation of some simplifying hypotheses, in all models, both axial and radial diffusion were not considered. This choice occurred due to some features of the studied reactor, for example, it presents a high length to diameter ratio, in order to assure a turbulent flow for different operating conditions. Consequently, effects of a possible external diffusive resistance tend to be reduced. A second common simplifying hypothesis present in all models concerns the absence of pressure drop, therefore an isobaric reactor was considered. This hypothesis was assumed because experimental data revealed a pressure drop less than 3% along the catalyst bed, bellow literature recommendation threshold of 10% to disregard possible pressure drop effects (Iordanidis, 2002).

4.1 Model 1 - Pseudo-homogeneous isothermal reactor

The first modeling attempt represents a very simplified reactor model as given by Eq. (12)

The reaction rate is based on power law kinetics and is given by Eq. (13)

For modeling purposes, reaction rate considered molar fractions instead of the components partial pressure, according to (Adams & Barton, 2009). According to the authors, a pressure correction factor, Fpress, given by Eq. (14) also needs to be considered as a pressure increase tends to increase the effect of molecular diffusion inside the catalyst pore.

where: P is the absolute pressure in bar.

The equilibrium constant, Keq, is given by Eq. (15), obtained by considering temperature dependent heat capacities.

Finally, it is worth mentioning that the reaction rate constants were obtained from (Hla et al., 2009) as presented in Table 4.1.1 and also that the catalyst activity was considered constant.




Fig. 4.1.1. Model 1 results.

After solving the reactor model, normalized experimental CO conversion plotted against normalized CO conversion predicted values are shown in Figure 4.1.1. It can be observed that a systematic deviation occurs, probably because of the number of simplifying assumptions. The first hypothesis to be revisited is the reactor isothermal behavior, mainly because of the direct temperature effect on CO conversion and also because of the reaction exothermal behavior.

4.2 Model 2 - Pseudo-homogeneous non-isothermal reactor

This model represents and extension of Model 1. Due to the non-isothermal behavior, the reaction rate is not constant along the reactor length. The exothermal characteristic of the reaction also contributes to performing a heat balance on the reactor, yielding Eq. (16):




Fig. 4.2.1. Model 2 results.

Consequently, the reactor model is now comprised by a system of ordinary differential equations. Figure 4.2.1 is obtained after plotting normalized experimental CO conversion against normalized CO conversion predicted values. It can be observed, after comparison with Figure 4.2.1, that non-isothermal feature actually resulted in worse model predictions. By analyzing Figure 7, it can be observed that for higher experimental conversion values, systematic higher predictions are obtained. This probably happens because the non-isothermal behavior leads to higher temperature values, consequently not only leading to higher reaction rates overestimating CO conversion, but also affecting diffusion phenomena inside the catalyst particles. Therefore, an alternative modeling approach would be considering an effectiveness factor in order to correct the reaction rate.

4.3 Model 3 – Pseudo-homogeneous non-isothermal reactor with reaction rate correction

In this model, the reaction rate (Eq. 13) is corrected by an effectiveness factor as presented by Eq. (17).

It is important to realize that in Model 1 and Model 2 only simulation studies were carried out, no model parameter estimated. Now, parameter η , which remains in the interval (0,1], will be estimated in order to improve data fitting the model predictions. As mentioned before, only part of the experimental data set will be used for parameter estimation using the minimum least square method, while the other part will be used for validation purposes.




Fig. 4.3.1. Model 3 validation.

After parameter estimation, an optimal value of $\eta=0.56$ was obtained. Considering this value, the mathematical model was then used to predict CO conversion as presented in Figure 4.3.1. It can be seen a considerable improvement in the model prediction, which was achieved by estimating only one parameter. However, the experimental data set refers to a considerable production horizon; consequently, catalyst activity may have changed, leading to another opportunity for model improvement.

4.4 Model 4 – Pseudo-homogeneous non-isothermal reactor with reaction rate correction and catalyst deactivation

This model considers the reaction rate given by Eq. (18)

In this effective reaction rate, the catalyst activity, a(t), can be described by a hyperbolic rate expression (Eq. (19)) as previously reported (Keiski et al., 1992):




Fig. 4.4.1. Model 4 validation.

It must be stressed that α is the only parameter to be estimated in Model 4 as η was kept equal to 0.56. Parameter α was estimated as 10-5. Figure 4.4.1 presents experimental normalized CO conversion plotted against predicted normalized values considering only the validation data set. It can be observed that the use of catalyst deactivation improved model performance, indicating an important role played by catalyst deactivation. However, the intrinsic reaction rate was not yet used for parameter estimation as exponents i, m, n, p values were considered the ones reported in the literature (see Table 4.1.1), consequently, this creates an alternative for model improvement.

4.5 Model 5 - Revisiting model 4 intrinsic reaction rate

It can be observed that the order of H2O in the reaction rate is equal to 0 as reported in Table 4.1.1. This indicates that H2O is present in such a large excess that concentration changes does not considerably affect the reaction rate (Hla et al., 2009). However, in the industrial reactor, where the feed composition may change due to the nature of a petrochemical plant, H2O may be in excess, but not in enough amount to be considered constant throughout the reactor length. Therefore, exponent m needs to be re-estimated, while the others will be kept at the same values. However, changes in m may affect the effective rate, consequently, η value also needs to be revisited and estimated. To sum up, Model 5 basically keeps the same structure of Model 4 only different parameters need to be estimated.




Fig. 4.5.1. Model 5 validation.

After performing the estimation task, a m value of 0.2 was obtained, simultaneously to a η value equal to 0.575. Figure 4.5.1 presents experimental and predicted values of CO conversion, showing that model predictions improved considering the new m value.




Fig. 4.5.2. Model comparison.

In order to compare the model predictions, the sum of the square difference of experimental and predicted values of CO conversion was performed and Model 2 led to the highest sum being the worst model. The sum of the squares of Model 2 was used as normalization factor and the normalized sum of all models are presented in Figure 4.5.2. It can be concluded that two hypotheses played a key role in the reactor modeling: firstly the isothermal behavior; secondly, the effectiveness factor. Further changes were import to improve, but not considerably, the data fit. It must also be noted that a few number of parameters were estimated, indicating an important likelihood feature of the reactor model. Finally, it is worth stressing that the correlation coefficient between experimental data and model predictions of Model 5 was equal to 0.8.

5. A novel approach to optimal process control strategy

Due to the shift reaction features, for a given reactor feed stream composition and flow rate, the temperature of the feed stream can be manipulated in order to maximize CO conversion. Consequently, if the industrial reactor has in-line/on-line composition analyzers as well as flow rate measurement instrumentation, on-line optimization can be successfully implemented. The problem is that this kind of in-line/on-line instrumentation is not only expensive but also may need continuous and excessive calibration and maintenance. Therefore, some question arises: can other real-time measurements be used for CO conversion? How does temperature influence CO conversion correlated? This is an important issue as temperature measurements are usually reliable, accurate, real-time and low cost. Moreover, fixed bed reactors can have temperature instruments installed along the reactor length, providing a temperature profile. Towards this, a novel and alternative approach will be presented in order to overcome this issue, focusing on CO conversion control.




Fig. 5.1. Historical data: CO Conversion versus feed flow rate.

Figure 5.1 presents historical normalized CO conversion data plotted against normalized feed flow-rate values, obtained from PETROBRAS shift reactor unit. As mentioned before, the normalized variables equal to 1 represent the reactor design values. These data refer to the same reactor temperature; however, due to the nature of petrochemical process, raw material composition can fluctuate, explaining the different CO conversion values obtained for the same experimental conditions. As expected, the higher the feed flow rate, the lower the reactor conversion.

In Figure 5.1, one observes, for example, conversions of 1.02 or 1.04, indicating that in these scenarios the experimental values were over the design values. The same observation can be made for the feed flow rate, indicating some operating conditions either bellow or above the design values. Consequently, it is important to emphasize that the reactor feed composition represents an important disturb variable affecting reactor performance, enhancing the importance of well tuned and designed regulatory control loops.




Fig. 5.2. Historical data: CO Conversion versus Delta_T.




Fig. 5.3. Historical data: Delta_T versus feed flow rate.

The studied shift reactor has thermocouples installed at the reactor feed and exit streams. It also has four thermocouples equally distributed along the reactor bed. After performing extensive sensitivity analysis, the temperature difference between the thermocouple placed on the reactor exit stream and last thermocouple of the bed provided the highest sensitivity, here denominated Delta_T. After analyzing the historical data set, Figure 5.2 presents experimental data of CO conversion plotted against normalized Delta_T. It can be observed a good correlation between both variables, which corroborate the idea of monitoring CO conversion by using lower cost measurements. Finally, Figure 5.3 presents the relationship between normalized Delta_T and normalized feed flow rate values, as expected indicating strong correlation and also good sensitivity.




Fig. 5.4. Sensitivity Analysis.

The developed mathematical model was used for sensitivity analysis in order to study the CO conversion behavior for different operating conditions. More specifically, this analysis is aimed at providing not only the control feasibility itself, but also the feasibility of leading to operating conditions which may allow optimum conversion values. Figure 5.4 shows the CO conversion behavior for different feed flow rate values, considering in all simulations the feed composition design value. More specifically, the design value of the feed flow rate (FLOW1), the design value increased by 35% (FLOW2) and the design value increased by 55% (FLOW3) were used. Firstly, one can observe that due to the shape of the curve, the feed flow rate temperature can be manipulated in order to reach a maximum CO conversion. Secondly, the simulation results show that keeping the reactor feed temperature constant, for example at 1.03, an increase in the flow rate may lead CO conversion reduction, similar to the behavior of the historical data exhibited by Figure 5.1. It is also important to observe the effect of the temperature of the reactor feed stream on the CO conversion. After careful analysis, it can be also noted that to keep track of CO conversion, for example, at 0.955, the feed flow rate needs to be increased for a feed stream temperature increase. Consequently, feed flow rate and feed temperature can be regarded as important manipulated variables for CO conversion either in servo or regulatory control.




Fig. 5.5. Sensitivity Analysis: Composition.

However, it is important not only to provide control feasibility, but also to assure that the control can lead to optimal conversion values. Figure 5.5 presents a sensitivity analysis study focusing on the effect of feed composition. The reactor feed flow rate was kept constant in all simulations, while two different feed compositions were chosen, more specifically, the design feed composition (COMP1) and a feed composition involving an increase in CO amount (COMP2). For each feed composition, the temperature of the feed stream was changed in order to evaluate the correspondent resulting Delta_T values and the maximum conversion was determined and plotted. For COMP1, the maximum conversion is reached at a Delta_T value equal to roughly 3.7. Consequently, for this feed composition and feed flow rate, the feed temperature set-point needs to be roughly 1.01. The same analysis can be performed for composition 2.




Fig. 5.6. Sensitivity Analysis: Feed Flow.

On the other hand, Figure 5.6 presents a sensitivity analysis study focusing on the effect of feed flow rate. The reactor feed composition was set equal to COMP2 and different values of the flow rate, FLOW1, FLOW2, FLOW3 were chosen. For each feed flow rate value, the temperature of the feed stream was changed in order to evaluate the correspondent resulting Delta_T values. For each feed flow rate, the maximum conversion was also determined and plotted. Considering the feed composition COMP2, for the feed flow rate close to the design value, Delta_T should be equal to 3.3 to lead to the maximum CO conversion, consequently, the feed temperature set-point should be roughly 1.02. Keeping the composition unchanged and increasing the flow rate by 35%, Delta_T should be equal to 3.6 and, therefore, the feed temperature should be increased to approximately 1.05. Increasing the design value of the feed flow rate by 55%, Delta_T should be changed to 4.4, so the feed temperature should be increased to approximately 1.06.

Based on the historical data and on the sensitivity analysis results, an alternative CO conversion control loop having the following features arises:

- controlling Delta_T represents the same as controlling CO conversion;
- controlling Delta_T can lead to optimal conversion values;
- cascade structure can be used with Delta_T control mastering the loop by providing appropriate set-points to the reactor feed temperature control loop;
- feedforward features may also be considered as if feed flow rate changes the Delta_T value leading to the optimal conversion needs to be updates as observed in Figure 7;
- feedforward features may also be considered if feed analyzers can be installed, as any change in feed composition would lead to a different Delta_T set-point.

Simulation of Non-Newtonian Fluids Through Porous Media

1. Introduction

The past two decades have appeared techniques for simulation of hydrodynamic systems (Mc Namara & Zanneti, 1998; Higuera & Jiménez, 1989; Qian et al., 1992; Doolen, 1990; Benzi et al., 1992), magnetohidrodynamics (Chen, 1991), multiphase and multicomponent fluids (Shan & Chen, 1993), included suspensions (Ladd, 1994) and emulsions (Boghosian et al., 1996), flows chemically reactive (Chen et al., 1995) and multicomponent flows through porous media (Landaeta, 1997), only for mention some. This techniques, don't based on directly in the discreet state of hydrodynamic equations, don't ether tally with the microscopic level of molecular dynamic. These techniques have been named techniques of mesoscopic simulations. In general, these discreet techniques involve collisions of "particles" which retain mass, momentum and some cases energy and consistently, give place a hydrodynamic macroscopic behavior. These methods are known like Cellular Automaton and Lattice Boltzmann.

The Lattice Boltzmann Method (LBM), including the method Cellular Automaton (AC), present a powerful alternative to standard approaches known like "of up toward down" and "of down toward up". The first approximation study a continuous description of macroscopic phenomenon given for a partial differential equation (an example of this, is the Navier-Stokes equation used for flow of incompressible fluids); some numerical techniques like finite difference and the finite element, they are used for the transformation of continuous description to discreet it permits solve numerically equations in the computer.

The second approximations study a microscopic description of the particles, through molecular dynamic's equations. Here the position and speed of each atom or molecule in the system are calculated with the solution of the Newton's movement equations.

Between the two approximations, are the LBM and the AC, which are considered mesoscopic approaches that was mentioned previously (Wolf-Gladrow, 2000).

With regard to the LBM, this has his origin en the AC, the first effort for simulate systems of flow of fluids was made in 1973 by Hardy, Pomeau and de Pazzis (*HPP*) (Hardy et al, 1973), whom showed the model into and this is named with their initials "*HPP*". In this model, all particles have mass unit and speed; the particles are limited to travel in directions

 $\vec{e}_{i,i} = 1,...,4$ of the square lattice. A boolean variable is used to indicate the presence or absence of the fluid's particle in each place of lattice in one direction given. A rule of exclusion is applied, is for it, that a particle only permits travel in each direction lengthwise of link for stage. When diverse particles arrive in some e at same place, these collisions in accordance with collision's rules pre established in the model, the collision is conduct for the conservation of mass and momentum. If this collision isn't presenting, then the particles will continue their travel in straight line. The model HPP is absolutely stable, but present absence of isotropy in some tensorials terms involved in Navier-Stokes equation. In the same way, the results of the model don't recuperate the Navier-Stokes equation (NSE) at microscopic level. This insufficiency is due to inappropriate grade of rotational symmetry of the square lattice (Hardy et al, 1973). In 1986, Frisch, Hasslancher and Pomeau (Frisch et al, 1986) developed that NSE can be recuperated using a hexagonal lattice. Their model is known like FHP model. This model is similar to HPP, only those particles with unitary mass and speed they move in the vertex of discreet hexagonal lattice. A Boolean variable is used to indicate the presence or absence of a particle this direction. The particles are updated in each time step, when happen a collision or are flowing to a neighbouring site, depend of the case. The collisions of the particles are determined for a pre inscription the collision's rules that contain all possible state of collisions. This model presents two problems; the presence of statistic noise and the incapacity for simulate fluids in three dimensions.

With regard to the LBM, it has its basis in concepts of the kinetics of gases theory. Is method has been employed for simulate many physical phenomenon with the use of discrete lattice, the Boltzmann equation and computational tools. For example in dynamic of fluids, the Navier-Stokes equations can't solve directly, but if when recover like consequence. The problem is obtaining the function of particle's distribution, $f_i(\vec{x},t)$ and starting from these obtains observable variables like viscosity, fallen pressure and Reynolds number. In general, the methods of lattice Boltzmann consist in two operations; the first is denoting the advance of particles at the neighbouring site of the lattice. The second operation, is for simulate particle's collisions. An important advantage is that this method is fully parallel and local; too is simple made the programming. In this can incorporate boundary conditions and complexes geometries (Chen et al, 1994).

2. Basis of kinetics theory and Boltzmann equation

Fort the solution of complex problems of dynamics of fluids, exist traditionally two kinds of points of view: the first is macroscopic, which is considered continuous, with an approach of differential equations in partial derivatives, for example of Navier-Stokes equations used for flow of incompressible fluids and numerical techniques for its solution. The second point of view is microscopic it has its basis in kinetics theory of gases and statistical mechanics.

With regard to the kinetics theory of gases, this mentions that a gas contain many particles in interaction α (the order is 10^{23}), the physical state is describing by their positions $\bar{\mathbf{r}}^{\alpha} = \left\{ \mathbf{r}_{1}^{\alpha}, \mathbf{r}_{2}^{\alpha}, \mathbf{r}_{3}^{\alpha} \right\}$ their speeds $\bar{\mathbf{v}}^{\alpha} = \left\{ \mathbf{v}_{1}^{\alpha}, \mathbf{v}_{2}^{\alpha}, \mathbf{v}_{3}^{\alpha} \right\}$ during the time t. The micro state is given by the complete set $\left\{ \bar{\mathbf{r}}^{\alpha}, \bar{\mathbf{v}}^{\alpha} \right\}$ and each particle can be describing through its trajectory in the space of 6-dimensional by complete extension $\bar{\mathbf{r}}^{\alpha}$ and $\bar{\mathbf{v}}^{\alpha}$, it is named *phase space* (Struchtrup, 2005).

This chapter will shortly explain the basics of the Boltzmann equation, the derivation of the Lattice Boltzmann equation and the connection to the Navier-Stokes equations.

2.1 Boltzmann equation

A fluid can consider like a continuous medium when the fluid is dense, this meaning that the particles are behind the other particles and there isn't space between they, in this case the fundamental equations that conduct the fluid's evolution are of kind Navier-Stokes (NE). One form of determinate if the continuous medium is acceptable, is through of Knudsen's number $(Kn=\lambda/1)$, which is defining like the relation between the free mean trajectory λ (mean distance that a molecule travels through before collisions with other molecule) and the characteristic length l; the model continuous medium is acceptable for a rank of $0.01 \le Kn \le 1$. In other words the Knudsen's number should be less that unit, in this form the continuous hypothesis will be valid.

In other way in the real fluid, the particles have strong and continuous interactions. In a gas named rarefied, the particles move during many time like free particles, except when collisions occurs of binary body.

When the Knudsen's number is in the rate of $Kn \ge 0.01$, the fluid could be considered like flow of rarefied gas.

The LBM has its basis in the approximation of a fluid like rarefied gas (or diluted gas) of particles. The rarefied gas can be describing by Boltzmann equation that was derivative the first time in 1872 by Ludwig Boltzmann (Duderstadt & Martin, 1979; Schwabl, 2002; Chapman & Cowling, 1970). The NS equations can derive of Boltzmann equation in a limit.

The Boltzmann equation is

Any solution about Boltzmann equation needs an expression for collision term $\Omega(f)$. The complexity of it, carry the search of simple models of collision processes, it will permit to make easy the mathematical analysis. Perhaps collision model more known was suggested simultaneously by Bhatnagar, Gross and Krook (Bhatnagar et al., 1954) and it is known like *BGK*:

Where υ is an adjusted parameter and $f^{eq}(\vec{r},\vec{v},t)$ is the local thermodynamic equilibrium of distribution. This simplification is called the "single-time-relaxation" approximation, already that the absence of space dependence, is implicating that $f(t) \to f^{eq}(\vec{v})$ the exponential manner in time like exp(-vt). This model keeps important properties of collision term in Boltzmann equation. For example, satisfies theorem H and obeys the laws of mass,

momentum and energy conservation (for this reason, it keeps the structure of hydrodynamic equations), it keeps the collision invariants

The collision term with the model BGK is writing the following form

Without knowing the form of $\Omega(f)$ there are however several properties which can be deduced. If the collision is to conserve mass, momentum and energy it is required that

Any linear combination of the ψ_i terms is also a collision invariant.

The ordinary kinetics theory of neuter gas, the Boltzmann equation is considered with collision term for binary collisions and is despised the body's force F_{α} . This simplified Boltzmann equations is an integro - differential non lineal equation, and its solution is very complicated for solve practical problems of fluids. However, Boltzmann equation is used in two important aspects of dynamic fluids. First the fundamental mechanic fluids equation of point of view microscopic can be derivate of Boltzmann equation. By a first approximation could obtain the Navier-Stokes equations starting from Boltzmann equation. The second the Boltzmann equation can bring information about transport coefficient, like viscosity, diffusion and thermal conductivity coefficients (Pai, 1981; Maxwell, 1997).

2.2 Equilibrium distribution function and theorem H

The equation (1) with the collision term described for binary collisions, it isn't lineal, is for that reason that the solution is very difficult. Nevertheless, exists a solution for Boltzmann equation, it isn't trivial and is very important and is known like *distribution function Maxwellian*. For this case the Boltzmann equation presents a non reversible behavior and distribution function lays to distribution Maxwellian, this represent the situation of an uniform gas in stationary state.

For derivate the distribution fuction Maxwellian, supposes the absence of external forces F_α and uniform gas, the distribution function is $f(\vec{r},\vec{v},t)$ independent of space coordinates \vec{r} , i.e, $f=f(\vec{v},t)$. Whereas these conditions, Boltzmann equation (1) with binary collision term is

This condition is known like *detailed balance* and can be expressed like $(\ln \overline{f} + \ln \overline{f}' = \ln f + \ln f')$

Therefore, whether f^{eq} is an equilibrium distribution, then $\ln f^{eq}$ is an invariant of the collision and it could be $\left\{\ln f^{eq} = \sum\limits_{i} \alpha_{i} \psi_{i}; \quad i=0,1,...,4\right\}$. Where ψ_{i} are invariant collisions (equation 4) and α_{i} is a constant. It writes again like

The theorem H shows that any distribution function f lays out its equilibrium state f^{eq} for long times.

If a system is not uniform, it is not in thermodynamic equilibrium then can obey law of Maxwell's speeds distribution. However, if "equilibrium absence" is not big, can considered like good approximation, all little volume (microscopic scale) is in equilibrium (considered like subsystem). This is for two reasons. First little portions of gas contain a big number of molecules. Second the necessary time for established the equilibrium in a little volume is brief in comparison with necessary time for that transport processes get equilibrium in little volume with rest of system (it is true when concentration, temperature, etc. gradients are not too much big). In consequence, can suppose that is *local thermodynamic equilibrium* so speed distribution in any volume element (macroscopic) of medium is Maxwellian, although density, temperature and macroscopic velocity change the position (Duderstadt & Martin, 1979; Schwabl, 2002; Bhatnagar et al., 1954; Pai, 1981; Maxwell, 1997; Succi, 2001; Succi, 2002; Cercignani, 1975; Lebowitz & Montroll, 1983).

2.3 From the Boltzmann equation to the lattice Boltzmann equation

Lattice Boltzmann equation can be obtain through two ways, first is through of "cellular automaton" and second starting from Boltzmann equation, it was review previously, for carries out derivation of Boltzmann's lattice equation is necessary the *space time discretization*. Immediately presents brief description of second way, it shows by pace series.

The derivation begins when the Boltzmann equation with the model BGK is writing like

In the equation (14), $f = f(\bar{x}, \bar{\xi}, t)$ is distribution function of only particle, $\bar{\xi}$ is microscopic velocity, λ is the relaxation time due to collision, and g is the Boltzmann-Maxwellian distribution function (fM), is important mention that collision term has been transforming in accordance with equation (2).

Hydrodynamic properties of fluid, density ρ , velocity \bar{u} and temperature T, could be calculated starting from momentums function f. For quantify the fluid's temperature, uses the energy density $\rho \varepsilon$ (He & Luo, 1997).

For obtaining the equation is necessary the space velocities discretization, too equilibrium function g it could be consistent with Navier-Stokes equations. The equation (20) is the evolution of distribution function f with discreet time (He & Luo, 1997; Maxwell, 1997).

2.3.2 Approximation of equilibrium distribution

A point of view very import, is the obtaining of equilibrium distribution function, it was mentioned before, of this depends obtaining appropriately the Navier-Stokes equations. Maxwell's distribution that is employing like equilibrium distribution g for unitary particle mass and "D" dimensions is

2.3.3 Discretization of the velocities

For discretization of the velocities, it will be $-\infty$ a $+\infty$ in both directions "x" and "y" for specific case in two-dimensional model (D2Q9), it will unroll in this part of chapter. The particle momentums of distribution function are very important, because of this depends the consistence of (N-S) equations. in the same way, the isotropy is keeping during the discretization, it is an important property in the symmetry of NE equations, of this form, lattice will be invariant for problem rotations.

Is important mention that an isothermic model is only necessary first momentum. These can be describing by the equation (24) two dimensions like

2.4 From lattice Boltzmann equation to the Navier-stokes equation

The popular problems of kinetics theory is the derivation of hydrodynamic equations, in certain conditions, solution of $f(\vec{r},\vec{v},t)$ transport equation is similar the form that can relate directly to continuous or hydrodynamic description. In certain conditions the transport process is like hydrodynamic limit. In 1911 David Hilbert was who proposed the existence Boltzmann equations solutions (named normal solutions), and these are determinate by initial values of hydrodynamic variables it return to collision invariant (mass, momentum and kinetics energy), Sydney Chapman and David Enskog in 1917 were whose unrolled a systematic process for derivate the hydrodynamic equations (and their corrections of superior order) for these variables.

In spite of have been proposed many approximated solutions to Boltzmann equation (including the Grad's method of 13 moments, expansions of generalized polynomial, bimodal distributions functions), however the Chapman-Enskog is the most popular outline for generalize hydrodynamic equations starting from kinetics equations kind Boltzmann (James & William, 1979; Cercignani, 1988).

2.4.1 Chapman-Enskog expansion

For show that ERB can use for describing the fluid's behavior, NS equations are derivate by process are named *Chapman-Enskog's expansion* or *multi-scale analysis*. It depends of *Knudsen's number* it was mentioned at the first part of this chapter; it is the relation between the *free mean trajectory* and the *characteristic length*.

For derivation of NS's equation, the Boltzmann equation divides in different scales for space and time variables. It has his basis in the expansion of parameter ε , it is necessary for using the Knudsen's number. In general the expansion is truncating after second order terms. The following representation is for temporal variables

3. The model

The Lattice Boltzmann Method (LBM), its simple form consist of discreet net (lattice), each place (node) is represented by unique distribution equation, which is defined by particle's velocity and is limited a discrete group of allowed velocities. During each discrete time step of the simulation, particles move, or hop, to the nearest lattice site along their direction of motion, where they "collide" with other particles that arrive at the same site. The outcome of the collision is determined by solving the kinetic (Boltzmann) equation for the new particle-distribution function at that site and the particle distribution function is updated (Chen & Doolen, 1998; Wilke, 2003). Specifically, particle distribution function in each site $f_{\hat{\mathbf{i}}}(\bar{\mathbf{x}},t)$, it is defined like a probability of find a particle with direction velocity $\bar{\mathbf{e}}_{\hat{\mathbf{i}}}$. Each value of the index i specifies one of the allowed directions of motion (Chen et al., 1994; ThÄurey, 2003).

For this work we use D2Q9 and periodic boundary conditions in the inflow and outflow plane and non-slip boundary (bounce-back) conditions on the walls and the porous matrix. Bounce-back conditions were used whenever the fluid hit a node of the porous matrix. Our porous media is represented by blocks that are projections in the plane of actual three dimensional geometries Stability is improved by considering the porous matrix as made out of these blocks and makes the code less noisy as well. To initialize the lattice, a constant body force (F) is used and acts during the simulations, which physically corresponds to a constant pressure gradient. In this work we focus only on externally applied pressure; namely we deal with pressure-driven flows.

Fluid flow in porous media is modeled here by using a modification of the Lattice Bhatnagar-Gross-Krook (LBGK) technique (eq. 32).

Fluid density and velocity are calculated as follows: $\rho = \sum_{i=0}^{b} f_i$; $\rho u = \sum_{i=0}^{b} f_i \cdot e_i$. The method

used in this work involves a modification of the LBGK, where instead of constant viscosity, the effective viscosity is used directly as a rate-dependent relaxation time parameter avoiding the calculation of the matrix elements for Ω_{ij} (Boek et al., 2003; Ahronov & Rothman, 1993; Rakotomala et al., 1996). τ Is the relaxation time provided by the kinematic fluid viscosity.

$$\tau = \frac{1}{2} + 3k \left(\frac{dv_x}{dy}\right)^{n-1} \tag{38}$$




Fig. 1. LBGK velocity profiles and Analytical Navier Stokes velocity profiles in a rigid pipe.

To test our algorithm, simulations were run for fluids in a rigid pipe with n = 0.33, 0.56, 1.0, 2.0 and k = 0.001, 0.005, 0.5, 10.0 respectively, in a 200×200 lattice. The steady-state velocity profiles were reached after 30,000 times step. Dimensionless velocity profiles from the LBM and analytical solutions are shown in Figure 1. Our numerical results and analytical solutions are within a 0.9% error (the maximum value being for n>1).

Next step in our model is the simulation of the fluid flow in porous materials (or packed beds). These materials have a portion of space occupied by heterogeneous or multiphase matter.

In studying flows through porous media, we extend the LBM so as to study arbitrary and random approaches. Even at a first glance, many porous media, particularly the natural ones, show that the distribution of pores is random (Christakos & Hristopulos, 1997), so randomness is a really important factor to describe natural and man-made porous materials; they usually possess formidably complicated architecture. In modeling, reasonable idealizations have to be assumed (Dullien, 1992; Gibson and Ashby, 1988; Telega and Bielski, 2003).

Simple predictions concerning the flow of non-Newtonian fluids through porous media (Bird et al., 1960) have long been provided. Though Darcy's law for the flow of Newtonian fluids through a porous medium agrees with a model of parallel tubes, analogous behavior is not obvious for non-Newtonian fluids. This model does not take into account the tortuosity of the flow path among others; an additional nonlinearity in this case. As a first step, by assuming that a porous medium can be viewed as a collection of parallel pipes, the relation between flux and force for a non Newtonian fluid can be approached by

$$q = C \left(\frac{dP}{dx}\right)^{1/n} \tag{39}$$

where q is the volumetric rate of flow per unit area. C is a proportionality constant, function of the consistency index k, the porosity ε and the effective permeability K. For n=1,

equation (39) reduces to Darcy's law. In practically all cases, eq. (39) is valid as long as the generalized Reynolds number; $\operatorname{Re}_{\operatorname{gen}} = \left\{ \left[\left(2\varepsilon/3(1-\varepsilon) \right) \operatorname{D}_{\rho} \right]^n \left(\overline{\operatorname{v}}/\varepsilon \right)^{2-n} \rho \right\} / \left[8^{n-1} k \left(3n + 1/n \right)^n \right]$

does not exceed some value between 1 and 10. Here, D_{ρ} is a length dimension scale proposed by Collins (Geankoplis, 2000).

Our LBM are such that all experiments performed in this work are in the range $Re_{gen} < 1$ and can provide some output in the relative importance of the different parameters (for the fluid, and the geometrical structure) with statistical validation. We fully comply with the empirical macroscopic scale relation (39) obtained experimentally.

Two different types of porous media are studied here: a) *Arbitrarily generated porous media*. In this case, the authors propose a set of porous media totally constructed by arbitrary choice, fulfilling the following important conditions. At first percolation is guaranteed. Secondly, well defined, interconnected channels are constructed and finally low tortuosity is provided.

b) Randomly generated porous media. In this case, the medium is generated by means of a random configuration. The Box-Muller method for generating standard Gaussian pseudorandom numbers is used to obtain the positions of the seeds in the solid matrix, 3 *X* 3 lattice sites nodes are defined as blocks around each seed; thus providing the porous matrix. This simplified geometry substitutes the projections on a plane of more complex and realistic cases (throats channels, chairs, cylinders, etc) improve stability and avoids noisy results.

The core of the Box-Muller method is a transformation that takes as inputs random variables from one distribution and as outputs random variables in a new distribution function. It allows us to transform uniformly distributed random variables to a new set of random variables with a Gaussian distribution. We start with two independent random numbers, x_1 and x_2 , which come from a uniform distribution (in the range from 0 to 1). Then, apply the transformations $y_1 = \sqrt{-2\ln x_1}\cos(2\pi x_2)$ and $y_2 = \sqrt{-2\ln x_1}\sin(2\pi x_2)$ to get two new independent random numbers that have a Gaussian distribution with zero mean and a standard deviation of one. This method of generating random porous media produces similar pore space characterization that several natural media.

Moreover, as it is well known for a Newtonian fluid that standard Darcy law can be used in order to obtain permeability. Namely

$$K = \mu v / \left(\frac{dP}{dx}\right) \tag{40}$$

Here K is permeability and μ is the viscosity for a Newtonian fluid. In the case of a non-Newtonian fluid with power law viscosity, we introduce the apparent viscosity (instead of the standard viscosity) which is given by the following equation.

$$\mu_{\text{app}} = k \left(dv_{x} / dy \right)^{n-1} \tag{41}$$

Thus, effective permeability for non-Newtonian fluids (with power-law viscosity) is calculated in this work as follows

$$K = \mu_{app} v / (dP/dx) = k (dv_x/dy)^{n-1} v / (dP/dx)$$
(42)

4. Local effective permeability




Fig. 2. Randomly generated porous media, porosity 47.4%, flow paths (left) and permeability bands in lattice units (right) for non-Newtonian fluids, n=0.529, n=2 and Newtonian fluids. Here F represents the pressure gradient.

We work with porosities 47.4%, 51.9%, 68.7% and 71.9%, randomly and arbitrarily generated, outputs of our experiments are presented (see figures 2-4). This is done for n=2, n=1, n=0.529 and different pressure gradients. Actually, if n=1, the permeability bands do not depend on the pressure gradients as expected in natural systems for porosities 50% or larger. In these Figures, the pore space characterization is shown at the upper left corner of the figure. Secondly, right below, the flow paths in each particular case are shown (from the numerical data, vuggy zones can be detected, among others). Finally, in the right part of each figure, the permeability bands produced by our LBM are introduced. Although qualitative in part, important contributions of our paper are the correlations of the band structures with different pressure gradients (F), fluid parameters (F), the index number), geometrical factors (porosity and tortuosity), and randomness.

In Figure 5, we explore the role of different porosities and pressure gradients in arbitrarily generated porous media, for a non-Newtonian fluid (n=0.529). The progressive introduction of high permeability bands as a natural consequence of the geometry, fluid, and flow parameters shows interesting patterns, as can be observed.

Uncertainty is well recognized as an important factor in natural porous media (in fact, it is well known that effective permeability is subject to greater uncertainty than porosity) and numerous studies have employed random methods to model Newtonian flow in subsurface porous media by assuming a given effective permeability probability density function.

It is important to construct models that are able to closely mimic the heterogeneity of actual porous media and sufficiently efficient to allow simulation of flow and transport phenomena. To predict the network flow at core scale (for instance, in hydrocarbon reservoirs, packed beds and aquifers), we propose to construct the permeability probability distribution within our model. Our results are shown in Table 2 in this work. Although it is widely understood that the selection of a particular effective permeability probability density will markedly influence simulation results in applications, only a few studies (this paper, among others) describe the manner in which to construct these effective permeability probability density functions from mesoscale information.

We correlate the effect of randomness, porosity, and fluid parameters with permeability fields and probability distributions predicted by our model, thus improving our understanding of heterogeneous media for applications to natural systems. Normally, at core scales for reservoirs and aquifers; among others, the unknown permeability distribution in the subsurface on all length scales is much needed for practical goals (Sitar et al., 1987; Cooke et al., 1995).

Normally, first step in estimating permeability from thin-sections of natural media is to convert representative digital images into binary images. These binary versions are used for porosity estimation and as conditional data for the stochastic pore-structure realizations.

Flow simulations are then conducted on each pore-structure realization. Our approach then provides the local effective permeability estimate for each bed type (see for instance Figures 2 to 5).

We perform experiments for non-Newtonian fluids and obtain permeability bands (see Figures 2-5) for the following power-law fluids A) n = 0.529, B) n = 1 and C) n = 2. This is done in the following cases: a) arbitrarily generated porous media and b) randomly generated porous media, porosities 47.4%, 51.9%, 68.7% and 71.9%, and a number of

pressure gradients, see Figures 2 to 5. Also arbitrarily generated porous media, flow paths, and the obtained permeability fields for a number of porosities, pressure gradients and n=0.529 are introduced in Figure 5. We then perform a null hypothesis analysis over the data by Kolmogorov-Smirnov contrast, obtaining the best fitting effective permeability distribution for each case, as shown in Table 2. Kolmogorov-Smirnov contrast (a non-parametric null hypothesis analysis) is a technique where two data distributions are compared (the one to be tested and another one hypothetically true) and they are accepted to be statistically the same, provided the maximum distance between both is below a certain threshold.




Fig. 3. Arbitrarily generated porous media, porosity 71.9%, flow paths (left) and permeability bands in lattice units (right) for non-Newtonian fluids, n=0.529, n=2 and Newtonian fluids. Here F represents the pressure gradient.




Fig. 4. Randomly generated porous media, porosity 71.9%, flow paths (left) and permeability bands in lattice units (right) for non-Newtonian fluids, n=0.529, n=2 and Newtonian fluids. Here F represents the pressure gradient.




Fig. 5. Arbitrarily generated porous media, flow paths and permeability bands in lattice units for non- Newtonian fluid (n=0.529) and different pressure gradients (F) are shown. We study porosities 64.8, 66.6%, 68.7%, 70.1%, 71.9%.




Fig. 5. (Continued)




Fig. 5. (Continued)

5. Conclusions

The 2-D permeability variations considered in this work are applicable to real contaminated aquifers where the length and width of high-permeability inclusions are large relative to their height (or thickness). For example, fluvial deposits as "cut-and-fill" (e.g., scour pool and dissection elements) and accretionary (e.g., horizontally bedded gravel sheets) elements can have high length- and width-to-thickness ratios. The 2-D permeability variations considered in this work are not applicable to more complex contaminated aquifers, e.g., where high-permeability inclusions do not have large length- and width-to-thickness ratios, or where tortuous 3-D flows cause streamlines to twist.

Effective permeability distributions have been used to study geological phenomena for petroleum technology, among others. In this paper, a study of how different geometrical features and rheological parameters affect local permeability of a porous medium has been conducted in order to enhance the knowledge of the local permeability distribution and its importance when developing global permeability models (Lundström et al.,2004; Lundström & Norlund, 2005). We conclude that randomness, porosity, and the power law index for non-Newtonian fluids play an important role in the local effective permeability distribution obtained for each experiment (Normal, Gamma, or any other). Our detailed results are presented for a range of porosity from 47.4% to 71.9% in this paper. We are able of using our approach for porosities as low as 10%, but then the average relative error on n (comparing the experimental with the value obtained by LBM) can reach a maximum of 6.8% (for n=0.529). See Table 2.

We consider several heterogeneous porous media representations to illustrate flow performance; all of them are two-dimensional. A number of high-permeability inclusions within low-permeability zones are obtained from a variety of fluid characterizations (see Figures 2-5). The effect of porosity, randomness, fluid and flow parameters are correlated with permeability bands in a number of cases; original outputs shown in this paper.

It is intriguing to see how Newtonian fluids always produce symmetrical bands and high permeability bands included into small permeability bands with several layers provided porosity is large. We can also remark that for n<1, bands of low permeability are more numerous than in the case of n>1. Some throats can be formed if we introduce randomness and high porosity, see Figure 4, in the case of n<1 and high pressure gradients. Additional anisotropy appears for small porosity, see Figures 2.

Streamlines determined by numerical simulation are obtained and shown in Figures 2-5. From these, and our numerical results (rough input data to construct Figures 2-5), it is clear that flow is mainly parallel and uniformly distributed in the low-permeability zone. However, in the region containing the high-permeability inclusion there is very little flow in the low-permeability zone and almost all flow is focused in the high-permeability inclusion. In other cases, a number of high-permeability inclusions within a low-permeability zone are produced. In regions between high-permeability inclusions, most flow is uniformly distributed, see Figure 5. In regions containing high-permeability inclusions, most flow is focused in these inclusions and is parallel to the boundaries. From our numerical results and the path flows, vuggy zones can also be easily identified.

The effective permeability data (input for our figures), represented by path flow, show that the "vuggy" features are always in the neighborhood of the walls distributed around a central "non-vuggy" zone. These results show particularly low effective permeability near the entrance and towards the end of the tunnel. It is clear that a zone of high effective permeability can be found towards the end of the tunnel, especially for Non-Newtonian fluids and low effective permeability near the tunnel walls. Similar studies for effective permeability maps, as functions of the distance from the tunnel wall and the distance from the entrance, for sandstone perforated with underbalance have already been reported (Karacan and Halleck, 2000).

It is straightforward to see, from our experiments, that if n (fluid parameter, power law index) increases, the number of homogeneous effective permeability zones decreases; namely the local probability data take values in a smaller set of numbers. Besides, for Newtonian flows, the effective permeability field is always symmetric for large porosity, no matter the detailed structure of the porous media. For non-Newtonian fluids, this symmetry may be affected by an angle sweeping the horizontal axis, provided the porous medium is not randomly generated (here, symmetry in the local probability field is lost) and most flow is globally oriented at a clear angle to the horizontal direction.

Pseudoplastic fluids in randomly generated porous media generate effective permeability fields, where zones of constant values are oddly shaped (bottle necks, among others, that can be considered scale up, equivalent to geometrical features, result of our mesoscale experiments), totally abnormal behavior can also be obtained for a different set of parameters. There seems to be a critical value for porosity to keep symmetric effective permeability fields. Our results can be used as models for materials with several zones

where different fine erosion and deposition processes occur and provides an original approach to learn from the effect of the fluid parameters (n, the power law index) in the flow, provided the remaining features are constant.

Finally, in what follows, we learn how our LBM (mesoscale information) can be used, by the inter-relationship of geometrical factors, randomness and fluid parameters, to produce permeability (as probability laws) distributions in order to predict scaled up subsurface permeability bands.

In our experiments, normal distribution for effective permeability is obtained mostly for randomly generated porous media provided the fluid is Newtonian or shear thinning, see Table 1. Eventhough this distribution is not expected for arbitrary generated porous media, it may appear provided the fluid is Newtonian. It should be remembered that the use of normal distribution can be theoretically justified in situations where a large number of effects act additively and independently together. The porous media, LBM and fluid factors used in these experiments can be a first approach to the effective permeability distribution of caffeine and testosterone solutions in silicone membrane (Khan et al., 2005).

Provided porosity increases, our results show that for Newtonian and shear thickening fluids, regardless the way the porous matrix (randomly or not) was generated, the effective permeability distribution tends to be Weibull. It is possible to conclude that the experiments shown in Table 1 as Weibull effective permeability distributions are describing systems involving a weakest link and/or non-linear effects derived from the fluid viscosity. Statistics of the mechanical and failure properties on the grain scale are often assumed to follow the Weibull distribution; here, the significant influence of microcrack length statistics has been emphasized (Wong et al., 2006). A Weibull distribution can accurately describe experimentally determined time trends of the infiltration rate (Faybishenko et al., 2003).

Infiltration experiments conducted on packs of rocks show that fluxes may stabilize into an exponential distribution (Tokunaga et al., 2005). Exponential distribution for effective permeability has also been reported in the analysis of heterogeneities in porous media (Savioli et al., 1996). In our simulation, the effective permeability distribution is exponential only for arbitrarily generated porous media and shear thinning fluids, no matter the porosity used in the simulation, see Table 1. They are fit to be used as models for petroleum processes. We believe that arbitrarily generated porous media may provide the deterministic background to obtain exponential effective permeability distributions since these are found in situations where certain events occur with a constant probability per unit distance. Clearly, for non-Newtonian fluids, non-linear effects are introduced; these are small if n tends to one.

The gamma distribution has been used as a statistical representation of surface roughness for flow in unsaturated fractured porous media and tortuosity distributions in porous media (Or and Tuller, 2000; Lindquist et al., 1996). In our simulation, the effective permeability distribution is gamma for shear thickening fluids and rather low porosity, regardless the way the porous matrix was produced, see Table 1. So the gamma effective permeability distributions found in our experiments can be considered applicable to particle tracking. This process has been modeled as the sum of elementary steps with independent random variables in the sand.

In our experiments, the effective permeability distribution is Generalized Extreme Value distribution for arbitrarily generated porous media, porosity 71.87%, n=2. This seems to be a very particular case, probably coming from a strong non-linearity. This is the limited distribution of the maxima of a sequence of independent and identically distributed random variables. Extreme hydrometereological phenomena follow an extreme distribution (Gutiérrez-López et al., 2005). At constant potential, the maximum peak currents in different time intervals during a potensiostatic test follow extreme distribution (Zuo et al., 2000).

Summarizing, this paper has presented a method to study scale up processes (mesoscale to core scale) of flow in porous media from geometry, fluid parameters, stochastic realization and LBM; namely, parameters such as tortuosity (arbitrarily generated porous media always have a clearly smaller tortuosity than randomly generated porous media), randomness in void space, geometrical distribution, porosity and consistency index of the non-Newtonian fluid, among others. This model is ready to predict as an output from thin small samples, effective permeability bands and the corresponding subsurface probability distributions scaled up for subsurface reservoirs, aquifers, etc.

Simultaneous Elimination of Carbon and Nitrogen Compounds of Petrochemical Effluents by Nitrification and Denitrification

1. Introduction

Human activities have resulted in the increase of nitrogen and carbon content in wastewater and groundwater affecting the environment (Bremmen, 2002). The average water consumption in Mexico is close to 0.25 m³/d, resulting in municipal and industrial wastewater generation between 168 and 232 m³/s, respectively. Only 12 and 20% of wastewater has received some treatment (Monroy et al., 2000). The increase of nitrogen compounds such as nitrate, nitrite and ammonium in superficial and groundwater has caused several environmental effects such as eutrophication, toxicity to aquatic organisms, loss of biodiversity (Galloway, 1998; Mateju et al., 1992; Schimel et al., 1996); and human health damages as methahemoglobinemia (Mateju et al., 1992; Morgan-Sagastumen et al., 1994); formation of nitrosoamines which are potentially carcinogenic compounds (Cerhan et al., 2001, as cited in González-Blanco et al., 2011) and gastric cancer (Knobeloch et al., 2000; Ward et al., 2005). In the north of Gulf of Mexico, an important hypoxic zone has been detected where oxygen concentration is lower than 2 mg/l due to high nitrate discharges and eutrophication (Alexander et al., 2000; McIsaac et al., 2002). Nitrate concentrations between 7 and 156 mg/l (Antón & Díaz, 2000) and higher than 80 mg/l (Muñoz et al., 2004; Pacheco et al., 2001) have been determined in aquifers of middle and south of Mexico, respectively. These nitrate concentrations are higher than the maximum levels established by Secretary of Environmental and Natural Resources (SEMARNAT), NOM-003-ECOL-1997 (15 and 40 mg total nitrogen/l) (Diario Oficial de la Federación, 1998) and the United States Environmental Protection Agency (USEPA, 2007) (10 mg N-NO₃-/l, 1 mg N-NO₂-/l and 10 mg N-NH₄⁺/l). Therefore, it is clear the need of applying effective wastewater treatments for reducing nitrogen contamination.

One of the most important sources of carbon pollution is the petrochemical industry. In 2009, more than 85 million of crude oil barrels were produced in the world in order to satisfy the energy and derivatives demand for industrial uses. At present, Russia is the first crude oil producer followed by Saudi Arabia and USA. Both of them produce almost 30% of

the total crude oil. In 2010, Mexico was the seventh petroleum crude oil producer (close to 2.5 million barrel/d) accounting to 0.05 million barrel (eq)/d of derivatives. Monoaromatic hydrocarbons such as benzene, toluene and xylenes (so-called BTX) are also produced from crude oil (Kirkeleit et al., 2006) by catalytic reforming (dehydrogenating process of the aliphatic compounds) and by alkylation and transalkylation processes (Perego & Ingallina, 2004).

A crescent BTX production has been observed all over the world. For instance, in 2000, the USA toluene production was close to 6.5 million of tons. In 2002, xylenes production was around 7 million of tons while in 2005, the USA benzene production was around 7 million of tons with a higher production of toluene and xylenes. BTX are widely used for producing paints, rubber, adhesives, varnishes, agrochemicals, polymers among many other products. In fact, almost 30% of gasoline content corresponds to BTX (Hartley & Englande, 1992; Sander et al., 2010). The average daily gasoline sales in Mexico in 2001 were close to 547,400 barrels (PEMEX Petrochemical, 2001). Accidental spills, evaporation of industrial sources, leakage from storage tanks in gas stations, industrial discharges and car combustion have resulted in environmental pollution with BTX. The great mobility abilities and toxicity of the BTX compounds are of major concern for environment and human health (Coates et al., 2002). These aromatic compounds have a high vapor pressure and are relatively watersoluble. Some of the physical and chemical properties of BTX are illustrated in Table 1. In this sense, BTX presence in soil, air, surface and groundwater has been increasingly reported (Jain et al., 2011; Martínez et al. 2009; Peña-Calva et al., 2004b; Steen-Cristenesen & Elton, 1996).

Concentrations (mg/l) ranging from 9-14, 23-81 and 13-171 of benzene, toluene and isomers of xylene have been respectively reported in groundwater (Gersberg et al., 1989). Likewise, considering the non polar characteristic of these compounds, there is an important bioaccumulation of BTX in the lipid fraction of cell membrane. Benzene is the most dangerous of the BTX compounds as it is a known human carcinogen (Huff, 2007). Breathing low levels of benzene can cause drowsiness, dizziness, rapid heart rate, confusion, and unconsciousness whereas higher levels of this compound can result in death (Ashly et al., 1994). It has been reported that benzene may induce damages to the bone marrow and cause anemia (Fishbein, 1985; Vereb et al., 2011), depression in the immune system and leukemia (Huff, 2007). The narcotic and neurotoxic properties of toluene are the major health hazards in humans due to its tendency to accumulate in adipose tissue. Toluene is highly lipophilic affecting the central nervous system (Fornazzari et al., 2003) where it seems to inhibit neuronal transmission by causing changes in protein conformation and hence in the membranal transport (Rosenberg et al, 1988). Acute intoxication from inhalation is characterized by euphoria, hallucinations, dizziness, confusion, headache, ataxia, stupor, and coma. Exposition over long periods of time may produce neuropsychosis, cerebral degeneration with ataxia, peripheral neuropathies, cognitive ability problems, ototoxicity and deafness (Waniusiow et al., 2008). However, there are no epidemiological evidences whether toluene induces cancer in persons exposed to the solvent (Fishbein, 1984; Weelink, et al., 2010). Xylenes seem not to be as toxic as benzene and toluene since their values of LD50 range from 200 to 4000 mg/kg for animals (Fishbein, 1985). According to Mexican legislation (NOM-127-SSA1-1994), (Diario Oficial de la Federación, 1994), the maximum levels established in potable water for BTX are (mg/l): benzene 0.01; toluene 0.3 and isomers of xylene 0.5. In the United States the maximum levels are 0.0005, 1 and 10 mg/l for benzene, toluene and mixed xylenes, respectively (USEPA, 2006, as cited in Farhadian et al., 2008). All of these BTX characteristics clearly illustrate why these compounds represent an environmental and health challenge.

There are different alternatives for nitrogen and carbon compounds removal from contaminated water, such as physical-chemical and biological processes. Gravity separation, volatilization, adsorption, dialysis, inverse osmosis, ultrasonic radiation or chemical reactions as phentom are some of the most used physical-chemical processes (Jacobs & Testa, 2003; Thoma et al., 2006). Nevertheless, most of these processes are not cost-effective, are poorly efficient when highly contaminated streams are treated and generally give undesirable residues (Farhadian et al., 2008). On the other hand, biological treatment processes are economically feasible, result in highly nitrogen and carbon consumption efficiencies and conversion to innocuous products such as N_2 , CO_2 and water, respectively. Nitrogen compounds can be biologically removed from water by the coupling of nitrification and denitrification processes (Cuervo-López et al., 2009).

BTX are chemically reduced compounds, thus, their biologic oxidation is thermodynamically favored (Table 7). Many biological attempts have been conducted in order to remove these volatile organic compounds from the environment. Aerobic treatments have been widely proposed for BTX elimination (Duetz et al., 1994; Haigler et al., 1992; Rozkov et al., 1998; Yerushalmi et al., 1999). Removal of BTX mixtures appeared to be favored at aerobic conditions (Deeb & Alvarez-Cohen, 1999; Prenafeta-Boldú et al., 2002); however, negative effects such as inhibition or catabolic repression have also been reported at these conditions

(Chang et al., 1993; Duetz et al., 1997). Nevertheless, aerobic conditions might lead to important BTX stripping to atmosphere due to their volatilization characteristics. In fact, depending on aeration system, losses of BTX have reached up to 30% of their content (Zytner et al., 1994, as cited in Farhadian et al., 2008). In spite of complete removal of these compounds has been achieved (Deeb & Alvarez-Cohen, 2000), high conversion into biomass has also been reported (Chang et al., 1993; Reardon et al., 2000; Reardon et al., 2002). Biomass generation, stripping into atmosphere, besides their relatively low water-solubility seemed to be the most important disadvantages for aerobic treatment utilization. Therefore, anaerobic biological treatments appeared to be an adequate alternative for BTX removal.

Attempts for BTX removal using different electron acceptors such as nitrate (Burland & Edwards, 1999; Major et al., 1988; Martinez et al., 2007; Peña-Calva et al., 2004b; Weelink et al., 2010), sulfate (Craig et al., 1996; Feris et al., 2008) and CO₂ (Corseuil et al., 1998; Lovley, 2000; Morgan et al., 1993; Weelink 2010) have been conducted. There is scarce information describing interaction of BTX mixtures under anaerobic conditions. Benzene appeared to be recalcitrant in most of the cases (Weelink 2010); however, some investigations reported benzene removal under nitrate reducing conditions (Burland & Edwards, 1999). Rapid toluene consumption has been reported under sulfate (Beller & Spormann, 1997), hem (Kane et al., 2002) and methanogenic (Washer & Edwards, 2007) conditions. Most of these studies are focused on the disappearance of the aromatic compounds and the electron acceptors; however, no information about products formation is mentioned as no mass balances are indicated. Emphasize on the dissimilative catabolism has not been made, and further research on this topic is needed. Likewise, scarce consumption rate values are included; however, most of the values reported suggest that the processes are slow due to the microbial growth is slow and scarce. Information about these parameters would be useful for practical applications.

This chapter pretends to succinctly present the current knowledge of biological removal of ammonium, nitrate, and BTX compounds by nitrification and denitrification and describe some environmental factors that affect these microbial processes. Likewise, the goal of this work is to give practical information in order to obtain processes mainly mineralizing. The work is divided into two parts. In the first part, the simultaneous elimination of ammonium and BTX compounds by nitrification is described. In the second part, the simultaneous consumption of nitrate and BTX compounds by denitrification is presented. A general description of microbiology and physiology of nitrification and denitrifying processes are also described. In the case of toluene consumption by denitrification, studies carried out in batch and continuous cultures are also included. The importance of performing a complete evaluation of the biological processes through response variables such as efficiencies, yields, consumption and production rates, mass balances for the development of environmentally acceptable wastewater treatment processes is emphasized.

2. Nitrification

Nitrification has been extensively investigated as a very useful process in the first step of nitrogen removal in biological wastewater treatment. The oxidation of ammonia and nitrite by nitrifying processes generates nitrate for denitrifying processes where nitrate is converted to molecular nitrogen.

2.1 Definition of respiratory process

Nitrification is the biological oxidation of ammonium (NH_4^+) to nitrate (NO_3^-) via nitrite (NO_2^-). It is an aerobic respiratory process where nitrifying bacteria use ammonium and nitrite as energy sources, carbon dioxide as a carbon source, and molecular oxygen as the final electron acceptor (Prosser, 1989). The nitrifying process is composed of two consecutive steps: 1) the oxidation of ammonium to nitrite that is mainly carried out by ammonium-oxidizing bacteria (AOB) and 2) the oxidation of nitrite to nitrate that is catalyzed by nitrite-oxidizing bacteria (NOB) (Table 2). As indicated by the free energy change (ACG^-) values, the oxidation of hydroxylamine (NH_2OH) to nitrite is the main step where the AOB obtain energy. The ACG^- is lower for nitrite oxidation than for ammonia oxidation and the consequence is a lower growth yield for NOB than for AOB. Due to the low energy availability for cellular biosynthesis in the respiratory process, growth of nitrifying bacteria is slow and scarce, even in optimal conditions. Growth yields have been found to be 0.08 g cells/g NH_4^+ -N for AOB and 0.05 g cells/g NO_2^- -N for NOB, respectively (Wiesmann, 1994). Doubling times have been reported to vary between 7 and 24 h for ammonium-oxidizing species and 10 and 140 h for Nitrobacter species (Bock et al., 1991).

2.2 Microbiological aspects

Nitrification is carried out by two groups of Gram negative chemolithoautotrophic bacteria that belong to the Nitrobacteraceae family: the ammonium- and nitrite-oxidizing bacteria. There are no known autotrophic bacteria that can catalyze the production of nitrate from ammonium (Kowalchuk & Stephen, 2001). The AOB are species of the following genera: Nitrosomonas, Nitrosospira, Nitrosolobus, Nitrosococcus, and Nitrosovibrio, being Nitrosomonas and Nitrosomonas europaea the genus and species better studied, respectively. Ammonia can also be transformed by a number of heterotrophic fungi and bacteria but it is generally accepted that chemolithotrophs are the primary nitrifiers in many systems (Kowalchuk & Stephen, 2001). While AOB are considered critical in nitrification, recently it has been reported that two major microbial groups are now believed to be involved in ammonium oxidation: AOB and ammonium-oxidizing archaea (You et al., 2009). Candidatus "Nitrosopumilus maritimus" and Candidatus "Cenarchaeum symbiosum" have been shown to be ammonia-oxidizing archaea containing the genes for all three subunits (amoA, amoB, and amoC) of ammonia monooxygenase, the enzyme responsible for ammonia oxidation (Hallam et al., 2006; Könneke et al., 2005, as cited in You et al., 2009). The genera of NOB are: Nitrobacter, Nitrococcus, Nitrospina, and Nitrospira. Most of the physiological and biochemical investigations have been carried out with members of the genus Nitrobacter. Some strains of

Nitrobacter have been shown to be able to grow heterotrophically but their growth is very slow (Bock et al., 1991).

2.3 Biochemistry aspects

In the ammonium-oxidizing process, the first reaction is catalyzed by an ammonia monooxygenase (AMO) (Eq. 1) and the second one by a hydroxylamine oxidoreductase (HAO) (Eq. 2).

In the first reaction of ammonia conversion into hydroxylamine (NH₂OH), one of the oxygen atoms from O_2 is transferred to NH₃, producing hydroxylamine, while the other is involved in H₂O formation (Hollecher et al., 1981). It is generally accepted that ammonia (NH₃) rather than ammonium (NH₄+) is the real substrate for the enzyme AMO. AMO is located in the cytoplasmic membrane. The broad specificity of the AMO has shown to permit the co-oxidation of numerous organic compounds, including recalcitrant aliphatic, aromatic, and halogenated molecules (Juliette et al., 1993; Keener & Arp, 1993, 1994; McCarty, 1999). The second reaction of the ammonia oxidation, the NH₂OH conversion into NO₂-, is catalyzed by the complex enzyme system HAO. HAO is located in the periplasmic space (Whittaker et al., 2000). Two of the electrons produced in the second reaction are used to compensate the electron input of the first reaction, whereas the other two are passed via an electron transport chain to the terminal oxidase, thereby generating a proton motive force (Kowalchuk & Stephen, 2001). This proton motive force is used as the energy source for ATP production.

The second step in nitrification is the oxidation of nitrite to nitrate and is catalyzed by the enzyme nitrite oxidoreductase (NOR) (Eq. 3). In this reaction, the oxygen atom is derived from water. NOR is located in the cytoplasmic membrane and is composed of cytochromes *a* and *c*, a quinone and a deshydrogenase dependent on NADH (Aleem & Sewel, 1981; Spieck et al., 1998).

2.4 Environmental factors affecting nitrification

Nitrification is affected by environmental factors such as temperature, pH, substrates concentrations (O₂, NH₃, and NO₂-), and organic matter (Bernet & Spérandio, 2009). Such parameters can cause an effect on both the anabolic (biosynthetic process) and catabolic (respiratory process) processes.

Growth conditions are optimal at 25-30°C and pH 7.5-8.0 for AOB and at 28-30°C and pH 7.6-7.8 for NOB (Bock et al., 1991). In nitrifying processes, ranges of 25-30°C and pH 7.5-8.0 are generally used to obtain a successful nitrification. However, nitrification has been shown to occur in acidic conditions at pH = 5 (De Boer & Kowalchuk, 2001). pH has also an indirect

effect on nitrification by acting on the equilibrium ammonium/ammonia (NH₄+/NH₃, pKa = 9.25 at 25°C) (Hoffman, 2004). At alkaline pH values, the availability of NH₃ is not limited and this would be favorable for nitrification considering that NH₃ is the substrate for AMO (Suzuki et al., 1974). However, it is also known that high concentrations of free ammonia inhibit nitrification (Anthonisen et al., 1976; Vadivelu et al., 2006b). In aerobic nitrifying reactors operated under constant aeration and agitation, NH₃ can be lost from the system by volatilization. On the other hand, the ammonia oxidation to nitrate produces protons and leads to an acidification of the environment. This decrease in the pH value can inhibit nitrification by diminishing the availability of NH₃. pH also establishes the concentrations of nitrite (NO₂) and nitrous acid (HNO₂) with a pKa value of 3.34 at 25°C (Whiten et al., 2008). It has been observed that high concentrations of nitrite can inhibit the nitrification process and that could be mainly related to the pH values through the formation of HNO2. Nitrous acid is known to inhibit nitrification, thus, low pH values must be avoided in nitrifying processes (Anthonisen et al., 1976; Vadivelu et al., 2006a, 2006b). Recently, Silva et al. (2011) reported that the nitrite-oxidizing process was more sensitive to the presence of nitrite than the ammonium-oxidizing process, suggesting that nitrite accumulation in nitrification systems should be controlled to avoid a higher accumulation of nitrite and a decrease in nitrate yield. In consequence, pH value is generally controlled in nitrifying systems and maintained between 7.5 and 8.0 to avoid operational problems.

In the nitrifying respiratory process, oxygen is used as the final electron acceptor. It is generally assumed that oxygen concentrations higher than 2 mg/l are adequate for a successful nitrification (Gerardi, 2002). Nitrification is very sensitive to low dissolved oxygen concentrations. AOB and NOB present different affinities for oxygen (K_{O2}) and NOB are more sensitive to O₂ limitation than AOB (Laanbroek & Gerards, 1993). Therefore, low dissolved oxygen concentration, around 0.2 to 0.5 mg/l, is a possible condition for limiting nitrite-oxidizing activity in nitrification systems (Bernet & Spérandio, 2009). Partial nitrification is used to obtain nitrite instead of nitrate as end product. Partial nitrification is involved in several processes (OLAND, CANON, SHARON, ANAMMOX, denitrification via nitrite) where the shortcut of nitrate could mean considerable savings in demand for oxygen and carbon source (Ahn et al., 2011; Moore et al., 2011; Peng & Zhu, 2006).

The high sensitivity of nitrifying bacteria to the toxic or inhibitory effects of organic compounds is well-documented, and it is known that the stability of nitrifying systems in wastewater treatment can be altered by the presence of organic matter (Schweighofer et al., 1996). Most of the studies on effects of organic compounds on nitrification have used axenic cultures or consortia such as activated sludge as inoculums. It has been shown that the effects mainly depend on the type and chemical structure of the organic pollutant as well as its concentration and hydrophobicity but also the type of culture (axenic or consortium) and the origin of the sludge (Gómez et al., 2000; Zepeda et al., 2006).

2.5 Ammonium and BTX removal

2.5.1 Inhibitory effects of organic matter and BTX on nitrification process

There are numerous studies in the literature on the inhibitory effects of organic compounds on nitrification. Some works with axenic cultures of *Nitrosomonas* sp. or *Nitrobacter* sp. have been focused on the growth inhibition of bacteria (Jensen, 1950; Steinmüller & Bock, 1976),

others on the activity of the AMO (McCarty, 1999). There is also information on the effects of different organic substances on the nitrifying respiratory process of microbial consortia (Gómez et al., 2000, Silva et al., 2009; Zepeda et al., 2003, 2006). Various hypotheses have been proposed to explain the negative effects of organic matter on nitrification. In axenic cultures of Nitrosomonas europaea, it has been observed that the AMO had a broad substrate range for catalytic oxidation and the inhibitory effects of many organic substances would be due to competition for the active site (Chang et al., 2002; Hyman et al., 1985; Juliette et al., 1993; Keener & Arp, 1993). The enzyme AMO contains copper and iron, and metal chelators such as allylthiourea are inhibitory (Bremmer & Bundy, 1974; Hauck, 1980; Hooper & Terry, 1973, as cited in Bock et al., 1991; Hyman et al., 1990; Zahn et al., 1996). In the literature, it was also mentioned that nitrifying bacteria are susceptible to organic compounds because of a limitation of reducing power (lizumi et al., 1998; Shiemke et al., 2004), the formation of covalent binding with the enzyme AMO (Hyman & Wood, 1985), or the hydrophobic character of the organic molecules and their effects on biological membranes (Sikkema et al., 1994, as cited by Zepeda et al., 2006; Takahashi et al., 1997). In microbial consortia, the competition between heterotrophs and autotrophs for ammonia and oxygen is another hypothesis commonly mentioned for explaining the nitrification inhibition by organic matter (Hanaki et al., 1990).

Some aromatic compounds are known to inhibit nitrification (Amor et al., 2005; Brandt et al., 2001; Texier & Gómez, 2002). Little attention has been paid to the inhibitory influence of benzene, toluene, and xylenes (BTX) on nitrifying microorganisms and further work is required for understanding how BTX compounds can affect the performance of nitrifying treatment systems. Inhibition of nitrification by toxic chemicals, such as BTX compounds, focuses mainly on the modes of action of inhibitors on the enzyme AMO by using axenic cultures of N. europaea (Keener & Arp, 1994; McCarty, 1999). Main results are consequently in relation to the ammonium-oxidizing process and very little information is available on the effects of BTX compounds on the nitrite-oxidizing process. Keener & Arp (1994) in their study on the inhibition of NH₄+ oxidation by N. europaea from various aromatic compounds reported that benzene concentrations of 14.0 and 23.4 mg/l inhibited the NO₂ production by 60% and 80%, respectively. Dyreborg & Arvin (1995) observed that the level of benzene concentration provoking 100% inhibition of the ammonium oxidation was 10.7 mg/l. In the studies of Zepeda et al. (2003, 2006), the effect of different initial concentrations of benzene, toluene, and m-xylene on a nitrifying consortium produced in steady-state nitrification was evaluated in batch reactors. The values for the ammonium consumption efficiency, nitrate yield and nitrification specific rates were determined. These values are needed for characterizing the physiological behavior of the nitrifying sludge in the presence of BTX compounds. Zepeda et al. (2006) observed that at 5 mg C/l of each aromatic compound, there was no significant effect on nitrification efficiency and the ammonium removal efficiency was of 95 \pm 7% after 16 h. Benzene and m-xylene at 10 mg C/l decreased ammonium consumption efficiency by 57% and 26%, respectively, whereas toluene did not affect the efficiency of the ammonium oxidation process. In all cases, the consumed NH₄+-N was totally oxidized to NO₃-N after 16 h. The nitrifying yield was close to 1.0 and nitrite concentration was negligible. This indicated that the process was mainly dissimilative and biomass formation was limited. These results suggested that wastewaters containing up to 5 mg C/l of benzene, toluene, or m-xylene would not affect the efficiency of ammonium conversion to nitrate in a treatment system. However, BTX (5-20 mg C/l) induced a significant decrease in the values for specific rates of NH₄+ consumption (76-99%) and NO₃production (45-98%), affecting mainly the ammonium-oxidizing pathway (Table 3). These results indicated that, in the presence of BTX compounds, the nitrification process was inhibited but the nitrifying metabolic pathway was only altered at the specific rate level as nitrate was still the main end product. At 10 mg C/l of BTX compounds, the inhibition order on nitrate production was: benzene > m-xylene > toluene while at 20 mg C/l, the sequence changed to m-xylene > toluene > benzene. The same authors also reported that at 5 mg C/l of BTX compounds, there was no toxic effect on the sludge whereas bacteria did not totally recover their nitrifying activity from 10 to 50 mg C/l. Results indicated that mechanisms involved in the inhibition of nitrification processes by BTX compounds depend on various factors, such as the initial concentration, the chemical structure, and the hydrophobic character of the pollutants. Zepeda et al. (2003, 2006) also observed that the inhibitory effects of BTX compounds seemed to be related to their persistence in the nitrifying cultures. At low concentrations, the chemical structure of the BTX compounds appeared to be the predominant factor whereas at higher concentrations, their hydrophobicity played an important role. The presence of different functional groups as well as the nature of the substituent can influence the metabolism and toxicity of aromatic compounds (O'Connor & Young, 1996). The absence of functional groups may confer to benzene higher stability and persistence to biotransformation while the presence of methyl groups may facilitate the mechanisms of biotransformation for toluene and m-xylene. Moreover, previous studies reported that many cyclic hydrocarbons are toxic and inhibitory to microorganisms because of their hydrophobic character and their devastating effects on biological membranes (Radniecki et al., 2011; Sikkema et al., 1995; Tsitko et al., 1999).

As it can be seen in Table 4, in nitrifying cultures, binary and ternary mixtures of benzene, toluene, and *m*-xylene provoked also a significant decrease in the values of specific rates for

 NH_4^+ consumption (from 72 to 90%) and NO_3^- production (from 39 to 79%) (Zepeda et al., 2007). The inhibitory effect of BTX compounds on the nitrifying process seemed to be higher when they were present in mixtures than individually. Results showed that benzene, toluene, and m-xylene individually or in mixtures significantly inhibited the nitrifying activity of the sludge by decreasing the nitrification specific rates. However, it was found that the nitrifying sludge can tolerate up to 5 mg C/l of BTX in single solutions or 2.5 mg C/l in mixed solutions, maintaining high the NH_4^+ -N oxidation efficiency and the nitrifying yield.

As observed by Zepeda et al. (2006, 2007) in the case of BTX compounds, in spite of the inhibitory effects of organic compounds on nitrification, it was demonstrated that in some cases and under controlled experimental conditions, nitrification processes could successfully proceed (Texier and Gómez, 2007). Moreover, microbial consortia under nitrifying conditions have been shown to be able to oxidize simultaneously ammonia and organic compounds, suggesting that nitrifying consortium coupled to a denitrification system may have promising applications for complete removal of nitrogen and organic compounds from wastewaters. This topic is detailed in the following section.

2.5.2 Simultaneous elimination of ammonium, organic matter and BTX removal

Previous studies have shown that the ammonia-oxidizing bacterium *N. europaea* was able to oxidize a broad range of hydrocarbons, including non-aromatic and aromatic compounds, and it is believed that the AMO is participating. The role of the AMO was demonstrated in experiments undertaken with selective inhibitors of the enzyme such as allylthiourea. Table 5 presents some examples of organic substances oxidized by *N. europaea* cultures. In the majority of these studies, kinetic data are missing for ammonium and nitrite oxidation

processes as for organic compounds, thus, more investigation is required to understand better the involved mechanisms.

Several investigations have shown that *N. europaea* oxidizes recalcitrant aromatic compounds, and it is also believed that these oxidations are mediated by the AMO (Chang et al., 2002; Hyman et al., 1985; Keener & Arp, 1994; Vannelli & Hooper, 1995). However, in these studies, there was an accumulation of more oxidized aromatic products in the culture medium. For example, in the case of benzene, ring cleavage did not occur and phenol was accumulated in cultures of *N. europaea*. In contrast, Zepeda et al. (2003, 2006) observed that when a nitrifying consortium was used, benzene, toluene, and *m*-xylene were converted to volatile fatty acids. These authors proposed that the aromatic compounds oxidation with ring fission could be the result of the coexistence and participation of both, lithoautotrophic nitrifying bacteria and heterotrophic microorganisms present in the consortium. It can be considered that the high diversity of microorganisms, enzymatic material and possible metabolic pathways which characterizes microbial consortia could contribute to obtain these results. However, further work is required in this direction to elucidate the underlying processes involved in the transformation of BTX by nitrifying consortia.

In their study, Zepeda et al. (2006) reported that the nitrifying sludge was able to completely consume benzene (6.5 mg C/l), toluene (5 mg C/l), and m-xylene (5 mg C/l) over 21 h. Specific rates of BTX consumption are presented in Table 6. These results indicate that for initial concentrations below 6.5 mg C/l, toluene and m-xylene disappeared faster from the cultures than benzene, which appeared to be most persistent. This is in accordance with the fact that benzene at low concentrations was the highest inhibitory compound on nitrification. Individually as in BTX mixtures, the nitrifying consortium presented the following sequence of biotransformation: m-xylene > toluene > benzene. However, in mixtures, significant differences in the values for specific rates of BTX compounds removal were found. The work of Zepeda et al. (2007) emphasizes the importance for considering the possible component interactions in the biotransformation of mixed BTX compounds in nitrification systems.

Up to a concentration of 10 mg C/l, benzene was first oxidized to phenol, which was later totally oxidized to acetate. At a concentration of 5 mg C/l, toluene was first oxidized to benzyl alcohol, which was later oxidized to butyrate while *m*-xylene was oxidized to acetate and butyrate (Zepeda et al., 2006). As it has been previously shown that the AMO oxidized benzene to phenol, then it is likely that benzyl alcohol be an intermediate of toluene oxidation by the AMO (Hyman et al., 1985; Keener and Arp, 1994; Zepeda et al., 2003). It is presumed that N. europaea may initiate oxidation of BTX to provide intermediates, such as phenol and benzyl alcohol, which could later be transformed to VFA by heterotrophic microorganisms from the nitrifying consortium. In nitrifying cultures added with benzene, toluene, and m-xylene compounds in individual (5 mg C/l) and mixed solutions (2.5 mg C/l for each one), Zepeda et al. (2007) observed that after 24 h, ammonium consumption efficiency and conversion of consumed ammonium into nitrate were close to 100%. These results confirmed that a nitrifying consortium produced in steady state was able to convert benzene, toluene, and m-xylene to VFA and simultaneously oxidize ammonium to nitrate through a dissimilative process. This type of nitrifying consortium coupled with a denitrification system may have promising applications for complete removal of both nitrogen and BTX compounds from wastewater streams into N₂ and CO₂.

In the last decades, several nitrifying consortia have been reported to oxidize simultaneously ammonium and various recalcitrant aromatic compounds, such as phenolic compounds (phenol, 2-chlorophenol, p-cresol, p-hydroxybenzaldehyde) (Amor et al., 2005; Martínez-Hernández et al., 2011; Silva et al., 2009, 2011; Vázquez et al., 2006; Yamaghisi et al., 2001) and BTX compounds (Zepeda et al., 2003, 2006, 2007). In some cases, nitrate and carbon dioxide were the major products from the process. As a consequence, nitrifying processes have been recently proposed as novel alternative technologies for the simultaneous removal of ammonium and aromatic pollutants from industrial wastewaters of chemical complexity such as effluents generated by the petrochemical industry (Beristain-Cardoso et al., 2011, Silva et al., 2011). Nitrification as the initial step in the removal of ammonia from wastewaters might be also used to oxidize simultaneously ammonia and aromatic compounds, allowing their mineralization or the production of intermediates that can be totally oxidized by denitrification (Beristain-Cardoso et al., 2009). However, additional studies in both batch and continuous bioreactors are needed to obtain more information about physiological, kinetic, ecological and engineering aspects in order to control the sludge metabolic capacity in nitrification processes.

3. Denitrification

Denitrification is a biological process that microorganisms use for obtaining energy from the reduction of nitrate to dinitrogen gas (Knowles, 1982; Mateju et al., 1992). Denitrification requires the concomitant oxidation of an electron donor in order to reduce nitrate to N_2 gas. Diverse compounds can be used for this purpose. Organic sources are used in organotrophic denitrification whereas inorganic compounds are used for lithotrophic denitrification. Different organic compounds have been used in organotrophic denitrification such as methanol, glycerol, benzoic acid, acetate, glucose, lactate (Akunna et al., 1993; Cuervo-López et al., 1999; Martínez et al., 2009). Recalcitrant compounds such as p-xylene, benzene, toluene and p-cresol have been successfully removed by organotrophic denitrification (Cervantes et al., 2009; Dou et al., 2008; Hänner et al., 1995; Martínez et al., 2007; Peña-Calva et al., 2004b). Therefore, denitrification seems a good option for treating wastewater and underground water contaminated with BTX as simultaneous removal of nitrogen and carbon compounds can be obtained. Nevertheless, it is essential to remark that for biological wastewater treatment, the denitrification process must be dissimilative and dissipative to prevent biomass generation.

The type of electron source will determine the performance of the denitrifying process in terms of change in Gibbs free energy ($\Delta G^{o'}$) and consumption rate (Cuervo-López, et al., 2009). Several respiratory process, including denitrification, with different electron sources and their respective $\Delta G^{o'}$ values are illustrated in Table 7. In all cases, the denitrification process is exergonic and appears to be thermodynamically favored when compared with anaerobic processes such as methanogenesis or sulfate reduction.

3.1 Microbiological aspects

Different taxonomic groups are involved in denitrification including Gram negative and positive bacteria. Their remarkable characteristic is their facultative respiration. Some of them are phototrophic, whereas many others can use organic sources or sulfur compounds. Some of them are illustrated in Table 8.

Denitrifiers able to consume BTX have been isolated from different places such as forest soils, sediments of aquifers, beaches, and contaminated soils with hydrocarbons. Toluene and xylene consumers as *Thauera aromatica* and *Azoarcus evansii* (Anders et al., 1995; Song et al., 1998, as cited in Peña-Calva, 2007), and BTX consumers as *Pseudomonas putida* and *Pseudomonas fluorescences* have been isolated from these sites (Shim et al., 2005). Axenic and enriched cultures of *Rhodococcus pyridinovorans* have been reported to be able to consume *m*-xylene. Enrichment cultures of *Betaproteobacteria* growing with *p*-xylene and nitrate have been reported (Rotaru et al., 2010 as cited in Sander et al., 2010), whereas the elimination of the three xylene isomers can be carried out by microbial consortia (Jung & Park, 2004). Some evidences on benzene consumption have been reported for *Dechloromonas* (Coates et al., 2001), likewise, there are evidences indicating that this strain is able to use BTX mixtures for microbial growth (Chakraborty et al., 2005).

3.2 Biochemistry aspects

The denitrification process could be described as a modular organization in which every biochemical reaction is catalyzed by specific reductase enzymes (Cuervo-López et al., 2009). Four enzymatic reactions take place in the cell as follows: (i) nitrate is reduced to nitrite by nitrate reductase (Nar); (ii) a subsequent reduction of nitrite to nitric oxide is carried out by nitrite reductase (Nir); (iii) afterwards, nitric oxide is reduced to nitrous oxide by the enzyme nitric oxide reductase (Nor); (iv) finally, nitrous oxide is reduced to N_2 by the enzyme nitrous oxide reductase (Nos) (Lalucat et al., 2006) (Table 9). These reactions take place when environmental conditions become anaerobic (Berks et al., 1995; Hochstein & Tomlinson, 1988). The enzymatic reactions, which are thermodynamically favored, are carried out in the cell membrane and periplasmic space. Small half saturation constant values (Km) have been reported for different nitrogen substrates for some denitrifying bacteria, indicating that denitrifying enzymes have a high affinity for their substrate. However, several factors have to be considered, as the presence of small quantities of molybdenum, cooper and hem to ensure the successful enzymatic activity, as they are known cofactors for denitrifying enzymes.

3.3 Environmental factors affecting denitrification

Low oxygen tension and the presence of nitrogen oxides are required as an inductor of denitrification (Cuervo-López et al., 2009). Denitrifying activity is inhibited in reversible manner under aerobic conditions. Oxygen concentrations ranging from 0.09 to 2.15 mg/l have resulted in a decrease of nitrate consumption and denitrifying rate or accumulation of intermediaries as nitrous oxide (Bonin et al., 1989; Oh & Silverstein, 1999; Wu & Knowles, 1994). Thus, in order to maintain high consumption efficiency of the reducing source and high denitrifying yield values ($Y_{\rm N2}$, conversion of nitrate to N_2) in denitrifying systems, oxygen concentrations should be maintained lower than 2 mg/l.

Carbon/nitrogen (C/N) ratio is an important factor which determines the denitrifying performance. This variable is related with the accumulation of denitrification intermediaries and could determine the dissimilative reduction of nitrate to ammonium (DNRA) (Cuervo-López, 2009). Several works focused on BTX removal have resulted in nitrite accumulation due to the low C/N ratio established (Burland & Edwards 1999; Dou et al. 2008; Evans et al., 1992). This behavior is in contrast with that reported by Peña-Calva et al. (2004a, 2004b) and Martínez et al. (2007, 2009), where BTX were converted to CO₂ whereas nitrate was reduced to N₂ at C/N ratios close to stoichiometric values. Thus, these results evidenced that complete elimination of both, carbon and nitrogen compounds will outcome with no accumulation of undesirable intermediaries if C/N ratios are close to stoichiometric values. According to Peña-Calva et al. (2004b), the type of electron source has also an important effect in the accumulation of nitrogen intermediaries, as NO₂ and N₂O were detected when

m-xylene was used whereas no intermediaries were observed when toluene was assayed. Another important parameter which affects denitrification, particularly its thermodynamics, is the pH value, as the rate of denitrifying enzymes could be affected. In this sense, batch studies with Paracoccus denitrificans indicate important differences in the rate of nitrite and nitrous oxide consumption and production (Thomsen et al., 1994). Another important effect of pH might be observed on the transport mechanisms of substrates as membrane properties could be affected. As a result, changes in consumption efficiency and consumption rate will be observed. Denitrification could be carried out in a temperature range between 5 and 35°C (Lalucat et al., 2006). However, temperature effects can be observed in rates and consumption efficiency of substrates and possibly in the products formation yield. Similarly to pH, effects of low and high temperatures are mainly related with the physicochemical changes in the cell membrane structures, either for lipids and proteins. It has been reported that toluene denitrification was performed with influents at 5°C in a continuous UASB reactor (Martínez et al., 2007). Therefore, for obtaining a constant and acceptable denitrifying rate it is recommendable to conduct biological wastewater treatment at C/N stoichiometric values, neutral pH and temperature values between 20 and 35°C.

Finally, kinetics considerations have to be taken into account for a successful denitrifying process (Cuervo-López et al., 2009). According to these authors, the metabolism of denitrifying cultures can be described by the following equation:

$$q_s = \frac{\mu}{Y_{x/S_{CX}}} + \frac{q_p}{Y_{p/S_{CP}}} \tag{4}$$

Where q_s is the specific consumption rate of substrate, a constant of first order which its value is dependent on the environmental culture conditions; μ is the specific growth rate; q_p is the specific product formation rate; $Y_{x/Scx}$ and $Y_{p/Scp}$ are substrate conversion or yield for biomass and products respect to the consumed substrate, respectively. The equation summarizes the metabolism of many cell cultures; where $\mu/Y_{x/Scx}$ expresses the biosynthetic process and $q_p/Y_{P/Scp}$ the respiratory process. In denitrification, it is desirable to obtain dissimilative processes where μ and $Y_{x/Scx}$ will be very small for obtaining negligible biomass production but high substrate conversions to molecular nitrogen and bicarbonate. This situation is highly recommended for practical purposes, as operational costs by sludge disposition could be minimized. In this regard, Peña-Calva et al. (2004a, 2004b), Hernández et al. (2008) and Martínez et al. (2007, 2009) have shown that denitrification process with BTX could be clearly dissimilative.

3.4 Nitrate and BTX removal

First evidences indicating toluene consumption by denitrification and its conversion to CO₂ are those obtained by Zeyer et al. (1986). Similar results have been reported by several authors (Alvarez & Vogel, 1995; Chakraborty et al., 2005; Elmén et al., 1997; Kobayashi et al., 2000). However, in these works nitrate consumption and N₂ production have not been mentioned, thus, the occurrence of denitrification process has not been verified. Evans et al. (1991, 1992) have reported toluene consumption and production of CO₂, biomass and intermediaries as benzilsuccinate with a concomitant accumulation of nitrite. Toluene

elimination close to 80% was achieved by Schocher et al. (1991). The authors determined that 50% of the aromatic compound was oxidized to CO₂ whereas they assumed that the other fraction was assimilated as biomass. High nitrate concentrations corresponding to low C/N ratio values (close to 0.2) have been used in most of these works, resulting in nitrite accumulation. The three isomers of xylene have been eliminated under denitrifying conditions, where m-xylene was firstly consumed followed by p-xylene and finally by oxylene (Haner et al., 1995; Kuhn et al., 1988). It has been reported a removal of m-xylene close to 55% but there is no mention about the fate of the aromatic compound or nitrate (Elmén et al., 1997; Evans et al., 1991a). In most of these works enrichment cultures have been extensively used as inocula. Peña-Calva et al. (2004b) evidenced that toluene and mxylene concentrations ranging from 15 to 100 mg of toluene-C/l and 15 to 70 mg of mxylene-C/l were used as electron sources for a denitrifying dissimilative respiratory process when sludge without previous acclimation to BTX was used as inoculum. However, the physiologic stability of the sludge was important. Likewise, these authors conducted their assays at C/N ratio close to stoichiometric values (C/N = 1). At these conditions, nitrate consumed was completely converted into N₂, while toluene and m-xylene were completely converted into HCO₃- within 4 to 7 days of culture. Under these conditions, the efficiency of the denitrification pathway was not influenced by toluene or *m*-xylene; and the denitrifying yield values were close to 1. However, the authors reported that benzene was recalcitrant. Benzene elimination by denitrification has been reported by using sediments (Major et al., 1988), enriched cultures (Burland & Edwards, 1999) and axenic cultures of Dechloromonas RCB (Coates et al., 2001; Kasai et al., 2006, as cited in Weelink et al., 2010). These authors have determined that benzene was oxidized to CO2 and assimilated into biomass. Dou et al. (2008) have assessed BTX concentrations ranging from 1.3 to 15 mg C/1 for each aromatic compound with an enriched mixed bacterial consortium. Similarly to other works, an excess of nitrate (C/N = 0.05) was established for achieving consumption of the aromatic compounds by denitrification. BTX and nitrate were consumed within a period of 20 and 40 days of culture, however, significant nitrite accumulation was observed concomitant to N2 production. Therefore, benzene is still considered as the most recalcitrant of the BTX under denitrifying conditions (Alvarez & Vogel, 1995; Cunningham et al., 2001; Da Silva & Alvarez, 2002; Peña-Calva et al., 2004b; Phelps & Young, 1999; Weelink et al., 2010).

BTX are usually present in contaminated aquifers as a mixture of them. There are some reports under denitrifying conditions where BTX interactions were evaluated (Alvarez & Vogel, 1995; Ma & Love, 2001). These studies showed that only toluene and xylene were consumed but no benzene. In spite of toluene and xylene were mineralized, reduction of nitrate to molecular nitrogen was not evidenced. The denitrification of different concentrations (50, 70 and 90 mg C/l) of a mixture of BTX using a stabilized sludge without previous contact to BTX was studied by Peña-Calva et al. (2004a). Firstly, toluene was completely consumed and oxidized to HCO₃- whereas nitrate was reduced to N₂. After this, partial *m*-xylene consumption (close to 55%) and partial reduction of nitrate to N₂ was observed as NO₂- and N₂O were accumulated. Benzene was not consumed in any of the cultures. Nevertheless, oxidation of an equal mixture of benzene and toluene coupled to nitrate reduction has been reported in a pure culture of *Dechloromonas* (Chakraborty et al., 2005) and enriched mixed bacteria culture (Dou et al., 2008). However, most studies with consortia have shown that benzene seems to be recalcitrant to biodegradation under

denitrifying conditions in both cases: in mixtures and as a sole electron donor. In this sense, it has been suggested that benzene is not consumed due to the lack of oxidizing enzymes (Gülensoy & Alvarez, 1999) and/or to the high structural stability of benzene (Cadwell & Sufita, 2000). Likewise, toxic effects on bacteria cell membranes have been proposed (Sikkema et al., 1994). Limitation in cell transport system for benzene incorporation into the cell has also been proposed (Peña-Calva, 2007). More investigation is required to understand better the involved mechanisms.

Mixtures of BTX are often present in different types of water along with other carbon sources which might influence the rate and extent of its elimination (Lovanh & Alvarez, 2004). Several studies about the elimination of mixtures of readily consumable carbon compounds with BTX have been made. Numerous substrate interactions among BTX and other carbon compounds have been mentioned that affect the elimination of the aromatic hydrocarbons. Under aerobic conditions, high BTX consumption was obtained with mixtures of these compounds (Deeb & Alvarez-Cohen, 1999; Prenafeta-Boldú et al., 2002). However, negative effects such as competitive inhibition with toluene in presence of phenol (Lovanh & Álvarez, 2004) or ethanol (Da Silva et al. 2005) and catabolic repression in presence of succinate or acetate (Lovanh & Álvarez, 2004) have been reported. The effect of alternate carbon sources on BTX consumption associated to microbial growth has been evaluated at denitrifying conditions. Su & Kafkewitz (1994) demonstrated that a nitratereducing strain of Pseudomonas maltophilia was capable of utilizing toluene and succinate simultaneously. Both substrates were consumed for microbial growth. Data about the effect of organic compounds on oxidation and consumption rate of BTX are seldom found in the literature. In this regard, Gusmao et al. (2006) evaluated toluene, benzene, ethylbenzene and xylenes consumption separately (between 14 and 33 mg/l of each BTEX) or in mixtures (5 mg/l of each hydrocarbon) in the presence of ethanol (566 mg/l) resulting in high toluene removal efficiencies. However, no information about the fate of ethanol or BTEX consumed was made. Evidences of microbial consortia capable of accomplish denitrification with different ratios of acetate-C/toluene-C concentrations at C/N ratio of 1.4 have been reported by Martínez et al. (2007). These authors achieved elimination efficiencies of toluene, acetate and nitrate close to 100%, as well as yields formation of HCO₃- and N₂ close to 1, indicating complete mineralization of both organic compounds. Likewise, denitrifying process was clearly dissimilative, as no biomass formation was detected.

All these results evidenced the feasibility of denitrification for BTX removal. Nevertheless, in spite of N_2 production was achieved in some of the works; significant nitrite accumulation was also obtained due to the high nitrate concentrations used in the assays. This problem could be overtaken by establishing C/N ratios close to stoichiometric values considering that it was not required an excess of nitrate in order to achieve effective BTX consumption. Moreover, the control and definition of C/N ratio seemed to be an option for negligible biomass production and obtaining dissimilative process during ground and wastewater treatment. Likewise, the use of sludge with no previously contact to BTX but physiologically stable, that is, in denitrifying steady state, could be an economical and less time-costly option when compared to the use of enrichment cultures. This type of denitrifying consortium may have promising applications for complete removal of both nitrogen and BTX compounds from wastewater streams into N_2 and CO_2 .

3.5 Kinetic data for BTX consumption

Some kinetic data for BTX consumption obtained in batch denitrifying cultures are illustrated in Table 10, whereas data obtained for mixtures of BTX are mentioned in Table 11. It is difficult to make comparisons among these data considering that operational and environmental conditions, as well as biomass concentration used are different. However, it is possible to see that specific consumption rate values are generally low. Elmen et al. (1997) reported in axenic cultures of Azoarcus tolulyticus that specific toluene consumption rate decreased in 25% at toluene concentrations of 102 mg/l, whereas Peña-Calva et al. (2004b) using a denitrifying sludge without BTX acclimation determined a decrease of 21% in specific toluene consumption rate (q_T) at 100 mg toluene-C/l. According to Peña-Calva et al. (2004b), the maximum value of specific m-xylene consumption rate (q_X) was reached at 70 mg mxylene-C/l, whereas a significant inhibition of the denitrifying pathway was observed at higher m-xylene concentrations, as they observed accumulation of NO₂- and N₂O. It is important to remark that at the same experimental conditions, the q_X reported by these authors was 6 times lower than toluene consumption rate. Similar results have been obtained by Dou et al. (2008) as they reported that q_T values were higher than q_X values. Likewise, they observed an inhibitory effect of xylenes on biodegradation rate of BTX. These results suggested that wastewaters containing less than 100 mg/l of toluene or m-xylene would not affect the removal rate in a treatment system. Nevertheless, generalizations about this situation must be avoided as previous physiological state of sludge, biomass concentration and the rest of culture conditions might affect kinetic data and performance of the respiratory process.

Several assays with mixtures of BTX have indicated substrate interactions among these compounds. Differences in consumption rate values have been observed when mixtures of BTX are assayed (Table 11) and compared with the values obtained in assays with the single

BTX compound (Table 10). In this sense, enhancement in xylene and toluene consumption rate between two to three times was determined in mixtures of toluene, benzene and xylene (Peña-Calva et al., 2004b), suggesting a positive interaction in hydrocarbons consumption when they are in mixture (Table 11). In contrast Dou et al. (2008) reported a diminishing in BTX consumption rate when mixtures of BTX concentrations higher than 5 mg/l were assayed and compared with those obtained in single BTX tests (Table 10). On the other hand, reports on mixtures of easy consumable substrate such as acetate and toluene conducted with microbial consortia with no previous contact to BTX, have indicated that at the acetate/toluene ratio of 65/20 the specific consumption rate of toluene value was twice compared to that obtained at 20 mg toluene-C/l alone (Martínez et al., 2009) (Table 11). Therefore, whereas the acetate concentration is clearly higher than toluene the consumption rate for toluene was increased. Authors have suggested that the specific consumption rate of toluene was biochemically enhanced by the presence of acetate. Noteworthy, at these conditions the denitrifying process was clearly dissimilative, as no biomass formation was detected. All these results indicate that substrate interaction among BTX and organic compounds mixtures are complicated as beneficial and deleterious effects on consumption rate values have been observed. More investigation is required on this topic. The wastewater treatment should be focused on obtaining dissimilative process with high consumption rates values. The use of some BTX mixtures or addition of easy consumable substrates might be helpful.

3.6 Examples of simultaneous elimination of BTX and nitrate in reactors

Different configurations of reactors have been proposed for conducting biological BTX remediation (Farhadian et al., 2008). Some studies on BTX removal by denitrifying bioreactors have been carried out in recent years using different configurations such as horizontal anaerobic immobilized bioreactors (HAIB) (Gusmao et al., 2006, 2007), up flow anaerobic sludge blanket (UASB) reactors (Martínez et al., 2007, 2009) and sequencing batch reactors (SBR) (Hernández et al., 2008).

A horizontal-flow anaerobic immobilized biomass reactor (HAIB) inoculated with a denitrifying consortium was used for treating both a mixture solution of approximately 5.0 mg/l of each BTEX and the hydrocarbons separately dissolved in a solution containing ethanol (Gusmao et al., 2006). Organic matter removal efficiencies were of 95% with benzene and toluene amendments and about 76% with ethylbenzene, m-xylene and the BTEX-mix amendments. Ethanol was removed with an average efficiency of 86% whereas a concomitant nitrate removal of 97% was determined. Another HAIB reactor inoculated with a denitrifying pure culture resulted in nitrate and BTEX removal close to 97% (Gusmao et al., 2007). These systems showed to be an alternative for treating wastewater contaminated with nitrate, BTX and ethanol, however, no data about N₂ formation and BTEX lost due to volatilization or adsorption in the polyurethane used as packing material in the reactors was mentioned. Martínez et al. (2007), reported a successfull denitrification of different toluene-C loading rates (25, 50, 75, 100 and 125) mixed with acetate (accounting for a total carbon loading rate of 250 mg C/ld) in a continuously fed UASB reactor inoculated with denitrifying sludge physiologically stabilized. At these operational conditions, the C/N ratio was adjusted to 1.4. Authors indicated that even at 125 mg toluene-C/ld the biological process was not affected as carbon consumption efficiency values were close to 100%, whereas Y_{HCO3} and Y_{N2} values were higher than 0.71 and 0.88, respectively. This work evidenced that acetate and toluene can be effectively consumed by denitrification at C/N ratios close to stoichiometric values in continuous culture. These results suggest that the simple UASB denitrifying reactor system have promising applications for complete conversion of nitrate, toluene and acetate into N2 and CO2 with a minimal sludge production. Likewise, Martínez et al. (2009) reported in a continuous UASB reactor that no sludge acclimation was require for removing toluene from synthetic wastewater. They evidenced that the addition of acetate was useful for improving the specific removal rate of toluene. In order to discriminate whether the acetate effect was on the microbial community or on their metabolic denitrifying activity, these authors conducted molecular biology and ecological studies. Results showed no close effect of acetate on the microbial community composition suggesting that acetate could act as a biochemical enhancer. Thus, practical applications could be derived as no enrichment or previously adapted inocula have to be used in order to achieve successfull BTX elimination by denitrifying respiratory process. Finally, using a sequencing batch reactor (SBR), Hernández et al. (2008) determined that at 70 mg toluene-C/l, toluene and nitrate consumption efficiencies were 84 and 100%, respectively whereas Y_{N2} , Y_{HCO3} values were close to 1, thus, the process was clearly dissimilative. Authors observed that specific toluene (q_T) and nitrate (q_N) consumption rate values were increased in twofold after 17 cycles of operation. They also evaluated the settleabilities properties of the denitrifying sludge by means of sludge volume index (SVI). Under these operational conditions, toluene (r_I) and nitrate (r_N) volumetric consumption rates were 46 mg toluene L-1d-1 and 50 mg nitrate L-1d-1, respectively, whereas the SVI values remained close to 40 ml/g. Considering that operational troubles due to bad sludge settleability properties are often observed at SVI values higher than 200 ml/g, the results obtained by these authors suggest that SBR could be useful for effectively treating wastewaters contaminated with toluene. However, additional studies in bioreactors are needed to obtain more information about physiological, kinetic, ecological and engineering aspects in order to control the sludge metabolic capacity in denitrification processes for treating BTX removal.

4. Conclusion

As described in this chapter, the progress made over the last decades in the understanding of the metabolic capabilities of nitrifying and denitrifying microorganisms for the biotransformation of carbon and nitrogen compounds has allowed the simultaneous elimination of BTX compounds, ammonium, and nitrate from wastewaters by nitrification and denitrification processes. The coupling of nitrifying and denitrifying processes could constitute a technological alternative for the biological treatment of petrochemical effluents. However, more investigation is required on various aspects such as physiology, engineering, and ecology information among others, to control better nitrifying and denitrifying bioreactors for the simultaneous consumption of BTX and nitrogen compounds from industrial effluents of chemical complexity.

Attenuation of Guided Wave Propagation by the Insulation Pipe

1. Introduction

Pipeline systems are widely used in gas, refinery, chemical and petro-chemical industries, which usually carry high pressure, high temperature or even highly corrosive fluids. Cracks and corrosion are often found at the outer or inner surface of pipeline and can lead to a serious thinning of wall thickness. Leaks or sudden failures of pipes can cause injuries, fatalities and environmental damage. Ultrasonic nondestructive techniques are available for the detection of wall loss associated with defects in the pipe. Unfortunately, a high proportion in pipelines of these industrial are insulated, so that even external corrosion cannot readily be detected by the conventional ultrasonic testing (single position measurement) without the removal of the insulation, which in most case is time-consuming and cost expensive. Especially in typically industrial plants, there are hundreds of kilometers of pipelines can be in operation. Making inspection of full pipelines is virtually impossible in industrial plants. There is therefore a quick reliable method for the detection of corrosion under insulation (CUI). This technique, called guided wave, employs a pulseecho system applied at a single location of a pipe where only a small section of insulation need to be removed, using waves propagation along the pipe wall. The changes in the response signal indicate the presence of an impedance change in the pipe. The shape and axial location of defects and features in the pipe are also determined by reflected signals and their arrival times. Propagation distance of many tens of meters can readily be obtained in steel pipes [1-6]. Since these guided waves are cylindrical Lamb waves along the pipe, no lateral spreading can occur and the propagation is essentially one-dimensional. In a uniform pipe, their amplitude with propagation distance is therefore only reduced by the material attenuation of the steel [7].

However, many pipes of interest are necessary wrapped with the coated materials for manufacturing process in refinery, chemical and petro-chemical plants. When the pipe is coated, some energy from the guided wave in the pipe wall can leak into the insulation

material and the wave attenuates as it goes along the pipe, thus reducing the wave propagation distance. The rate of energy leakage depends on the wave propagating mode in the pipe, on the acoustic impedance and attenuation properties of the insulation material [8]. The insulation material like a mineral wool has very low acoustic impedance and is not strongly adhered to the pipe. So it has virtually no effect on either the torsional or longitudinal wave. However, if the pipe is coated by a heavy viscous substance such as bitumen, epoxy, then both shear and longitudinal modes can leak from the pipe. The rate of leakage is then controlled by the properties and thickness of the coating, the displacement of the pipe surface in all direction (radial, circumferential and axial) and the frequency. This paper describes an investigation of the attenuation of a guided wave propagating on the pipe due to various coated materials such as mineral wool, polyethylene, and bitumen which are typically used to insulate the pipeline in industrial plants. The effect of reflected signals and the traveling distance of guided waves are demonstrated both on analytical predictions and experimental measurements for a variety of the coated materials on the pipe.

There have been few studied on this subject. However, Lowe and Cawly [9] considered the plate of adhesive and diffusion bonded joints to study the leakage of energy by both longitudinal and shear wave which leads to very high attenuation rates, especially when the acoustic impedance of the materials mismatch highly between another. This case is similar to the case of a pipe embedded in a solid. Wave propagation studies in structural composites are of relatively similar [10,11]. Since the composite laminates used in aircraft and aerospace structures are usually thin plate. They have been developed in an effort to gain model-based understanding of the nature of the guided waves that can be transmitted in the composite thin plates. Jones and Laperre [12,13] also considered the propagation of Lamb waves in bi-layered elastic plates, but they did not explore the effects of internal losses. More recently, the internal losses in the coating are modeled according to the theory of linear viscoelasticity by Simonetti [14]. He found that at low frequency the guided wave attenuation is only slightly affected by the longitudinal bulk attenuation, while the contribution of the shear bulk attenuation is substantial. However, while internal losses in metals are negligible at the low frequency used, the presence of attenuate media in combination with the propagation wave can dramatically attenuate the energy of guided wave. Since a significant proportion of industrial structures are coated or embedded in other material, the assessment of the attenuation characteristics of the propagating wave modes becomes a major issue. The attenuation of the torsional guided wave in a Coal-tar-enamel-Coated pipe was measured by Kwun [15]. He used torsional guided wave to measure the attenuation of buried pipe which is coated the Coat-tar-enamel material. However, no information is currently available on the effect of the coated material on the pipe when a guided wave is employed for pipeline inspection. The aim of this paper is to evaluate the attenuation of the industrial designation coated material on the pipe when the guided wave is traveling in the pipe.

2. Materials




Fig. 1. The wave structure of T(0,1) mode in a 6 inch pipe at 28 kHz. This profile shows the relative displacements from inside wall 76 mm to the outside wall 83.2 mm. The radial displacement u_r and axial displacement u_z are zero.

Since the pipe is coated with a viscous material and the energy can be carried away from the pipe by both shear and compressional waves, there is a need to analyze the wave structure

under energy attenuation. The wave structure describes the displacement pattern of the propagation mode for different frequencies across the thickness of the pipe. However, the wave structure of the torsional T(0,1) mode is not frequency dependent due to its completely non-dispersive characteristics at all frequencies. The wave structure of T(0,1) mode in a 6 inch steel pipe is shown in Fig.1. It shows the profile of the tangential displacement through the thickness of the pipe wall. The axial and radial displacements are zero in this mode. It can be seen that the tangential displacement are approximately constant through the wall thickness. It is also indicated that defects can be detectable anywhere in the cross section of the pipe as illustrated at 28 kHz in Fig.1, since the T(0,1) mode is a constant with frequency. An example of the wave structure for various coated material at frequency 28 kHz are also shown in Fig.2. These plots represent the amplitudes of the circumferential displacement from the centre line of pipe of the outer half space, i.e., through the inner of pipe, then through the pipe wall, and finally through the coated material layer. For the T(0,1) mode, the circumferential displacement through the coated material layer is dominant, since the inner of pipe is empty [16]. When the pipe is coated with the strong adhesive material, such as bitumen (Fig.2a), and with the weak adhesive material, such as polyethylene (Fig.2b), the energy of guided wave will leak into the coated material from the pipe wall. The rate of leakage is controlled by the strength of adhesion on the pipe and the frequency of propagation mode. If the pipe is coated with the insulation material, such as mineral wool (Fig.2c), it is not adhered to the pipe, and then the amplitude of circumferential displacement decreases in the pipe with distance due to the material properties of pipe. This T(0,1) mode and 6 inch steel pipe are also used in the experimental measurements for the results comparison.




Fig. 2. The wave structures of various coating materials at frequency 28 kHz; (a) for bitumen coating, the amplitude of circumferential displacement is vary from the inside wall (position 76 mm) to outside wall (position 83.2 mm) then through the coating material. The relative displacement changes significantly high in the viscous layer; (b) for polyethylene coating, the variation of the relative displacement is slightly high in the viscous layer. (c) for mineral wool coating, its relative displacement is near the same as in the viscous layer.

The coated material used on the pipe is usually a viscoelastic layer adhered on the pipe. The internal losses in the coated material are modeled according to the theory of linear viscoelasticity, which is also the model implemented in the software DISPERSE [17] used for the wave structure analysis. The shear velocity and shear attenuation of bitumen are obtained from the result of Simonetti measurement [16] for the software used to predict the attenuation of guided wave. The material properties of the other two coated materials are found from the data bank in the DISPERSE software. The theory of linear viscoelasticity for isotropic and homogenous media is modeled in the frequency domain, which leads to linear equation of motion [18]. Thus

$$(\tilde{\lambda} + \tilde{\mu})\nabla(\nabla \bullet \vec{u}) + \tilde{\mu}\nabla^2 \vec{u} + \rho\omega^2 \vec{u} = 0 \tag{1}$$

Where \vec{u} is the Fourier transformed displacement vector, ρ is the density of material, ∇ is the three dimensional differential operator and ω is the angular frequency. The complex frequency dependent functions $\tilde{\lambda}$ and $\tilde{\mu}$ are related to the relaxation functions of the material $\lambda(t)$ and $\mu(t)$.

$$\tilde{\lambda} = \lambda_0 + i\omega \int_0^\infty \lambda(t)e^{i\omega t}dt \tag{2}$$

$$\tilde{\mu} = \mu_0 + i\omega \int_0^\infty \mu(t)e^{i\omega t}dt \tag{3}$$

Where λ_0 and μ_0 are the asymptotic values of the relaxation curves.

Simonetti [14] studied the relationship among the guided wave attenuation, the strain energy in the viscoelastic layer, and the acoustic properties of the coated layer. For the case of torsional mode, it has already been shown [19] that by considering a volume, V, of one cycle in the circumferential direction (2π r), and with height equal to the thickness of the coated layer, the guided wave attenuation, α , can be related to the average dissipated power, P_d , in the volume and the average in-plane power flow, P_d , [14]

$$\alpha = \frac{dP_d / dz}{2 < P > } \tag{4}$$

Where z is the axial direction of pipe.

Generally speaking, at the considered portion of a viscoelastic medium, the average dissipated power per unit volume can be related to the peak strain energy per unit volume [20]. As a result, the total attenuation in volume, V, for the guided wave can be expressed as [14]

$$\alpha = \frac{1}{2}\omega \frac{\tilde{u}_i}{\tilde{u}_r} \frac{dE / dz}{\langle P \rangle} \tag{5}$$

Where the subscript i refers to the imaginary part of the quantity, and r refers to the real part of the quantity. E is the peak strain energy of the portion of the viscoelastic layer contained in V. There are two different material attenuation regimes can be defined in

Equation (5). When the material attenuation is low which is accompanied by small imaginary parts of the Lame constant, the viscoelastic layer embraces both the non-propagating and propagating branches of the corresponding elastic layer. It will disperse in the phase velocity and guided wave attenuation spectra. For the material attenuation is high which is representative of steel pipe coated with bitumen, the energy of guided wave is employed into two parts. The first one travels primarily in the elastic layer and the second one is trapped in the viscoelastic layer. While the energy of the second family have little practical interest, as they are highly attenuated with distance, the energy of the first family can be employed in suitable frequency ranges.

3. Experimental setup




Fig. 3. Profile of the test pipe and the measuring system.





Fig. 4. The reflected signals of the test pipe at frequency regime 1.0 (unwrapped).

All the experiments have been performed on a 6-inch schedule 40 steel pipe, which is usually used in refinery and petro-chemical factories, to measure the reflected signal of the torsional T(0,1) mode. The pipe has three flanges, two bends, one branch, one welded support, one simple support, one patch, and ten welds of features on it. Fig.3 shows the positions of various features on the experimental pipe. The flange is assumed to be a 100% reflector, since it breaks all of the energy in the guided waves and this signal is the level of the outgoing guided wave. At a bend the geometry of the pipe changes and the pipe is no longer symmetric about the plane normal to its axis. The major characteristics of the bends are the reflected signal from the two closely spaced welds, but there will some mode conversion caused by the change in geometry of the pipeline at the bend. The branch has a side outlet hole at right angles to the axial run of the pipeline. This hole, which changes in geometry, produces direct and mode converted reflected signals. The response from this branch is similar to a bend with two closely spaced weld reflected signals. The welded support is a bracket welded to the pipe over a significant axial length. The response from this welded support is complicated due to mode conversion. The amplitude of reflected signal from welded support depends on the length of the support. The clamped support is a U type of clamp. The reflection from clamped support depends on the tightness of clamp and the frequency of excitations. The patch is similar to a defect that extends in the axial direction order more than 1/4 of a wavelength. It generates reflections from the front and back of the patch. The reflected signals are the combination of the front and back of the reflections. In general, the weld is a symmetric geometry of pipe. The weld caps cause a geometric change in the pipe wall section, which also reflects the guided wave. The amplitude of the reflected signal is related to the percentage increase in the wall crosssection at the weld. The reflected signals from various features on the experiment at frequency regime 1.0 are shown in Fig.4. The frequency regime is introduced instead of frequency in the system since the behavior of the guided waves propagation in the pipe varies with pipe dimensions. It is defined as a number which normalizes the wavelength to pipe diameter. In Fig.4, the horizontal axis is the distance from the position of the transducer mounted on the test pipe. The vertical scale is the reflected amplitude in millivolts. The gray area in Fig.4 is the near field of transducer. The amplitude of the reflected signal in this near field cannot be measured for calculation. The green area in Fig.4 is the dead zone of the measuring distance. This dead zone is near the transducer that cannot be inspected. The -W1 and +W1 sign shown in Fig.4, represent the location of the welds where the distance are

2.5-m and 3.5-m from the transducer, respectively. The amplitude and shape of the reflected signals of the weld do not change with frequency. That is why the amplitude of the reflected signal of the weld is measured for comparison standard in this paper. The differences in the amplitudes of the individual welds, -W1 and +W1 sign, indicate the variation in size of the weld caps. The -N1 and +N1 signatures in Fig.4 are the location of artificial defect which are 3.6-m and 4.9-m from the transducer, respectively. Most defects are non-symmetric. The position of these reflected signals are generally suspected as indicating anomalies, with the shape of defect signature distorted from peak shape. The amplitude of the reflected signal from defect is dependent on the depth and circumferential extent of the defect. The position of -P1 in Fig.4 is the patch feature which locates at 4.7-m from the transducer. The -F1 sign shown in Fig.4 represents the location of the flange where the distance is 6.0-m from the transducer. The shape of the flange signature depends on the duration of the excitation signal and the geometry of the flange. No energy is propagated across flanges, and testing is only possible between flange breaks. The +E1 signature in Fig.4 is the location of elbow of pipe which is 6.35-m from the transducer. The dashed lines, which indicate exponential decay, represent the distance amplitude correction curves from the features of the flange, weld and noise, respectively.

A commercial instrument is used to generate a 10 cycles Hanning-winded tone burst signal to excite the transducers. The frequency regime of guided wave is excited from -1.2 increased equally 0.2 of frequency band to 3.4 to propagate the torsional T(0,1) mode on the pipe for the measurement, respectively. When the transducer ring generates the T(0,1) mode




Fig. 5. The reflected signals of the experimental measurement; (a) bitumen, (b) polyethylene, and (c) mineral wool.

on the pipe, the guided wave can be propagated to both ends of pipe. The coated material is embedded on the pipe between the position of transducer ring mounted and flange for the experiments. Various coated materials which are used commonly in industrial plants, such as mineral wool (1-m length, 5-cm thickness, no adhesive material). Polyethylene (1-m length, 1-cm thickness, adhesive strength: 1.56 kg/25 mm), and bitumen (1-m length, 2-cm thickness, adhesive strength: 2 kg/25 mm), are used in experiments to measure the reflected signal for attenuation investigation (see Fig.5). In Fig.5, the amplitude of the reflected signal could be measured at the same position for the attenuation evaluation. At the flange feature -F1 for bitumen coating shown in Fig.5(a), the amplitude of reflection is 8.51 mV at incident frequency regime 1.0, the value is 13.6 mV for polyethylene coating shown in Fig.5(b), and the measured amplitude is 22.6 mV for mineral wood coating shown in Fig.5(c). Comparison of the amplitude value of the flange feature among Fig.5(a), 5(b) and 5(c) shows that the attenuation is significantly high for bitumen coating. In order to evaluate the effect of the coated materials for guided wave T(0,1) mode, the attenuation of reflected signal is measured by comparing the amplitude of the guided wave when the waveguide is in air to the amplitude as the waveguide is embedded by coated material over a given length, L, on the pipe. As mentioned before, measuring the reflected amplitude of the weld feature before and after embedding is measured as the reference reflector. The guided wave attenuation α_e over the embedded length L in the experiment is then calculated as

$$\alpha_e = \frac{1}{2L} 20 \log \left[\frac{AF_a / Aw_a}{AF_b / Aw_b} \right] \qquad [dB/m]$$

Here L is 1-m since the embedded length of coated material is united in the experiments. At a given frequency regime, the amplitude of the Fourier transforms of the flange reflection and the weld reflection before embedding are denoted by AF_b and Aw_b , respectively, and after embedding by AF_a and Aw_a , respectively. This attenuation α_e corresponds to Equation (5) of α for the excited frequency propagating in the pipe.

4. Results and discussion

4.1 Predictions




Fig. 6. Prediction of attenuation of guided wave for (a) polyethylene and (b) bitumen. The attenuation of guided wave of mineral wool cannot be shown in the DISPERSE software since the attenuation of guided wave is zero.

All the predictions presented in this paper were produced using the DISPERSE software. The software is based on the global matrix method for the analysis of multi-layered structures that over-comes the problem of instability at high frequency-thickness products commonly associated with the Thomson-Haskell transfer function technique [21]. When predicting the attenuation due to the material damping of the coated material, the DISPERSE software is used in this research. The acoustic properties of various coated materials are shown in Table 1. The attenuation of the prediction discussed for various coated materials are shown in Fig.6. Notice that the attenuation of guided wave for mineral wool is nearly zero at the frequency range of 10 to 40 kHz (there is no attenuation diagram can be shown in DISPERSE software), since the coated material of mineral wool has no adhesives strength on the pipe. It means that there is zero traction at the surface of the pipe, and the energy of guided wave has no leakage to the coated material. It is obviously that the attenuation of guided wave for polyethylene (Fig.6a) and bitumen (Fig.6b) of coated material have significantly decayed with frequency. This attenuation results due to the energy dissipation of guided wave by the viscous of viscoelastic material. The behavior of the viscoelastic material combines the energy-storing feature of elastic media, the dissipating feature of viscous layer, and frequency dependent in elastic moduli [22]. The traveling distance of guided wave T(0,1) mode in the pipe will be reduced by the higher attenuation. In Fig.6, the circumferential displacement through the pipe wall is dominant by the T(0,1) mode. The amplitude of displacement is reduced apparently for the cases of

bitumen and polyethylene coated, while the material damping of them is heavier than mineral wool is. Another interesting result in Fig.6 is the higher frequency, the heavier attenuation of the guided wave. The reason is the high frequency has small wavelength, and can be easily dissipated the energy of guided wave into the viscous layer.

4.2 Experimental results




Fig. 7. The results of the experiment for various insulation materials.

The experimental data is obtained using the experimental set-up shown in Fig.3. The amplitude of the reflected signals for the weld reflector and flange feature is measured to calculate the attenuation of guided wave before and after embedding the coated materials. Since the viscoelastic materials are very sensitive to temperature changes [22]. The measurements use the same set-up for various coated materials measurements and control the same temperature 28°C during the experiments in this paper. The results of measurements are shown in Table 2 for various insulation materials at selective frequency regime (0.2 to 3.0). The attenuation of guided wave is also shown in Table 2 which is calculated using Equation (6). It is found, as expected, that the attenuation of guided wave in the mineral wool coated material is near zero. This is because of the adhesive strength for mineral wool coated has no viscosity. Therefore, neither the amplitude of reflected signal nor the attenuation could be changed before and after embedding the coated material in the experimental measurements. Other interesting results are the cases of bitumen and polyethylene coated, since they have large adhesive strength. The amplitude value of the attenuation for guided wave is from 4.046 to 4.668 dB/m for bitumen coated, and the value range is from 2.235 to 2.453 dB/m for polyethylene coated at selective frequency regime (0.2 to 3.0). It became evident that the attenuation of guided wave is due to the leakage of energy into the viscous layer. On the other hand, the adhesive strength of bitumen coating and polyethylene coating is large enough that the T(0,1) wave leaks the energy into the viscous layer. The results of the experiment for various coated materials at selective frequency range are shown in Fig.7. Comparison of the results in Fig.7 with the results of predictions in Fig.6 shows that the attenuation of guided wave is significantly high for bitumen coating, slightly high for polyethylene coating, and there is almost no effect for mineral wool coating. The phenomenon of the predicted curves is clearly in agreement with the experiments for all case of various insulation materials on the pipe. Hence the agreement between the predictions and experiments for the attenuation of guided wave is excellent. In addition, the behavior of the higher attenuation of guided wave in the higher frequency has been observed. The reason for this variation with frequency is the small wavelength at high frequency cannot carry incident energy largely and easy to leak the energy into surrounding media.

For the traveling distance evaluation, the average attenuation of guided wave is used to calculate the propagating range for pipe inspection at selective frequency regime (0.2 to 3.0). The signal to noise ratio used in this experiment is 32 dB for the measuring instrument. It means that the noise or baseline level is set to 32 dB below the flange level, the 100% reflector, of the reflected signal. The traveling distance on pipe for the bitumen coating is about 7.53-m since the decay rate of guided wave is 4.250 dB/ m, take frequency regime 1.0 for example. For the polyethylene coating, the traveling distance is near 14.03-m for the decay rate of guided wave at frequency regime 1.0 is 2.281 dB/m. There is no effect on the traveling distance for the mineral wool coating. Hence, the amplitude of guided wave decreases exponentially with distance for T(0,1) mode propagating in the pipe. The value of

attenuation of guided wave for each frequency regime shown in Table 2 can also be calculated. Take bitumen coating at incident frequency regime 2.2 for example, the attenuation is $4.523~\mathrm{dB/m}$ listed in Table 2. Therefore, the traveling distance of guided wave is 7.07-m for incident frequency regime 2.2 propagating on the pipe of the bitumen coating when the T(0,1) mode is excited by 10 cycles Hanning-windowed tone burst signal.

5. Conclusions

Good agreement has obtained between the experiments and predictions for the attenuation of guided wave study on the insulation pipe. The effect of the adhesive strength on the pipe is investigated for various coated materials. The results show that the bitumen coating on the pipe has 4.046 to 4.668 dB/m attenuation of guided wave, the polyethylene coating has 2.235 to 2.453 dB/m, since the adhesive strength of the bitumen coating is larger than the polyethylene coating is. There is no effect on the torsional T(0,1) mode for mineral wool coating because it has no adhesive strength applied on the pipe. In addition, the traveling distance of the torsional T(0,1) mode on the pipe is evaluated in this paper. It can travel about 7.53-m for bitumen coating, and the traveling distance is near 14-m for polyethylene coating, while the guided wave is excited to propagate the pipe for pipeline inspection. For mineral wool coating, the propagating range depends only on distance due to the natural decay of material properties of the pipe. The results of this study are of interest refinery, chemical and petro-chemical industrial plants for pipeline inspection, since a high proportion of these industrials pipelines are wrapped with the coated material for the necessary of their work.

Radioisotope Technology as Applied to Petrochemical Industry

1. Introduction

Radioisotopes were first applied for industrial problem solving around the middle of the last century. Since then, their use has increased steadily. Today various applications of radioisotopes, as sealed sources and as radiotracers, are well established throughout the world for troubleshooting and optimization of industrial process plants. Petrochemical and chemical process industries are the main users and beneficiaries of the radioisotope technology.

In this chapter we present the three major techniques used in petrochemicals. Gammascanning is a very effective non-invasive technique used for on-line troubleshooting of distillation columns and pipes. Neutron backscattering is applied for level and interface detection in storage tanks and other reservoirs. Radiotracers are employed to establish the residence time distribution which is an important mean of analysis of the petrochemical units.

2. Gamma-scanning

Gamma Scanning is the best technique to carry out an internal inspection of distillation columns, vessels and pipes without interrupting production. The gamma-ray scanning technique is widely used for evaluating the operating characteristics of distillation columns considered as the most critical components in petrochemical plants. Gamma-ray scanning provides essential data to optimize the performance of the columns and to identify maintenance requirements.

Gamma Scanning is a very effective, well established, troubleshooting technique. This powerful diagnostic tool, which has been used for decades, has become popular as it allows inspection of the distillation column components without interrupting operation. In comparison to other non-destructive control techniques used in practice, gamma-ray scanning provides, in real time, the clearest vision of the production conditions inside a process reservoir. It is also cost-effective, particularly when compared to lost production (Hills, 2001).

Gamma scanning can help diagnose and solve approximately 70% of column problems encountered at refinery and petrochemical sites. For other cases, it allows resources to be

focused on finding the true source of the problem by eliminating inadequate possible scenarios. It provides essential data to optimize the performance, track any deteriorating effects and identify the maintenance requirements of a distillation column so that it significantly reduces repair downtime (Alami, 2009).

2.1 Main problems met on distillation columns

The hydraulic capacity of trayed distillation columns is always limited by either a high liquid entrainment, or by an overload of downcomers. The technology of high capacity trays deals with these two fundamental limits by reducing the entrainment or by releasing the loads of downcomers. Both are generally connected (Hills, 2001).

2.1.1 Liquid entrainment

The entrainment can be defined as the physical rise of droplets, provoked by the ascending flow of vapour. The vapour tends to hoist droplets upward, while the gravity tends to pull them downward. If the vapour speed is relatively high, then the entrainment can surpass the gravity and some droplets can be transported from a tray to the tray above. The entrainment can be also seen as the excessive accumulation of liquid on trays, which is led by the ascending transport of liquid from a tray to the other one by the current of ascending gas.

A high liquid entrainment can lead directly to a column flooding called "flooding jet". It can also end in it indirectly by increasing the liquid load until reaching the limit of the downcomer, putting in danger the efficiency of separation. Consequently the reflux flow of the column is increased, increasing more the global liquid flow.

The devices of contact between liquid and vapour in the distillation and absorption columns which we meet most generally are trays with sieves and with valves and, in a more or less large extent, of trays with bubble caps. The capacity of retention of these trays is mostly limited by the phenomena of entrainment or flooding. In all the distillation columns of trays type, liquid entrainment and flooding can be present.

2.1.2 Flooding

The flooding of a distillation column is usually defined as the operating mode in which the entrainment is such as there is no downward flow or clear reflux. Conditions of flooding are useful for the engineer-designer, because they represent the maximal authorized operating mode which can serve as reference.

The flooding is usually caused by the accumulation of deposits (dirts) or a blockage on trays. It is also present when the feeding flow of reflux towards the column is upper to the flow coming down from the downcomer.

The flooding can also concern the capacity of downcomers to channel the liquid flow. Because downcomers are passages fitted out for the liquid flow coming down from a tray towards the other one, limitations in their capacity lead to a reduction of the efficiency of trays and, if the limitation is complete, the flooding of the column takes place.

The efficiency of the downcomer or its capacity is limited by:

- Its size
- The difference of pressure between trays, and
- The vapour pulled in the liquid passing by downward.

If the downcomer capacity is inadequate, the level of liquid in this one increases gradually until it limits the liquid flow on the tray above, or on its tray. This, however, increases the entrainment from one tray to the other one and cause finally the flooding. So conditions of flooding can result, either of an inadequate capacity of the downcomer, or of an excessive liquid entrainment in the vapour space.

In summary, the flooding can be seen as an indication of ineffectiveness due to an insufficient liquid-vapour contact (Hills, 2001).

2.1.3 Other encountred problems

Some other problems can be met. These are mainly:

- "Foaming": foam formation
- Destruction and collapse of trays
- "Weeping" or in other words presence of downward droplets in the vapour space between trays.

2.2 Measurement and physical principles of gamma scanning




Fig. 2-1. Principle of column gamma scanning.

In performing a scan of a distillation column or a similar reservoir, a small and adequately sealed source of gamma rays, with an appropriate collimator, is placed on one side of the column and a sensitive radiation detector is placed on the opposite side (Knoll, 2000). A collimated beam of gamma rays passes through the column wall, is affected by the column internals and hydraulic conditions, and passes through the other side. The source and the detector are simultaneously moved down along opposite sides of the column in small increments (Figure 2-1). Guide ropes for the source and detector are sometimes attached to the column to ensure scan orientation and as an additional factor of safety during the scan.

The scattering of the gamma radiation produces changes in the intensity of the beam that can be correlated to the density of the material inside the inspected column through which the radiation passed according to the following fundamental relationship:

$$I = I_0 e^{-\mu \rho x} \tag{1}$$

where:

• I_0 and I are the initial and transmitted intensities of the gamma beam,

- x is the thickness of the traversed material of density ρ ,
- and μ is the coefficient of absorption which is constant for a given gamma-ray energy and material composition.

Equation (1) shows that an increase in material density will reduce the radiation signal and vice versa. The transmitted radiation intensity is measured and recorded via an interfaced portable computer at predetermined length intervals or positions along the side of the column. A radiation absorption profile (the "scan profile") is then produced.

By comparing the obtained scan profile with a mechanical drawing of the column, deductions can be pulled concerning, as well the possible mechanical damage of the trays as certain operating conditions of the column, such as flooding, blockages, weeping and other abnormalities of process.

Gamma scanning can be performed on almost any type and size of column (0.5 m to 10 m in diameter) and is not affected by pressure and temperature. It usually requires no preparation of the vessel or alteration to process and can be performed from existing platforms and through insulation on vessels.

The correlation of the changes in density recorded in the scan profile with the inner part of the column lead, therefore, to an accurate picture of performance and physical conditions (Hills, 2001).

Each tray and the space above it reflect its working state. For instance, a tray functioning correctly has a reasonable level of aerated liquid showing a fast decrease of the corresponding density until a clear steam space is reached just below the following tray.

- When gamma radiation goes through a medium containing a tray filled with aerated liquid, much of the incident beam is partially absorbed and the radiation quantity reaching the detector is relatively small.
- When a radiation beam goes through a non-aerated liquid, the majority of this radiation is absorbed and the detected signal is weak.
- When a radiation beam goes through steam, only a small amount of suspended material is present to absorb the radiation. This means that high intensities of radiation are transmitted to the detector.

To sum up, a scan using gamma radiation of a column can detect and localise regions of liquid and steam within the column. It can also discriminate between liquid aeration and can detect levels of foam and aerosol in steam regions (Urbanski, 1999) (Pless, 2002).

For distillation columns, without affecting processing unit, this reliable and accurate technique can be used to determine:

- the liquid level on trays,
- the presence or absence of internals, such as trays, demister pads, packing and distributors

- the extend and position of jet and liquid stack flooding
- the position and the density characteristics of foaming
- etc...




Fig. 2-2. Typical profile scan obtained (IAEA, 2002).

Baseline Gamma scans are performed after a startup or when a column is running efficiently to define an operational reference condition within the column. The baseline scan can be compared to future scans to determine how the column is responding over time or is responding to changes in operating conditions.

An important factor to take into account is that, as far as is possible, the operating conditions (such as feed rate, temperature and other process parameters) must remain constant especially during the scan investigation. It is very important to record any process changes during the time of the scan. This will facilitate the interpretation of the scan profile if anomalies are observed.

2.3 Scanning of trayed columns

To conduct a tray-column scan, it is advisable to execute a scan across the trays and to avoid scanning through the downcomers of the trays. Typical and recommended scan line orientations for trayed columns are shown in the following figure (IAEA, 2002).




Fig. 2-3. Typical scan line orientation for single pass-trays' column (left) and double pass-tray column (right).




Fig. 2-4. Examples of typical scan profiles obtained for various problems met on distillation columns, respectively from up and left to bottom and right: normal column, collapsed tray, flooding, entrainment, weeping and foaming (IAEA, 2002).

Examples of typical scan profiles obtained for various problems met on distillation columns are presented in Figure 2-4.

2.4 Scanning of packed beds




Fig. 2-5. Scan line orientations for packed beds (left) and example of real scan profiles obtained for packed bed (Hills, 2001).

Grid scanning is recommended for packed bed columns. A typical orientation of grid scan lines is shown in the figure 2-5. At least four scans are recommended to examine a packed bed column.

Grid scans may be conducted to investigate process-related conditions such as:

- flooding or blockages
- · entrainment or carry over of liquid or
- maldistribution of liquid flow through packed beds.

Grid scans can also be used to investigate mechanical construction problems such as collapsed packed beds or the correct installation of distributors as well as the correct distribution of incoming liquid feed. An irregular distributor can undermine the performance of the entire packed bed and column. Liquid distributors must spread liquid uniformly on top of a bed, resist plugging and fouling, and also provide free space for gas flow. An incorrectly water level installed distributor, that is a tilted distributor, could cause liquid to flow preferentially on one side of the column.

Grid scanning is recommended on packed columns with diameters up to approximately 3m. Larger diameter columns must be approached in a different way, since too large an area (especially in the centre) is not covered.

2.5 Planning of a gamma-ray scan investigation

The following data is required before a scan can be carried out:

- inside diameter and wall thickness of the column (mm)
- bulk density and type of packing material, for packed beds
- downcomer orientation and type of trays present (single, double pass trays)
- operating problems experienced, e.g. low or high pressure problems across the column, or temperature differences along the length of the column

 detailed mechanical drawings of the unit showing internal structure, such as elevations, tray or packing assemblies, nozzle and pipework locations as well as other special features.

Such information is vital for interpreting data from column scan profiles obtained and for identifying and visualising possible mechanical problems. The following additional information is useful:

- gamma scan profiles of an "empty" column (with all the internals but not in operation)
- a scan profile before a maintenance shutdown
- a scan profile after a maintenance shutdown when the column is under normal operating condition.

The activity required depends of the column diameter, ranging from 5-10 mCi for 1-2 m up to 60-70 mCi for 5-6 m and higher for greater diameters. Estimated source strength (activity) can be calculated as follows:

$$A = (D.(d)^{2}.(2)^{2wt/hl}) / T$$
 (2)

Where:

- D = dose rate required (mR/Hr)
- d = diameter of column (m)
- wt = total wall thickness of column (mm) + wall thickness of scan container
- hl = half layer thickness value of material (25 mm for steel for 60Co)
- T = gamma-ray constant for a specific source (1.31 R/h on a distance of 1 meter for 1 Ci ⁶⁰Co source).

When using the above equation it is suggested that 200 mm be added to the diameter of the column to make provision for the source and detector container on the outside.

The above equation is an approximation, and build-up factors of the material are not taken into account. Shielding calculation software can be used to greater effect.

2.6 Factors Influencing the gamma-ray scanning technique

Major factors influencing the technique are:


- Accessibility to the distillation columns
- External construction of columns (piping, brackets, platforms, etc...)
- Variation of the operating conditions during the scan (feeding flow, temperature, reflux feeding, etc...)
- Weather conditions (wind and rain)

2.7 Pipe scanning

Pipe scanning technique is a derivation of gamma scanning technique for pipes. It can be used to detect:

- solids build-up
- refractory quality and losses

- slugging effects
- vapour and liquid presence in the line.

There are a number of radioisotope sources, which can be used; two of them are mostly used: 137 Cs with a gamma-ray energy of 662 keV (half-life 30 years), and 60 Co with gamma-ray energies of 1172 keV and 1332 keV (half-life 5.27 years). The source activity is calculated accepting a dose rate of approximately 1.0 – 1.5 mR/h, at the detector.

Before executing any pipe scanning, the following information is needed:

- the inside diameter and wall thickness of the pipe
- the medium in the pipe (gas, liquid or slurry).

A jack guide is used so that source and detector can be synchronised and always maintain the same distance. The source must be collimated with a collimator of 6 – 8 mm and 10 mm deep in order to obtain a narrow radiation beam. The detector also must be collimated for best results.

A reference scan is obtained on a representative area of the pipeline that is clean and deposit-free.




Fig. 2-7. Example of a scan profile obtained for a pipe containing deposits.




Fig. 2-8. Typical scan profiles obtained for respectively empty pipe (up), pipe with liquid and vapour (middle) and pipe with liquid and vapour separated by an intermediate phase (bottom).

Figure 2-7 gives an example of a scan profile obtained for a pipe containing solid deposits. In figure 2-8 scan profiles for various conditions in pipes are presented (IAEA, 2002).

3. Detection of level and interface by neutron back-scattering technique

Modern petrochemical plant operations often require accurate level measurements of process liquids in production and storage vessels. Although a variety of advanced level indicators are commercially available to meet the demand, these may not suit the specific needs of a situation.

3.1 Neutron backscatter principle

In a neutron backscatter gauge, fast neutrons (with energy 2 to 10 MeV) from a radioactive source (241 Am/Be or 252 Cf) are beamed onto the inspected vessel. Neutrons are particles with no charge and a relatively large mass. Because the distribution of nucleus is relatively sparse in the matter, it could be assumed, that the neutron radiation can pass deeply enough through the material. The effective measurement volume extends typically 100-150 mm into the vessel. By collision with the nucleus the neutrons lose their energy and change the direction of their movement. For ratio of energy of the neutron before collision E_1 and energy after collision E_2 the relation holds (Thyn, 2002):

$$E_2/E_1 = (A-1)^2/(1+A)^2$$
 (3)

Where A is the mass number of atom whose nuclei participated in the collision.




Fig. 3-1. Neutron backscatter level measurement principle (Hills, 2001).

Thus the elements with small atom number have the greatest ability to slow down the neutrons. So, fast neutrons are slowed down mainly by collisions with hydrogen atoms of material inside the vessel (50% of the neutron energy in average is transferred to the hydrogen nucleus in a single collision). The neutron flow has substantially lower energy (thermal neutrons) and different direction after collision with material containing hydrogen. A part of thermal neutrons are then bounced back towards the source. By placing a thermal neutron detector next to the source, these backscattered neutrons can be measured. The number of backscatter neutrons is directly proportional to the concentration of hydrogen atoms in front of the neutron detector. As the source and detector move down the side of the vessel (Figure 3-1), interfaces can be detected thanks to the change in hydrogen atom concentration (Charlton, 1986).

Neutron backscatter gauge clearly indicates solid/liquid and liquid/liquid boundaries and, with careful interpretation of the data, foam levels.

The inspection of the interface between water and oil, as well as among hydrocarbon fractions is the major application of this technique.




Fig. 3-2. Typical neutron backscattering profile obtained for a storage tank with various liquid and vapour phases.

Typical profile using the neutron backscattering technique, obtained for a storage tank filled with various liquid and vapour phases, is given in Figure 3-2 (IAEA, 2002).

In practice this method is seldom applied to vessels with wall thickness above 40mm. Although this technique is not suitable in units with thick walls (over 40mm) and although the detector "sees" not deeper than 10 to 15cm into the system, the portable measuring equipment is a valuable tool often used in analysis and diagnostics of chemical processes.

As long as the vessel has a wall thickness less than 100mm, the use of neutrons is a quick and versatile technique, ideally suited if access to both sides of the vessel is not possible.

3.2 Source and detector used

Helium (He-3) or BF3 neutron detectors can be used. He-3 detector has a higher efficiency and is mostly utilized in recent neutron gauges. The neutron source mostly used is $1 \text{ Ci}^{241}\text{Am/Be}$ neutron source, which produces a flux of 2.2×10^6 n/s with energies from 0.1 MeV to 11.2 MeV, and average energy of approximately 5 MeV. Cf-252 neutron source is used as well, but it is more expensive.

3.3 Applications and limits

Applications of the neutron backscattering technique include:

- Inventory in oil storage tanks without gauges
- Level determination of liquid petroleum gas storage vessels
- Calibration of permanent conventional level gauges
- Determination of sludge or water layers in tanks
- Measurement of packing levels in absorption towers
- Detecting collapsed beds in packed columns
- Monitoring levels of toxic or corrosive liquids in tank cars and railway tankers

- Identifying build-up and blockages in pipes and reactor coils
- Measurement of catalyst levels in reactors
- Detecting ice formation in flate/vent systems.

Neutron backscatter gauge can be used to measure level and interface of transported liquids in pipes as well.

The following factors may influence the measurement and give wrong results:

- Hydrogen-rich materials in the vicinity of the source and detector but outside the process
- Moisture in insulation
- Non-uniform insulation thickness
- Angle and curved surfaces.

4. Radiotracers applications

The use of the radioactive tracers in industry started about fifty years ago, with the arrival on the market of diverse radioisotopes, and did not, since then, stop knowing a continuous extension. The success of the radiotracers applications is mainly due to the possibility, offered by the unique properties of the radioactive materials, to collect data which cannot be obtained by other techniques of investigation (Margrita, 1983).

The radiotracers allow a diagnosis of the functioning of manufacturing units to reach one of the following objectives:

- to determine the characteristics of circuits: flow rate measurements, leaks on heat exchangers...
- to detect the abnormalities of functioning of reactors: short circuit, dead volume, defective mixture
- Detailed knowledge of the conditions of flow: identification of a mathematical model of the residence time distribution and determination of the characteristic parameters (e.g. Peclet number);
- Define the data to be introduced into the automatic circuits: determination of the transfer functions of phases, substances in solution or in suspension
- Complete the kinetics information by hydrodynamics data: obtaining the residence time distributions of the various phases in reaction.

The importance of such studies is underlined by the fact that the competition to which are subjected the diverse chemical industries brings these to optimize their units' efficiency to make more competitive the made product. A better knowledge of the flow of fluids passing through devices contributes to reach this objective: we are led in certain cases to internal mechanical modifications of the devices which induce an improvement of their performances.

The implementation of radiotracers methods so allows to answer a certain number of questions concerning the characteristics of material transfer in the units without disrupting the operation. The main applications concern very diverse industrial domains such as the oil, the cement, the inorganic chemistry, the chlorine, etc....

Radiotracers play an important role in troubleshooting of processes in petrochemical industry.

4.1 Methodology

4.1.1 What is a tracer?

A tracer is by definition a substance which can become identified with a product, the characteristics of flow of which we want to know. This tracer will have to have a behaviour identical to the product, while being able to be revealed and measured by an appropriate technology.

The used radioactive tracers are generally gamma-ray emitters to be detectable through the walls of the installations by external probes.

These radioactive tracers, so called radiotracer, line up in two categories:

- The tracer is an isotope of the product to be studied; in that case it constitutes the intrinsic tracer so giving the confidence of a physico-chemical behaviour and a hydrodynamics strictly identical to that of the product;
- The tracer is an isotope of an element other than the constituent of the product, when this one can not be or badly activated; in that case we have to make sure that its behaviour is the same than the one of the product to be studied.

The radioactive tracer, obtained by irradiation of some grams of the product in the neutronic flow of a nuclear reactor, is mainly characterized by:

- The period or half-life T (time at the end of which the initial activity is divided by 2),
- The energy of the emitted gamma-rays (E keV),
- The physico-chemical form (gaseous, liquid or solid pulverulent as the case may be).

4.1.2 Why a radioactive tracer? Advantages of the radiotracers

The used tracers are, as the case may be, coloured, fluorescent, radioactive chemicals, etc...

The radioactive tracers present various advantages on the other types of tracers:

- Their qualitative and quantitative detection can be made through walls;
- The ease of qualitative analysis (presence, absence of tracer) or of quantitative of the radioactive tracers, analyze which are independent from the matrix. We shall obtain mostly a maximal quantity of information with a radioactive tracer.
- The radioactive methods offer the widest range of tracers, what is often major when we examine a problem of labelling.
- Another characteristic of the radioactive measures is their high sensitivity. This
 interesting property finds its origin in the nature of the used detectors, in the fact that in
 spite of an omnipresent natural activity the signal on noise ratio is favourable, and
 finally, in the possibility that we have to improve the precision of measure of a sample
 by increasing the counting time.

The results obtained by this method are interesting during all the duration of evolution of a chemical process since the conception until the exploitation, including the improvement of the installation and the optimization of the operation.

4.1.3 Choice of tracer

The best labelling consists in using radioactive isotopes identical to those of the medium to be marked and under the same chemical form. We then have to deal with an internal tracer. If we do not arrange such isotopes, we shall use an isotope of different nature, so called external tracer. This tracer will be chosen so that we can plan that it will have a dynamic, chemical, physico-chemical behaviour, identical to that of the product to be marked.

- For compounds, mostly under the macro-aggregates form such as powders, the direct irradiation in a flow of thermal neutrons gives rise to radioactive isotopes of often present elements in the state of traces. The sodium, for example, is often used in this purpose.
- If the substance to be marked is made of rather big blocks, we shall make for it holes in which are included the tracers (powder, wire).
- The marking of solid substances is still made by soaking them with solutions of a radioactive substance or by putting down on the surface a radioactive substance.

We are sometimes led to realize, in laboratory, tests the object of which is to show that the proposed tracer is valid.

The gamma rays must have enough energy to get through the wall and be exactly recorded. Its period must be long enough to take into account deadlines between the dates of the irradiation and the use.

Let us indicate finally that the radioactive tracers have, for the used activities, very low masses, of the order of fractions of micro-grams. We often use them, if there are risks of adsorption, in parallel with important quantities (several grams) of similar but not radioactive substances. The last ones are so called "trainers".

4.1.4 General principle of an industrial application of radiotracer

The principle of a tracer experiment is the one of any common method impulse-response (Figure 4-1): injection of a tracer in the entrance of a system and a recording of the concentration-time curve at the exit.



Fig. 4-1. General principle of radiotracer application in industry.

The operation consists in marking a slice of material, in the entrance of the device to be studied and to observe, in various characteristic points of this one, the response curve of the concentration of the tracer versus time, C(t).

1. Injection: the injection of tracers can be realized by various manners: very fast injection, injection with constant flow, injection in a very high-pressure circuit and under diverse

physical forms: gas, liquid, powder. The injection will have to be the most brief possible so that the recorded response in the chosen points of measure can be considered as a Residence Time Distribution (RTD) of the marked phase. The tracer, packaged e.g. in a quartz bulb for gases, is placed in an injection device surrounded with a lead shielding. The injection is made instantaneously in the flow of material in the entrance of the device, by a push of nitrogen the pressure of which is adapted to the operating conditions of the unit.

2. Detection: Detectors allowing to measure through the walls of the installations the gamma rays, emitted by the tracer, are generally scintillation detectors type. The signals delivered by these probes are registered in a data acquisition system, monitored by a computer allowing the storage of the information of about ten sensors (or more) collected at high sampling rate. So, we can have, for every test, of the order of 5 000 information for each measuring channel. Later the data so stored are treated in batch mode by a computer in the laboratory.

4.1.5 What is a Residence Time Distribution (RTD)?

Since its introduction in the chemical engineering by Danckwerts in 1953, the concept of the Residence Time Distribution (RTD) became an important means of analysis of the industrial units. We know that particles crossing a device stay in this one more or less for a long time according to the route which they go through. The Residence Time Distribution (RTD) represents the density of probability which has a particle entering a system, at a given moment, to go out of this system during time. The RTD of the marked phase is calculated from the response curves of the concentration in tracer versus time, C(t), measured in a point of the installation (Guizerix, 1970) (CEA, 1990).

The experimental residence time distribution E(t) is calculated:

$$E(t) = \frac{C(t)}{\int\limits_{0}^{\infty} C(t)dt}$$

4.2 Results which can be obtained

The Residence Time Distribution allows to calculate:

- The time of arrival (t_a) which corresponds to the time of transit of the fastest particles between the injection and the point of measure.
- The time (t_m) , the abscissa of the maximum of the curve, which indicates the time of transfer of the maximal concentration of tracer.
- The mean residence time, (τ), of the marked product in the system, defined by the difference of the abscissas of the centre of gravity of entrance-exit curves.

The physical parameters directly deductible from the RTD are:

- Speed of the flow of material
- flow of material
- Density

- Dead volumes
- By-pass




Fig. 4-2. Residence Time Distribution (RTD) curve.

4.3 Applications

4.3.1 Flow measurements

The flow measurement represents one of the most ancient applications of the radioactive tracers. According to the cases, two methods are used:




Fig. 4-3. Flow rate measurement by the "two Peaks" or transit time tracer method (IAEA, 2008).

1. Allen's method (or method of "two peaks"), for the pipes of known geometry (figure 4-3): it is the simplest technique where a small quantity of radiotracer is injected in the process and its passage downstream is monitored by two radiation detectors placed outside of the pipe. The used radioisotope should be a Gamma emitter allowing external detection. If the first detector is at a sufficient distance from the injection point, to assure a complete mixture of the tracer, the time measure of transit of the impulse between both detectors allows the calculation of the average speed of flow (speed of the fluid). Knowing the surface of the pipe section, the measured speed can be converted in volumetric flow. This method allows generally measures of average flows with better than ±1 %, when the internal diameter of the pipe is exactly known.

- 2. The method of dilution, with its two variants: integration method and injection method with constant flow. Here an appropriate radiotracer is injected in the process, and samples are collected in a point enough downstream to assure a complete mixture. The injection of the tracer and its concentration, both in the injected solution and in the diluted samples, are measured. From these data, the flow can be easily calculated.
 - a. Integration Method: the tracer (activity A) is injected during a short interval of time. In a section, situated downstream, we measure in a point the function C(t) representing its passage; the flow is given by:

$$Q = \frac{A}{\int C(t)dt} \tag{5}$$

The good mixing condition is: $\int C(t)dt = constant$, whatever is the point of sampling in the section of measure.

b. Injection method with constant flow: the tracer is injected in a section at constant flow, q, and at a concentration C₀. In a section situated downstream we determine, after reaching a constant regime of concentration, the concentration C of the tracer. If Q is the flow to be measured, an equation of balance of the tracer gives:

$$Q = \frac{C_0}{C \times q} \tag{6}$$

This relation can be written only if the distance between the section of injection and the section of measure is rather big so that in this last one there is good mixture of the tracer, condition which we represent by: C = constant, whatever is the point of sampling in the section. This technique is ideal for the measure of flow in open channels such as sewers and mouths of rivers (the range of measure is very wide: flows of rivers of several thousand cubic meters per second can be measured). The precision is among the best which we can obtain ($\pm 1~\%$ or better). A precision of $\pm 0.5~\%$ can be reached for regular flows with adequate distances of mixture.

These methods of dilution apply (cf. equation of balance) for the measure of constant flows. An analysis can be however made for the application of the method of injection with constant flow in case Q varies. It allows to measure continuously the flow of industrial waste over reference periods, for example of 24 hours.

These methods, apply as well to gases as to liquids, at high or low pressure. The techniques of measure of flow are immediate and are not thus useful for continuous measures. We apply them for the calibration of classic devices (ratemeters), with a 1 % precision, or in the studies of circuits with tapping.

The flows of products (liquid, solid and muddy) or of cooling water are measured in a 1-2 % precision in situations where ratemeters are not installed or are not reliable any more because of problems of deposits or corrosion.

Finally, the implementation of these techniques is very simple and induces only a minimal disturbance of the network; it is need, for example, only of a "pricking" for the injection of the tracer.

4.3.2 Volume measurements: Determination of dead (or stagnant) volumes

The capacity of a device is not always fully used, and it can exist zones, so called dead, which participate little or not in the flow.

The volume of the dead zones is determined by exploiting the obtained residence time distribution (RTD) using the method of dilution which consists in injecting an activity A and in measuring, after homogenization, the resultant concentration, what allows to reach the volume in which diluted the tracer.

The RTD allows to calculate t, the residence time of the material in the device. If τ is the mean residence time, determined by:

$$\tau = \frac{V}{Q} \tag{7}$$


Where V is the volume of the device and Q the flow.

In case the volume is completely occupied, t is equal to the mean residence time τ . If $t < \tau$ we deduct generally the existence of a dead volume V_m given by:

$$t = \frac{V - V_m}{Q} \tag{8}$$

Then:

$$V_m = V \times (1 - \frac{\tau}{t}) \tag{9}$$

The stagnating volume, which corresponds to a zone of fluid little accessible to the main flow, is represented on the impulse response by a trail of the curve.

4.3.3 Leak detection

Leak detection and leak location using radiotracer techniques are probably the most widespread applications of radiotracers in industrial troubleshooting. Leaks create problems in process plants or in pipelines, spoil the quality of the final product or reduce the capacity of oil and gas pipelines and contamination of surface or ground water and soil could also happen (IAEA, 2009) (IAEA, 2004).

The sensitivity inherent to the radiotracers techniques makes them extremely precious for the detection of leaks in pipes, heat exchangers, condensers and valves. The measures are realized while the units stay on operation and without interfering with the process.

Leaks in heat exchangers are more frequent problem in many processing plants of petrochemical industry. Radiotracers are very efficient and most competitive for detecting small leaks inside the heat exchangers. Detection limits of 0.5% of stream flow can be achieved. Radiotracers methods are also very effective when the pipes are buried.

The experiments of leak determination are two types: qualitative or quantitative.

- In the first case, it is only a question of showing that there is a leak between two media. The answer is given by marking the fluid of the first medium and by showing the appearance of the tracer in the second medium.
- In the second case, we try to determine the flow rate of the leak. An injection of tracer is realized in the primary circuit and the impulse responses are measured downstream to both circuits. If the leak exists, some of the tracer will pass into the lower pressure stream. There it will be detected either by sampling the process fluid downstream or by monitoring the movement of the tracer using detectors mounted externally. The equation of balance of the tracer allows easily to calculate the flow rate of leak. Leaks so low as 0.1 % can be measured with online external detection, while sampling can identify leaks as small as 0.01% of the main fluid flow rate.

For leak detection and leak location in buried pipes the so called "pig technique" is used. Here the pig means a sensor for detecting and recording radiation signals from inside the pipeline. Radiation detection pig consists of a detector and data logger assembled together inside a compact watertight cylinder. Pig moves inside the pipelines.




Fig. 4-5. Principle of radiotracer pig method: radiotracer injection device (up, left), pig container (up, middle), pig introduction in pipe (up, right), schematic principle of leak detection in buried pipe (bottom) and typical signal obtained from datalogger (middle).

The method is a two step procedure. In the first step, radiotracer solution is pumped into the pipeline as a tracer plug without any interrupting operation. Where the "plug" meets a hole or fracture, a small amount of the tracer will penetrate and be trapped outside the pipe wall. In the second step, the pig is launched into the pipeline for leak detection run (Fig. 4-5).

This method has a higher sensitivity for leakage detection in underground pipelines as the pig moves in close contact with the leak surrounds. Leaks of the order of 0.1 litter per minute can pinpointed (IAEA, 2009).

4.3.4 Determination of rate of by-pass (short circuit)




Fig. 4-6. Typical RTD curve obtained in case of by-pass or short circuiting.

We can identify short circuits, i.e. the existence of fluid flows quickly circulating in the reactor. In that case, following an instantaneous injection of tracer, the residence time

distribution (RTD) presents abnormalities of shape due to the presence of a narrow peak coming to overlap in the main response. This means the existence of a preferential passage inside the unit (Fig. 4-6).




Fig. 4-7. By-pass rate calculation method.

The importance of the by-pass can be quantified from the ratio of the area of the peak over the total area of the curve: by interpolating under this peak the main response, we can resolve the impulse response into two responses corresponding to both modes of flow, with respective areas A and B. The rate α of by-pass is (Fig. 4-7):

$$\alpha = \frac{A}{A+B} \tag{10}$$

4.3.5 Determination of recycling

The current of recycling corresponds to the reincorporation of a fraction of the outgoing flow, to the entrance of the reactor, and which we can detect on the impulse response by successive, but weakened waves, at regular intervals.




Fig. 4-8. Typical RTD curve obtained in case of recycling.

4.4 Construction, use of physico-mathematical models

One of the most interesting and the most promising modern applications of the tracers, generally, and the radioactive tracers, in particular, concern either the use, or the construction of physico-mathematical models. This is in a general tactics which is always adopted to optimize a situation. Better we know how to describe a phenomenon, more we master it (Margrita, 1983).

4.4.1 Models of flow

The behaviour of the material passing through manufacturing units is very often similar to a type of flow being situated between two extreme behaviours of theoretical flow: "Piston" and "Perfect Mixer".




Fig. 4-9. Piston model and its response curve.

1. "Piston" model: the fluid moves altogether according to the image of a piston in a cylinder, in parallel slices without any exchange between them. The impulse response of such a system is $h(t) = \delta(t - \tau)$, δ being a Dirac function (Fig. 4-9).




Fig. 4-10. Perfect Mixer model and its response curve.

2. "Perfect Mixer" model: this type of model represents an immediate and uniform mixture of the entering fluid. The impulsive response of such a system is the exponential Shape (Fig. 4-10) and spells:

$$E(t) = \frac{1}{\tau} e^{(-t/\tau)}$$
 (11)

"Piston-Dispersion" model (Fig. 4-11): it is the type of flow that we meet frequently. It is situated between the previous two models. Slices quoted in the "Piston" model exchange some material, leading to a phenomenon of dispersion of this material, quantified by a so called dispersion coefficient. This dispersion is also characterized by a without dimension parameter P called "Peclet Number" and which is calculated by the relation:

$$P = \frac{u \times L}{D} \tag{12}$$

A high value of Peclet number represents a low dispersion. When $D\rightarrow 0$, this model tends towards the Piston model; on the contrary when $D \to \infty$ (big dispersion, P low) this model is comparable to a Perfect Mixer.

The impulsive response has the form:

$$h(t) = \frac{u}{\sqrt{4\pi \times Dt}} e^{-\frac{(L-ut)^2}{4Dt}}$$

$$h(t) = \frac{u}{\sqrt{4\pi Dt}} \cdot \exp{-\frac{(L-ut)^2}{4Dt}}$$

4.4.2 Identification to a model

The relation between the entrance function and that of the exit of some system is given by a so called Convolution Operation. This operation allows to determine the exit function $\mathbf{s}(\mathbf{t})$ when we know the entrance function $\mathbf{e}(\mathbf{t})$ and the impulse response $\mathbf{h}(\mathbf{t})$ (Fig. 4-12).



The fit of a "Piston-Dispersion" model to an experimental curve in exit of a device, consists in determining u and D parameters of the impulse response h(t), in a way that the product of convolution of the entrance function by the impulse response of the considered system, overlaps at best with the experimental curve registered in exit.

The general approach is the following one:

- A physical model of the flow is imagined; its mathematical formulation allows to clarify, according to certain parameters, the residence time distribution.
- A tracer experiment on the unit gives the real residence time distribution.
- A fit between both distributions (experimental and theoretical) by the methods of
 mathematical optimization allows to evaluate the validity of the proposed model on
 one hand and to fix the values of the parameters on the other hand.

A good agreement between both distributions means that the proposed model is useful, either to optimize the system, or, still to extrapolate its dimensions to those of another device in project.

The values of the found parameters can be used to the establishment of tables which will facilitate, later, the extrapolations which we have mentioned.

The purpose of fit of a mathematical model can also be the automatic monitoring of the units by computer.

5. Conclusion

The economic benefits that may be derived from the use of radioisotope technology in petrochemical industry are large. In this chapter we tried to present the state-of-the-art in major techniques used in petrochemicals such as gamma-scanning as a diagnostic tool for distillation columns and pipes, neutron backscattering for level and interface detection in

storage tanks and other reservoirs and finally radiotracer applications for troubleshooting and optimizing processes (residence time distribution establishment, flow measurement, dead volume determination, leak detection, short-circuiting or by-pass calculation, etc...). It aims to provide a comprehensive description of what can be achieved by the application of such techniques and to promote their benefits to industrial end-users.

Resonance in Electrical Power Systems of Petrochemical Plants

1. Introduction

One of the most serious problems in the operation of petrochemical plants is the breakdown of the electrical energy in the production processes. This interruption could be due to the presence of failures that inhibit the continuity and reliability of the electrical energy service. A possible cause of fault in the electrical power system with permanent damages in the primary electrical equipment is the occurrence of the electromagnetic resonance phenomenon. The presence of this phenomenon is directly associated with the grounding scheme of the electrical power equipments. At the moment, in some petrochemical plants only one neutral is connected to ground. When a fault appears, the protection relays operate in order to release the fault and leaving the system temporarily without ground reference. During this time the electrical system remains floated the resonance phenomenon can appear. In petrochemical plants, it is a common practice to have a neutral bus where all the power equipments are connected through an energy cable with a length up to 1 km, with a parasitic capacitance in the order of 50 to 1,000 nF.

This chapter provides an analysis of research on the occurrence of resonance overvoltages in the electrical power system of petrochemical plants. Using digital simulation by *Graphic Alternative Transients Program* (*ATPDraw*) from *EMTP* was determined that this phenomenon appears when the electrical system does not have reference to ground. It was found that the occurrence frequency of this phenomenon is within a range near to 240 kHz and the magnitude of the overvoltages is in the order of 10 to 20 p.u. Likewise, the evidence of practical cases are discussed where the results were catastrophic for the plants. Also, an analysis of overvoltages by connecting potential transformers windings in open delta is presented.

As a practical solution to keep away from the presence of overvoltages by series resonance, a hybrid neutral grounding scheme is used with the aim of avoiding the power system could be floated during stationary and fault operation of the electrical power system in petrochemical plants. Hybrid neutral grounding consists on an implementation of high resistance grounding in parallel with the low resistance scheme on each of the electrical generators.

The solution for avoid series resonance in potential transformer with open delta windings is the used of wye connection to ground.

2. Grounding methods in petrochemical plants

The electromagnetic resonance phenomenon, will be described in section 3, it is directly associated with the method of grounding the electrical system of the petrochemical plants. Protection schemes and practical grounding of industrial power systems of medium voltage, such as industrial petrochemical plants, are based on IEEE standards, the National Electrical Code (NEC), IEC standards and technical publications [IEEE Standard 141-1993; IEEE Standard 142-1982; IEEE Standard 242-1986; IEEE Standard 241-1983; ANSI C62.92-1987; National Electrical Code National; IEC 61936-1 2002; IEC 60364-1 2001; Dunki-Jacobs, 1977].

The grounding of the electrical system is physically connecting a point of the system (usually the neutral transformer or generator) to ground and create a reference voltage for the electrical system [IEEE Standard 141-1993; IEEE Standard 142-1982; IEEE Standard 242-1986; IEEE Standard 241-1983; ANSI C62.92-1987; National Electrical Code National; IEC 61936-1 2002; IEC 60364-1 2001; Dunki-Jacobs, 1977].

In practice, the electrical power system of a petrochemical plant on 13.8 kV is grounded using "low resistance" method, grounding only one or maximum two points of the system, as the neutral of star winding neutral transformer or generator. Also, on 4.16 kV transformers are used in delta-star connection so the neutral is grounded using the "low resistance" method. At the level of 480 V as used by the method of "solid" grounding by the neutrals transformers.

On the other hand, when a fault to ground occurs on 13.8 kV, the system can be "floating" as described in section 2.3, in this case, the system is "ungrounded". The following describes each of the grounding methods used in the electrical system of the petrochemical pants.




Fig. 2.1.1. Resistance with grounding.

2.1 Low resistance grounding

In large systems where we have a high capital investment in equipment or losses which have a significant economic impact, we use the low impedance grounding [Manning, 1964; Shipp & Angelini, 1991]. In this scheme, a resistor is connected, normally a value that allows only a ground fault current of 200 to 800 A, through the neutral grounding system, see Fig. 2.1.1. As the grounding impedance is a resistance, any transient overvoltage is quickly damped and the overvoltage does not stay for a long time [Shipp & Angelini, 1991].

2.2 Solidly grounding




Fig. 2.2.1. Neutral solidly grounding.

Solidly grounding systems are the most commonly used. These schemes can be used in systems operating with a single phase loads, tending to a safe operation, see Fig. 2.2.1. If the system is not solidly grounded, the neutral system remains floating to ground, and remains as function of the load line to neutral and exposed to unbalanced voltages and instability [Shipp & Angelini, 1991].

2.3 Isolated from ground




Fig. 2.3.1. Ungrounded neutral.

A floating system is used in those systems where service continuity is the main concern, see Fig. 2.3.1. The perception is that the floating systems provide greater continuity on the service. This is based on an argument that the ground fault current is smaller and therefore, the heating produced by the presence of such failure is negligible [Shipp & Angelini, 1991]. That way, the line to ground faults can remain on the system until it's convenient to remove them. This idea has some validity only if snapshots or "solids" failures are considered. However, in practice, most faults begin as ground faults by arcs of low energy. When starting a ground fault arc, we can have the following problems:

- Multiple ground faults
- Resonance
- Transient overvoltages

Multiple failures to ground may occur in floating systems. While a ground fault on an isolated system does not cause an exit, if the fault continues, increases the possibility of occurrence of a second fault in another phase. That is because the ground insulation of the

unfaulted phases acquires the phase to phase voltage. In other words, the insulation is subjected to stress 73% above the normal operating condition.

Even though it isn't common, the phenomenon of resonance can occur when one phase is grounded through an inductance, for example, a ground between the winding of the instrument transformer. When this happens, the high current flow causes high voltages across the unfaulted phases. Transient events due to switching or intermittent faults to the ground can produce overvoltages on floating systems [Shipp & Angelini, 1991].

2.4 Advantages and disadvantages of grounding methods

Table 1. summarizes the most relevant characteristics of grounding schemes, available in the petrochemical plant electric system [Shipp & Angelini, 1991; Reyes Martínez, 2001].

3. Series resonance

Series resonance is the tuning of the inductive and capacitive reactance of the elements of an RLC series circuit. During the occurrence of this phenomenon dangerous overvoltages may occur depending on quality factor Q of the circuit [Rüdenberg, 1950; Boylestad, 1998; Boylestad, 1998; Fuentes Rosado, 1988], that way damage to associated equipment. This effect is observed in the digital simulation results presented in section 3.3. The resonance can also occur by the presence of harmonic frequencies [Lemerande, 1998; Currence, et al., 1995; Girgis, et al., 1993; Fujita, 2000]. This sections contains a description of the resonance phenomenon, the causes may brings as present in the electrical system of an industrial petrochemical plant during a fault.

3.1 Description of grounding practices that induce the presence of this problem




Fig. 3.1.1. Typical generation scheme of a petrochemical plant.

It is extremely necessary to maintain the electrical power supply of petrochemical power plants; therefore most of them have their own electrical energy generation. In some petrochemical plants there is a common practice to associate an electrical generator with a load connected directly to the electrical generator terminals. Most of the plants use 30 MW generators at 13.8 kV with a load on the order of 15 to 20 MW associated to their terminals. The generators are interconnected trough a synchronizing bus with short circuit current limiting reactors as shown in Fig. 3.1.1. The use of these limiting reactors is associated with voltage regulation problems and with the necessity to overexcite the generators, causing problems with generator stator core. However, the use of this scheme maintains the continuity of energy supply to the load sustained through the public network when generators are out of service.

3.2 Factors affecting series resonance

Petrochemical plants with 13.8 kV generators; use low-resistance neutral grounding method at just one generator. The ground connection through a resistance bank has a value of 8 to 13.2 Ω which limits the ground fault current between 600 and 1,000 A. In other hand, if all generators are connected to ground, all protection devices will operate to leave the entire generators out of service. Furthermore, the short circuit ground fault current increases at a point that it will easily exceed the 1,000 A.




Fig. 3.2.1. Actual generator neutral grounding scheme.

The neutral grounding method used in a petrochemical plant is shown in Fig. 3.2.1. The system has two power units, the first unit consists in two generators of 32 MVA (TG-1 and TG-2) and the second one with 2 generators of 40 MVA (TG-3 and TG-4). The four neutral generators are connected to a neutral bus through an interrupter. The neutral bus has a low resistance bank connected to ground. Therefore, only one generator is connected to ground.

When a ground fault occurs in a cable or in any other electric power equipment and this does not release appropriate, the protection system acts over the generator with the neutral connected to ground. The generator outs of service and the system operate temporality "ungrounded". Even though, it is in fact connected to ground through the ground system capacitance.

3.3 Overvoltages caused by series resonance




Fig. 3.3.1. Diagram of one generator neutral grounding.

Considering an ungrounded generator, that feeds an electrical load, as shown in Fig. 3.3.1. The generator model is represented by a source and an inductance in series. The cable and the load inductance are illustrated too. Also it represents the cables capacitance, the capacitors banks and the surge arresters.




Fig. 3.3.2. Fault in phase A and current return path.

The system has a steady performance. The load is feeding by the generator; the neutral current is almost zero. The generator is grounded by its own capacitance. There is not current through the neutral generator and there is a third harmonic voltage of 1 kV peak to peak approximated. When a ground fault occurs in the system, a return current through the generator capacitance and a voltage appears through the neutral, which affects the voltage applied in the un-faulted phases, as shown in Fig. 3.3.2.




Fig. 3.3.3. Voltage increase in the no fault phase A into an ungrounded circuit.

When a current is injected through the neutral capacitance, the neutral potential increases, in such a way that ground potential of the phases change to voltage between phases due to neutral shift. Although it is negative, this situation is considered in the electrical systems designs. For example, power cables are designed with 173% of insulated level. As shown in Fig. 3.3.3, an increase in the magnitude for the next phase in sequence to the ground fault phase is observed.




Fig. 3.3.4. Waveform of phase neutral voltage generated during a short circuit.

This voltage increase is not a problem for electrical equipments due to it is considered in design. The problem turns pessimistic due to short circuit current of ground fault phase to neutral, affecting the waveform of un-faulted phases, which stay with a no sinusoidal waveform. As a result of the interaction between fault phase and the others phases, it is obtained a waveform, as shown in Fig. 3.3.4.




Fig. 3.3.5. Frequency spectrum of the voltage waveform illustrated in Fig 3.3.4.

During a short circuit the phase-neutral voltage is affected, and it is attributable to harmonics components, whose frequency depends on the generator inductance and capacitance equivalent values, furthermore, the equipments and accessories that are connected with the generator to a distribution switchboard. If a Fourier transform is applied to the voltage waveform illustrated in Fig. 3.3.4, it is possible to find the frequency of harmonic components. Fig. 3.3.5 exposes the Fourier analysis of generator phase-neutral voltage.

During the ground fault short circuit, the un-faulted phases have a distorted waveform. With this distorted wave, the generator supplies the demanded electrical energy in conjunction with the electrical public network. At this moment, the question is if all network with capacitance and inductance distributed values of all component, are in resonance or it is represented in somewhere of the circuit where it has appropriate tuned values. Founded evidences in some faults, demonstrate that resonance is located specifically and the damage takes place in the nearby equipments to the overvoltage site. The ground fault occurs in a different phase from that had failed previously. In practice, the second fault could occur at a different site where it occurred at the first time, the crucial condition is that the inductance and capacitance are synchronized and forming a series resonant circuit as shown in Fig. 3.3.2.

3.4 Detailed analysis of equations of series resonance

The series resonance phenomenon can occur when a disturbance occurs as a phase to ground fault in power system operation. Resonance occurs when the inductive reactance equals the capacitive reactance [Rüdenberg, 1950; Enríquez Harper, 1978; Boylestad, 1998; Fuentes Rosado, 1988; Halladay and Shih, 1985; Hayt & Kemmerly, 1990; Strum & Ward, 1973; Bodger & Norriss, 1988; Kraft & Heydt, 1984].




Fig. 3.4.1. Series RLC circuit.

In a series *RLC* circuit as shown in Fig. 3.4.1, the current i(t) is given by equation (1).

Where *Z* is the impedance of the circuit by Kirchhoff's voltage law is equation (2).

$$Z = R + j \left(\omega L - \frac{1}{\omega C} \right) \tag{2}$$

Where ω is the angular frequency of the circuit and its value is ω =2 π f; the magnitude of Z is given by equation (3).

When $X_L = X_C$ or $\omega L = \frac{1}{\omega C}$, the circuit parameters are limited mainly by the resistance R and it says that the circuit is in resonance. Under these conditions the resonance frequency is given by

$$f = \frac{1}{2\pi \sqrt{L C}} \tag{4}$$

For the particular value of the frequency of equation 4, the current I and the voltage V are in phase (P.F = 1.0) and current-voltage relationship agree with Ohm's law. Analyzing the resonant circuit in Fig. 11 is obtaining resonance overvoltage.

The parameter Q is the quality factor of the resonant circuit and is defined as 2π times the storage energy ratio between the energy dissipated in half cycle [Rüdenberg, 1950; Boylestad, 1998; Hayt & Kemmerly, 1990; Strum & Ward 1973].

At resonance, the energy is stored in the inductor and the capacitor and only dissipated in the resistor. Also, the current through the resonant circuit is in phase with the voltage *V* of power source.

3.5 Practical example (showing photos of catastrophic effects in electrical equipment)

In some plants have occurred serious problems related to actual generator neutral grounding. This section describes three events in petrochemical plants.

3.5.1 Fault description in Plant "A"

The fault began with ground fault in the TDP-2 – RX-2 feeder (cable), see Fig. 3.5.1.1, when the ground fault occurred in this feeder, the negative sequence current circulated through the TG-3 neutral and TR-CFE transformer, condition that triggered the generator ground protection. After the trip from TG-3 also triggered transformer protection, therefore the power electrical system was temporarily ungrounded. Subsequently, TG-2 differential protection was operated. This protection operated because there was a ground fault in a coil of *R* phase into the TG-2 generator. Based on the system conditions at the time of TG-2 fault occurred, and the position of poles damaged, it is considered that this fault was caused, by the series resonance phenomena as a result of ungrounded system.

The resonance phenomenon occurs at the tuned frequency with the capacitive and inductive reactance of the circuit. In case of industrial system could be defined by 1) system capacitance, it is includes the cable, the windings and parasitic capacitance; and 2) the inductive reactance of the cable and equipment windings.

The generator core damage by electro-erosion, produce by arc flash, is shown in Fig. 3.5.1.2. The arc flash must begin by a magnitude voltage that broke the dielectric distance. For that distance, it is estimated an overvoltage that exceeding 100 kV.




Fig. 3.5.1.1. Localization of faulted cable in the power electrical system.

3.5.2 Fault description in Plant "B"

This plant was operated with three electrical generators: TG-2, TG-3 y TG-4. The power electrical system was synchronized to the public network through a "link" principal transformer. The electric network of this plant was ungrounded during a fault or there was not ground reference in system by a previous fault. Subsequently, in another site a fault occurs in a switchboard called "extension bus bar of TG-2" at voltage level of a 13.8 kV. The fault consists of an arc flash between bus bar and switchboard walls when the network was steady. Transient oscillations of the frequencies derived of the arc were tuned to the circuit, and it was in resonance. The evidence shows that intermittent arc flash occurs, promoted electro-erosion as is shown in Fig. 3.5.2.1.

The distance between bus bars and switchboard walls connected to ground was 14 cm; therefore, it must be at least an overvoltage of 160 kV to break down the air dielectric strength. Then, another arc flash occurred in the un-faulted phases, after it there was produced a three-phase fault at bottom of the bus bar. Due to three-phase fault the copper material was fused in bars until it was detected by the network protections.

Another switchboard fault was presented in this plant. The evidence showed that there was an arc flash between CT's connection bars to the switchboard wall. A few minutes before the fault occurred in the 115 kV transmission line in the public network which was feeding the load plant, then it was produced an overvoltage in the 13.8 kV network of the plant. Due to the principal transformer is connected through a reactor to the synchronizing bus; the transient was spread to the feeder circuits connected to the bus. Due to the disturber in the 115 kV line service, the interrupter was operated. Immediately after, the load segregation system was operated.

The voltage regulator of the TG-4 generator tried to absorb the load, however, the generator left of operation by overexcitation protection. The TG-1 and TG-2 generators continued operating and feeding the not segregated load. Fig. 3.5.2.2 shows the evidence of arc flash between CT's connection bars and the switchboard wall.




Fig. 3.5.2.1. Electroerosion damages by repetitive or intermittent ground fault arc flash.

3.5.3 Fault description in Plant "C"

In the cases above mentioned there was not an evidence of previous fault. In this case, the first fault occurred in a 13.8 kV cable feeder connected to TDP-1 switchboard about 200 meters away from where, 15 seconds after, occurred the second one. The second fault occurs in the called "cell fundamentals" where de protection and measure device's are located. The evidence shows that the generator surge protection capacitors were severely damaged, the connection bars were fused and the two potential open delta connecting

transformers, showed on theirs surfaces, a evidence of three-phase short circuit (see Fig. 3.5.3.1).




Fig. 3.5.3.1. Capacitor and capacitor bars connections damages.

The fault began in a phase 2 feeder as a ground fault, it had produced an overvoltage in phase 3 with sufficient magnitude to cause the capacitor ground fault. The ground reference during the fault was in TG-3 generator; the current must be circulated through the ground resistance in TG-3. The fault performance was apparently like there was not a ground reference; the zero sequence current did not found ground return, it produced overvoltage in the not fault phases. This fact caused the generator operated like an ungrounded system.

3.6 Problem solution




Fig. 3.6.1. High resistance grounded scheme to avoid resonance overvoltages.

It has been observed trough the years, that in some instances, when there is a ground fault in the 13.8 kV system, the generator that has a reference to ground sees the failure and the protection system takes it out of service. In this conditions, the electrical power system remains without a ground reference without being able to release the failure. The short circuit currents is limited by the capacitance of the generator, that is in the order of 0.5 A. The injected failure current trough the neutral produces a non sinusoidal voltage in the generator output. This voltage excites the failed system and a series resonant circuit can be excited. In this conditions a very dangerous overvoltages are generated. It practice, it has been observed arc flashover between electrodes that are 15 cm apart; and then the overvoltages are estimated in the order of 10 to 12 p.u. So, in order to avoid resonance overvoltages is necessary to have grounded systems to keep and intentional reference to ground. Fig. 3.6.1 shows a high resistance grounded system. When a ground fault occurs the short circuit magnitude is given by the high resistance value, in this diagram is 5 A. Simulations showed there are not maximums overvoltages more than 1.73 p.u. Finally, Fig. 3.6.2 shows a high resistance transformer installed in a petrochemical plant.

4. Resonance in potential transformers

It has been observed that the series resonance can occur in potential transformers (PT). In this case overvoltages were also presented by the series resonance phenomenon.

4.1 Description potential transformers in electrical switchgears

The PT is the transformer designed to provide the proper voltage to the measuring instruments such as voltmeters, frequency meters, wattmeters, watt-hour meters, etc., as well as protective devices such as relays, in which the secondary voltage is proportional to the primary and phase shift with respect to it an angle close to zero.

The terminals of the primary winding of a potential transformer are connected to the two lines of the system where is necessary to measure the high voltage and measuring instruments are connected in parallel to the secondary terminals. Its function is to provide an image proportional in magnitude with the same angle of tension in the power circuit connected. There are 2 types of PT's, one inductive (PT) and a capacitive type (PD).

A common practice in electrical energy distribution switchgears is the open delta connection of PT's used for measurement and protection. However, it is shown that failures occur between phases with relative ease [Magallanes Ramírez & Alba Medina, 1991]. In three-phase industrial systems, the use of this connection involves using only two PT's, so that economically there is a saving in purchasing one PT for each panel. It also requires less space to accommodate two PT's within the switchgears.




Fig. 4.1.1. Annual rate of PT's failures in petrochemical industrial plants.

The statistics regarding the incidence of failures in PT's, in some industrial plants indicate that as time passes, the number of failures in these devices increases substantially. For example, Fig. 4.1.1 shows the annual failure rate recorded in industrial plants until March 2001.

As shown in Fig. 4.1.1, the failure rate will increase. This is due to growth, sometimes excessive, of the installed capacity carried out without updating studies of the fault current levels and margins of safety switches and feeders. Also it is not considered necessary to make modifications to the grounding system. On the other hand, is a common practice in 13.8 kV to ground only one power equipment, either a generator or a transformer, so that the electrical system is exposed to surges by close-open events on switches, etc., which can be very large.

According to the records that have in some petrochemical plants, PT's that have failed, are usually located near a power source (generator or transformer), which is isolated from ground.

Therefore, considering all the above factors, it is feasible to consider the submission of PT's failures by phenomena of resonance.

4.2 Description of grounding practices that induce the presence of this problem

It is estimated that the possible cause of failure of the PT's, is due to series resonance effect caused by the open delta connection of the primary winding of the PT.




Fig. 4.2.1. Diagram of a PT in open delta connection.

The Fig. 4.2.1 shows that when a ground fault occurs, at the end of one of the feeders there is an RLC circuit formed by the resistor (R11 and R12), inductance (L11 and L12) and capacitance (C12) of the feeders. Under fault conditions the current flows through these elements, this stream may contain a component of a frequency (1 to 10 kHz) that could generate a series resonant circuit.




Fig. 4.2.2. Overvoltages registered in an industrial system due to maneuvers in the system itself.

The typical primary winding inductance of a PT is into the order of 28.5 H at 60 Hz, if the power cable would have a length of 1 m, this would present a capacitance of 1 nF. Therefore, in order to present the series resonance phenomenon requires a 990.8 Hz frequency. On the other hand, in the industrial petrochemical plants surges were detected in 5 to 7 kHz. These surges may be caused by maneuvers or system failure, see Fig. 4.2.2. Therefore, it is concluded that the open delta connection of PT's makes possible the resonance effect.

4.3 Practical example (showing photos of catastrophic effects in electrical equipment)




Fig. 4.3.1.1. Signals recorded of the feeder in the switchgear where the PT was installed.

Consider the following case, there was a failure of one of the PT's installed on the 13.8 kV level. The PT was located into a medium voltage switchgear connected to the output of a generator in an industrial petrochemical plant in Mexico. PT failure completely destroyed the switchgear that contained the PT, causing in turn the shot of the generators connected to the system and total loss of electrical power plant. As a result, the industrial petrochemical plant was out of operation for several hours, causing significant economic losses. Fig. 4.3.1 shows the damage to the PT, and Fig. 4.3.2, the damage on the switchgear.

The switchgear where PT was connected was of kind of metal-enclosed and was composed of 11 panels of 13.8 kV with a current capacity of 2,000 A. Nine of the panels were vacuum switches with their auxiliary equipment. One of the panels was used exclusively for measurement. The remaining panels, was empty because it could not be restored after the failure of one of the PT's occurred three years ago. One of the feeders of the switchgear was connected to one of the generators of the plant.

4.3.1 The process of deterioration that causes the failure of PT is slow

The industrial petrochemical plant where the TP failure occurred has a monitoring and recording system for events and variables. Fig. 4.3.1.1 shows the data of voltage, current and power recorded 20 minutes before the failure occurred.

The system logs indicate that the failure of PT began 5'30" before the three-phase fault occurred on the switchgear, see Fig. 4.3.1.2.

According to the records of power, there is an increase of active power on the order of 25% between 3:52:30 and 3:58.00. The PT had a two sections winding, each of 55 layers. Before the fault, the voltage was increased from 14.1 kV to 17.6 kV (25%). According to the transformer design, this means that one of the sections is affected at a rate of 12 seconds per layer. The initial conversion ratio was 120 and changed to 150 prior to the occurrence of the fault. That is, the transformer explosion happened after that was damaged 25% of the

primary winding. The energy stored in the internal failure of the PT was large enough to produce the explosion of the transformer and the spread of the arc.

Due to the open delta connection of PT's, it follows that the switchgear fire was started by the failure phase (between phases 2 and 3) of PT. According to the records of the fault currents, it is estimated that this event had duration of about 2 cycles (see Fig. 25). As shown in the figure, because the fault is a fault-phase, unbalanced residual current is generated through the common point of the current transformers. From the oscillograms it is concluded that the evolution of biphasic failure to three-phase fault was about 30 to 40 ms.

The electric arc between phases began in the TP that connects stages 2 and 3 of the switchgear. Subsequently, the arc evolves to cause the failure of phase 1 to generate a three-phase fault. Under these conditions, the arc length is estimated in the order of 60 cm. The arc is very unstable so a fire can easily spread through the fiberglass bulkheads separating the panels and the different switchgear cubicles.

Thus, according to the sequence of events leading to the occurrence of the fault, it is determined that the process of failure of a PT is a slow process, in the order of 5 to 10 minutes. However, the energy stored during this time causes serious consequences.




Fig. 4.3.1.2. Current signals recorded in the generator during the fault of the switchgear.

4.3.2 Design of PT

The failed PT had a capacity of 275 VA, therefore, the rated current of high voltage winding is limited to about 30 mA. To be connected in open delta, the level of its primary winding voltage is 14,400 V and the secondary winding is 120 V.

The failure of a PT can be started as a short circuit between turns or between rounds in the section of the primary winding of the transformer (see Fig. 4.3.2.1). The fault between turns can be maintained for a period of 5 to 10 minutes, until the pressure built up by the

insulation decomposition gases cause the explosion of the PT. This event causes mainly the carbonization of insulation and the generation of an arc between phases.

An inspection at the failed PT indicated some manufacturing defects. Due to the arrangement used for the construction of the windings do not have adequate penetration of the resin between layers. This produces cavities between layers and therefore high levels of partial discharges.

The arrangement of the windings of the PT is shown in Fig. 4.3.2.2. Each different sections of the primary winding is made of 31 AWG wire, whose capacity for maximum current is 0.160 A, with a resistance of 435 Ω / km. Each section consists of 55 layers and 200 turns per layer so that it has an electrical gradient of about 130 V per layer. Between each layer exists one or two layers of insulating paper impregnated with varnish. It has 3 metal screens (brass) placed in different areas, which are not only used to obtain a uniform distribution of the electric field inside the PT, but also serve as a connection between the different windings.

The secondary winding is isolated from the primary winding with a section of paper based on insulation and resin, with a cross section of about 7 mm. The secondary winding is formed with 16 AWG wire, whose current capacity is 6 A. This winding is made of two layers, the upper with 93 turns and the lower with 99. Between these layers are placed a paper based on insulation and varnish.

The core of the PT is covered with cardboard. It is estimated that this arrangement is used to absorb the mechanical stresses (expansion and contraction of materials) produced during the curing of the resin. This will reduce the possibility of fracture of the encapsulation of PT.

It was detected a manufacturing defect in the high voltage windings of PT. In the section that connects the terminal P2, shows a surplus of winding and insulating material in a way peak. That is, the coil is not parallel to the core, which causes the protruding part of the coil winding.

On the other hand, as a mechanism of protection for the PT's are generally used fuses of 2 A in the high voltage side. However, this protection is only suitable for the case of full ground faults in PT, and prevents internal short circuits in the windings of the transformer.

As noted in the records of power system switchgear the failure was caused by the fault between turns of the primary winding of the PT. The most critical condition occurred at the instant it had damaged 25% of the primary winding of the PT, in which case the maximum current that could flow through this winding would be about 45 mA. It is noted that this magnitude of current is very small, and therefore the fault cannot be detected by the fuses installed in the PT.




Fig. 4.3.2.2. Schematic design of PT.


4.3.3 Destruction of the switchgear as a result of the failure of PT

One of the causes that led the destruction of the switchgear was the materials currently used in it, which contributed to the rapid spread of fire. The switchgear was metal-enclosed type, in which the manufacturer used fiberglass spacers bonded to the separation between the phases of the switches and the separation between panels. This material (fiberglass) is

highly flammable, so that the arc fault produced by PT caused instantaneously the fire in panel separators.

The temperature produced by the arc is very high (around 10,000 - 20,000 K). Therefore it only takes a few milliseconds to melt the materials installed on switchgear. If the switchgear does not have a fire fighting system and the failure continues to be powered by the generator, the fire may spread to the rest of the panels [ABB].

Fig. 4.3.3.1 shows the relationship between arc duration and damage in different materials of the switchgear. This figure shows that from the 500 ms the damage caused by the arc can be considered catastrophic.

4.4 Solution to the problem

To avoid the resonance phenomenon in the PT's there are two alternative solutions that are mentioned below.

4.4.1 Winding wye connection of PT

To solve the problem of series resonance presented in open delta connection the PT windings can be connected in grounded wye. This connection limits the possibility of occurrence of the phenomenon of resonance, because only the parasitic capacitance of the

transformer is presented. Fig. 4.4.1.1, shows the arrangement of PT grounded wye connection. As shown in Fig. 4.4.1.1, if a fault occurs at point F in one phase, it is not possible that series resonance occur in the circuit, because one end of the primary winding of the PT is grounded.

When a failure occurs in the grounded wye connection of PT's, the fuse will act protecting the PT. It is necessary to prevent failures that may arise between phases to prevent arcing that could ignite the switchgear. It is necessary to install non-flammable separators between the panels of the switchgears to prevent fires from spreading to other panels.




Fig. 4.4.1.1. Circuit connecting a grounded wye PT.

4.4.2 Implementation of disconnector link

Another way to avoid damage in switchgears due to faulty PT's is installing disconnects under load conditions in each of the phases of the open delta, see Fig. 4.4.2.1. Since the failure process is slow it can be detected through a relay to operate as a differential voltage and sent a signal to open a disconnect. This change is easy to implement in new switchgears and requires a specific analysis for each switchgear due to the fault currents that may arise in each.




Fig. 4.4.2.1. Connection of disconnector link under load conditions in open delta PT's winding ircuit connecting a grounded wye PT.

5. Conclusion

The low resistance neutral grounding scheme at just one source of generation in industrial power systems creates favorable conditions for resonance overvoltages.

The TP's are probably the most susceptible to failure when they are operating in open delta connection, because it is feasible to generate faults between phases with relative ease.

The resonance faults occurred in specific places of the network where the concentrate parameters of capacitance and inductance are tuning at resonance frequency and not precisely the weak point of the system.

Resonance overvoltages can be avoided by the use of a proper grounding method. All energy sources, generator and transformer, must be grounded. It is necessary to consider the protection scheme and the interconnection's characteristics of the electrical power equipments to avoid failures.

Causes of Floccules Formation in Hydro-Treated Lubricating Base Oil

1. Introduction

150BS bright oil is an important kind of high viscosity lubricating base oil. Its main used field is to modulate some oils, such as gas engine oil, gear oil, compressor oil and aircraft hydraulic oil et al. The amount of thickening oil can be reduced greatly using this component. However, only a few refineries can produce this kind of product in China because of the special requirements of raw material and its high investment etc.

150BS bright oil produced by Karamay Refinery is a new series of health-friendly products. In comparison with traditional solvent-refined base oil, it has many excellent characteristics, such as high viscosity index, low volatility loss, and low aromatic content (Galiano-Roth and Page, 1994). However, the hydro-treated base oil became hazy and emerged floccules in low temperature after the high-pressure hydrogenation unit running for a period. This disadvantage seriously impact on the practical application and marketable credit of this product. Thus, it is necessary to find out the reason for the forming of floccules in KH150BS and to find an effective means to overcome this problem.

In recent years, many studies have discussed the problem of deposition emerging in base oils at low temperatures. Singh et al. (1999) pointed out the question of the three-dimensional structure of the network in gels and of the type of interactions between crystals. They discussed the changes of the morphology of the crystals under different rates of cooling. In addition, other research showed that needle-shaped crystals were formed during slow cooling under static conditions, while platelet-like crystals with amorphous solid appeared under flow conditions (Dirand et al., 1998). Srivastava et al. (1993) found that the solid-liquid and solid-solid thermally induced phase transitions occurring in petroleum waxes play a great role in deciding the appearance of waxes and the deposition of waxes as temperature decrease causes sedimentation course. Pederson et al. (1991) established a thermodynamic model for the prediction of gel formation. However, these investigations mainly focused on the morphological and thermal behavior of the crystals under cooling conditions. This study firstly analyzed the composition of floccules. Then it found the cause of floccules formation in KH150BS at low temperature from the floccules formation

mechanism and processing of KH150BS. Finally, the influence of floccules on properties of oil was investigated.

2. Experiment

2.1 Reagents and apparatus

Silica gel (60–100 mesh) was purchased from the Qingdao Chemical and Engineering Plant (Qingdao, China). The $n-C_{12}H_{26}$ to $n-C_{50}H_{102}$ n-Paraffins were all chromatographic grade, and other reagents used in this experiment were all analytical grade, including the petroleum ether, isooctane, carbon tetrachloride, urea, benzene, diethyl ether, butanone, toluene, and isopropyl alcohol. The petroleum ether was purified using percolation through the silica gel.

The analysis of the carbon number distribution of the floccules was performed on a gas chromatography (GC) 2010 (Shimadzu Company, Japan); the hydrocarbon type between the floccules and filtrated oils was analyzed by a QP5050 gas chromatography – mass spectrometry (GC-MS; Shimadzu Company, Japan); molecular weights were obtained using a K7000 Vapor Pressure Osmometer (Knauer Company, Germany); all degrees of branching were collected using a Nexus 670 infrared spectrometer (Nicolet Company, USA). For the other properties of original and filtrated oils, the apparatus are as follows: cloud point, BSQ-4D8K (Xi'an Jinghua Petrochemical Instruments Company, China); Pour point, CPP97-2 (CPP97-2 Company, France); freezing point, JH011208 (Xi'an Jinghua Petrochemical Instruments Company, Germany); Aniline point, JSH2802 (Hunan Petrochemical Instruments Company, China) Oxidation stability, SYD-0193 (Wuhan Gelaimo Company, China) Antifoam, P643 (Normalab Analis Company, France).

The hydrotreated base oil sample (KH150BS) was provided by Karamay Refinery (Xinjiang Province, P. R. China).

2.2 Experimental procedures

2.2.1 Separation of the floccules from KH150BS

To separate the floccules from the KH150BS under low viscosity conditions conveniently, a method of solvent dilution and filtration was employed at low temperature. The detailed procedures were as follows: (1) The sample was diluted with an equal mass of a solvent made of a 1:1 mixture of butanone and toluene. (2) One container of the above solution was set in each of four cryostats whose temperature was previously set at -5°C, -10°C, -15°Cand -20°C. (3) The samples were separated into filtrated residue substances and filtrates with a vacuum pump, a grit filter (G4, aperture 5µm – 6µm) and a filter flask. (4) The solvents in the filtrates were again obtained with a rotary evaporator at negative pressure and a small amount of solvent in the filtrated residues was vaporized on a water bath. Finally, the floccules and filtrated oils were obtained by a series of above procedures.

2.2.2 Separation of n-paraffins from the floccules

The urea was dried for 2 hours at 105°C and then ground. One gram of floccules was dissolved in 30 grams of petroleum ether; then a certain amount of urea and isopropyl

alcohol were added. The suspension was stirred in a round-bottomed flask for certain time at the certain temperature. After filtering with suction and washing the filter three times with 30 ml of petroleum ether, the mass was decomposed in hot water. The liberated hydrocarbon was dissolved up in 20 ml of diethyl ether, and the diethyl ether layer was separated. The evaporation of the diethyl ether and the residual petroleum ether left n-paraffins.

3. Results and discussion

3.1 Separation of floccules from KH150BS

The cloud point is the temperature at which haze was observed in the oil, and it can reflect the range of temperature when the floccules appeared. As is shown in Table 1, the pour point of KH150BS was 16°C; however, its cloud point was 12°C, and it decreased to 10°C after the floccules were separated from KH150BS at -5°C. As the experimental temperature decreased, the cloud point, pour point, and freezing point of filtrated oils obviously exhibited a decrease; the viscosity index of filtrated oils firstly decreased, but subsequently it increased to 84. The results indicate that the floccules were effectively separated from KH150BS by employing a method of solvent dilution and filtration at low temperature, and the floccules had high freezing points.

Kane et al. (2003) found that gel formation appeared for very low amounts of crystals (around 1–2%) when the oil was cooled under quiescent conditions. In such conditions, a colloidal network, which embodies the oil, is formed, and the whole dispersion becomes a gel. As shown in Table1, the lowest content of the floccules separated from KH150BS was 1.67%, and the content of the floccules exhibited an increase with a decrease in the experimental temperature. This experimental result revealed the morphology of crystals

formed in base oil during slow cooling under quiescent conditions. The common features of the morphology are the nuclei of crystals, which have the shape of discs and are a single molecule thick. The lateral extension of the nuclei depends on the crystallization conditions. Under quiescent conditions, the formation of extended, continuous lamellas is allowed, making a colloidal network, which covers the oil itself.

3.2 Analysis of the composition of the floccules

3.2.1 Average molecular weight

At lower temperature, the crystal growth depends largely on the molecular weight distribution, concentration of paraffinic component and the composition of the oil (Webber, 2001). The average molecular weights of the floccules, KH150BS and filtrated oils were firstly measured and the results were given in Table 2. From Table 2, it can be seen that the average molecular weight of the floccules was obviously higher than KH150BS and the corresponding filtrated oil, besides, the average molecular weight between the floccules and filtrated oil exhibited a decrease with a decrease of the experimental temperature. It indicate that its solubility decreased with an increase in average molecular weight of the floccules, so the floccules separated at higher experimental temperature were more difficult to dissolve in KH150BS. Webber (2001) pointed out that the hydrocarbon which had large molecular weight easily shaped crystals and deposited in the oil. Hence, it can be primarily concluded that the floccules were some hydrocarbon mixture which had larger average molecular weight and lower solubility compared with KH150BS.

3.2.2 Carbon number distribution of the floccules

3.2.2.1 Separation of n-paraffins from the floccules

The content of n-paraffins in the floccules was so low that the carbon number distribution of the floccules couldn't be directly obtained using GC. Bengen (1940) firstly found that urea had the interesting properties of forming solid complexes with straight-chain organic compounds. So the urea was selected for the separation of linear aliphatic compounds from the analogous branched and cyclic compounds by the complexes formation between urea and linear aliphatic compounds. Zimmerschied (1950) reported that formation of urea complexes was reasonably rapid at room temperature, where their stability was adequate for high recovery and convenient handling. Recovery of the components by heating or by stirring with water was practically quantitative. Hence, in this work, n-paraffins in the floccules were separated by above method and the detailed procedures were described in section 2.2.2. In addition, this work investigated the influence of each factor on the separation and the results are as follows:

a. The impact of the urea




Fig. 1. (a) The impact of urea to separation of n-paraffins.

From Figure 1 (a), it can be seen the amount of n-paraffins separated from floccules increase with amount of urea increasing. When m_{urea} : $m_{KH150BS}$ is more than 0.4, the amount of n-paraffins has no obvious change with increase of urea. The excess urea can make complexation equilibrium move to the synthesis direction, thus the m_{urea} : $m_{KH150BS}$ is determined to be 0.6 in this study.

b. The impact of activator

The activator isopropyl alcohol will affect the reaction effect. If isopropyl alcohol is less, the viscosity of reaction system will be too large, which will lead urea and sample cannot be fully engaged. Figure 1 (b) shows $m_{isopropyl \ alcohol}$: m_{urea} =0.2, which can meet the response need. So this experiment determine $m_{isopropyl \ alcohol}$: m_{urea} is 0.2.




Fig. 1. (b) The impact of activator to separation of n-paraffins.

c. The impact of reaction time

Figure 1 (c) is the relationship between the reaction time and content of n-paraffins and it shows when the reaction is 2 hours, the urea and n-paraffins has been completely complex. The content of n-paraffins has no obvious change with increasing of reaction hour after 2 hours. Therefore, it is determined the complex reaction time is 2 hours.




Fig. 1. (c) The impact of reaction time to separation of n-paraffins.

d. The impact of temperature




Fig. 1. (d) The impact of temperature to separation of n-paraffins.

The higher temperature can increase dissolving of each substance, decrease viscosity and improve the contact condition. However, the complex reaction is an exothermic reaction and lower temperature is conducive to this reaction. In addition, the higher temperature increases the stability of complexes and the content of n-alkanes will be reduced. From Figure 1 (d), it is determined the temperature was 25°C.

3.2.2.2 Analysis of carbon number distribution of the floccules by GC




Fig. 2. Carbon number distribution of n-paraffins in the Floccules.

The n-paraffins separated from the floccules at -20°C were dissolved in isooctane (0.01 g/mL), then the carbon number distribution of paraffinic molecules in the floccules was obtained by GC and the result was shown in Figure 2. Srivastava et al. (1997) found that the amount of deposition was connected with the phase-transition parameters of the wax, which in turn depended on its composition and the carbon number distribution. Wang and Dong (1995) studied the influence of carbon number distribution on the pour point of several Chinese crude oils, and the results demonstrated that if the molecular weight of hydrocarbon is heavier, then the pour point of hydrocarbon is higher. In these particular cases, there was not a defined maximum in the carbon number distribution curve, and bimodal behavior was not observed in simulated distillation chromatograms. Holder and Winkler (1965) inferred that the pour point depression for an n-paraffins binary blend begins when the concentration of the low molecular weight compound is higher than 25wt%. However, a very small amount of the heavier paraffin was required to activate the light one. Del Carmen Garcia (2000) reported that the abundance of large n-paraffins (n C24+) in paraffinic crude oils increased their tendency to the wax crystallization, which could be demonstrated by a linear correlation between the concentration of this hydrocarbon family and the crude oil cloud point. The carbon number of paraffinic molecules present in deposits was known to be higher than 15 atoms and to reach values of more than 80 carbon atoms, as reported by several authors (O'Donell, 1951; Woo et al., 1984). However, as is shown in Figure 2, the greatest atomic number of the carbon atoms of the floccules separated from KH150BS was 47. This is because KH150BS is produced using hydro processing technologies entirely. In this process, some n-paraffins with longer chains and iso-paraffins with a lower degree of branching are hydro cracked and turned into paraffins with shorter chains and a higher degree of branching. In addition, the hydrocarbon compounds with longer alkyl chains easily form crystals at ambient temperature, and they cannot form crystal line adducts with urea (Bengen, 1940). As is shown in Figure 2, the nparaffins in the floccules had longer chains, the relative abundance of n C24+ paraffins was higher, and they easily formed crystals.

3.2.3 Hydrocarbon type of the floccules, KH150BS and filtrated oils

The floccules, KH150BS and filtrated oils underwent a silica separation to yield saturates, aromatics and resins fractions through petroleum ether, benzene and ethanol washing off, respectively. Joao (1997) pointed out that the aromatic compounds didn't crystallize with paraffins nor changed their crystallization behavior. The concentration of aromatic compounds in KH150BS was approximately 5%, in order to study the hydrocarbon type of the floccules, a method similar to ASTM D2786 was employed using GC-MS to analyze the saturates in the floccules, KH150BS and filtrated oils. The data of hydrocarbon type were given in Table 3.

Table 3 shows that there were some hydrocarbon compounds including a large amount of naphthenes except for some paraffins in the floccules. The content of paraffins in the floccules was higher than which in KH150BS and filtrated oils, in particular, the content of paraffins in the floccules separated at -5°C was 18.6%, which was higher than which in KH150BS by 6.85%. However, the content of naphthenes in the flocules was lower than which in KH150BS and filtrated oils. In addition, with an increase in the content of the floccules, the concentration of paraffins in the filtrated oils slightly exhibited a decreased, for the floccules, the content of paraffins and mononaphthenes exhibited a decrease concomitant with an obvious increase in total naphthenes. This result is consistent with the report of the literature (Turner et al., 1955), namely, for the crystal formed in the 500°C+ fractionation, it is composed of some naphthenes with longer side branch and lower ring numbers except for a number of paraffins with longer chain and lower degree of branching. Maria (2000) found that there was no change in the cloud point value when the concentration of cyclo+isoparaffins was lower than 40wt%, but cloud point of crude oil was increased when their concentration was greater than 50wt%. This increment in the cloud point was believed to arise as a consequence of the higher average molecular weight introduced by these components. From Table 3, it can be seen that the lowest concentration of naphthenes in the floccules was 77.36% and it could heighten cloud point of the oil.

3.2.4 Degree of branching of saturates in the floccules

Li (1994) obtained some linear equations correlating the characteristic IR parameters to the η_{CH_2} / η_{CH_3} (1/degree of branching) using the standard n-paraffins in a proper solvent. Subsequently, he established a method for determining η_{CH_2} / η_{CH_3} of saturates in the petroleum wax by FTIR spectrometry. In this work, the above method was used to obtain η_{CH_2} / η_{CH_3} of saturates in the floccules. The results were shown in *Table 4*.

Where A_{1460} and A_{1380} is absorbency of sample in the 1460 cm⁻¹ and 1380 cm⁻¹.

From Table 4, it is observed that the degree of branching of saturates in the floccules separated at -5°C was lowest, and it increased with an increase in the content of the floccules. The results indicate that the degree of branching of hydrocarbon compound was lower, they were easier to increase wax crystallization. Ultimately, they formed deposition in the oil at low temperature.

3.2.5 Carbon type between KH150BS and filtrated oils

It was investigated that the viscosity index, pour point, oxidation stability, and other related properties of base oil depended on the composition and chemical nature of the aromatic, paraffinic, and naphthenic carbon contents (Yates et al., 1992). In this study, carbon types between KH150BS and filtrated oils were obtained using some base data of physical properties, and the method was similar to SH/T0729-2004. The results are shown in Table 5.

Table 5 shows that the C_P content of KH150BS was 64.78%, which was higher than that of filtrated oils. However, the C_N content was lower than that of filtrated oils. For the filtrated oils, the C_P content exhibited a decrease with a decrease in experimental temperature. The results confirm that the floccules are composed of paraffins with lower degrees of branching and naphthenes having longer side branches and lower ring numbers.

3.3 Causes of floccules formation in hydro-treated lubricating base oil

3.3.1 Floccules formation mechanism

In order to find the cause of floccules formation, it is important to study the floccules formation mechanism. Moussan (2004) thought at high temperatures, the crude oils containing linear paraffins behave like Newtonian liquids, the paraffins being in the molten state. Below the wax appearance temperature (WAT), which correspond to incipient crystallisation of the paraffins during cooling in static conditions, oils turning to gels. Sighn and Dirand (1999) pointed out the question of the 3D structure of the network in gels and of the type of interactions between crystals. They inferred that needle shaped crystals were formed during slow cooling under static conditions, while under flow conditions platelet like crystals with amorphous solid appear. Chanda (1998) thought the rheological behavior of a crude oil is highly influenced by its chemical composition, temperature and the current, as well as previous thermal history. High waxy crudes exhibit a non-Newtonian character, often with a yield stress at and below their pour point temperature. At a sufficiently high temperature the crude oil, although chemically very complex, is a simple Newtonian liquid. If the waxy crude oil is allowed to cool, wax will crystallize, agglomerate and entrap the oil into its structure. This phenomenon often happens if the ambient temperature of the place is below the pour point of the crude oil. In addition, two types of wax are commonly encountered in crude oils. The first is the macro crystal line wax composed of mainly straight-chain paraffins (n-alkanes) with varying chain length (about C₂₀-C₅₀). The second is the micro crystal line or amorphous waxes containing high portion of iso-parafins (cyclo alkanes) and naphthenes with a molecular weight ranges from C₃₀ to C₆₀. The presence of these solid particles causes a change in the flow behavior of crude oil from Newtonian to non-Newtonian (Rønningsen, 1991).

According to the analysis of section 2, the floccules were some hydrocarbon compounds with large average molecular weight, high paraffinic carbon content, and high freezing point. The floccules were composed of a large amount of naphthenes and some paraffins. The naphthenes had longer side branches and lower ring numbers, and the paraffins had longer chains and lower degrees of branching. During slow cooling under static conditions, these hydrocarbon compounds formed the nuclei of crystals, which had the shape of discs and were one molecule thick. Subsequently, the nuclei of crystals extended and became continuous lamellas. They formed acolloidal network and embodied the oil. Ultimately, they dispersed throughout the oil and formed the floccules.

3.3.2 The Impact of processing of KH150BS to floccules formation

KH150BS produced by the lubricating oil high-pressure hydrogenation plant which includes hydrogenation process, hydro-dewaxing and hydrogenation refining. Hydrogenation process is characterized that the hydrogenation components, aromatics, especially polycyclic aromatic hydrocarbons are saturated by hydrogenation in the hydroprocessing catalyst, the polycyclic naphthenes are open-loop and generate a single cycloalkane ring or single ring aromatics with long side chains to. The aim of this process is to increase the viscosity index of lubricating oil. The hydro-dewaxing is a new technology for lubricating oil production. The wax in oil are removed or transformed by shape-selective catalysts by hydrocracking or hydroisomerization. Its aim is to decrease the pour point of lubricating oil. The hydrogenation refining process remove the sulfur, oxygen, nitrogen and other impurities, which is to improve the stability and color of oil.

By analyzing the process of KH150BS, it can be seen that the hydro-dewaxing process has the significant relationship between floccules formation. The hydrodewaxing process, the key factor is to choose an ideal catalyst. This catalyst should have good selectivity, which is able to make paraffins with high melting point (n-paraffin hydrocarbons and isoparaffins with less side-chain) cracking into low molecular weight alkanes, or change paraffins with high melting point to the paraffin hydrocarbon with low melting point by isomerization. Finally, the freezing point of lubricating oil is decreased and the ideal lubricant component is not destroyed in order to ensure a high oil yield. The catalyst used in KH150BS hydrodewaxing stage used is RDW-1 catalyst developed by Research Institute of Petroleum in China. It is a dual function of ZSM-5 zeolite loaded Ni catalyst. The Ni catalytic is used to hydrogenation and dehydrogenation, but the role of ZSM-5 zeolite is to provide a acid site and the shape-selective function.

The selectivity of zeolite is that zeolite separates the molecules of different sizes and shape by its effective diameter. In the mixed raw materials, only the molecules whose diameter are smaller than the aperture of zeolite can enter the zeolite pore channels within the active site and participate in the reaction as a reactant, and the molecules whose diameter are larger than the aperture of zeolite will be excluded from the zeolite pore and cannot participate the reaction.

The floccules are some hydrocarbons with large molecular weight and low degree of branching. This may be due to pore of catalyst become more and more narrow in the end of hydrogenation catalysts, some naphthenic isoparaffin and long-chain alkyl with large molecular weight cannot enter the pore of cracking catalyst and participate in the reaction, which cause the oil was observed hazy and emerged floccules at low temperatures.

3.4 The Influence of floccules on properties of lubricating oils

In order to investigate the influence of floccules on properties of oils, the properties of KH150BS and filtrated oils were shown in Table 6. It shows that, after floccules was removed using the low-temperature leaching method, the cloud point, pour point and freezing point of KH150BS obviously decreased. For other properties, compared with KH150BS, the viscosity and viscosity index of filtrated oils decreased, which is due to removal of floccules with long-chain. The aniline point of the filtrated oils slightly decreased compared with KH150BS. The aniline point is determined by hydrocarbons type and

chemical composition of oils. In general, for different hydrocarbons with the same number of carbon atoms, aromatic is lowest and alkanes is highest. From Table 5, it can be seen that percentage content of aromatic carbon atoms in the filtrated oils are higher than which in KH150BS, which led the aniline point of the filtrated oils decreased. As the floccules are mainly some hydrocarbons with the longer carbon chain, the lower the degree of branching and they are easily be oxidized. Thus, the oxidation stabilities of the filtrated oils are higher than KH150BS. After removing floccules, the antifoams of filtrated oils have no obvious change except for at 24°C. The antifoams of filtrated oils after removing floccules at -5°C and -15°C became 15 ml and 25 ml at 24°C. This is because the viscosity of KH150BS is higher than filtrated oils. The viscosity is higher, the bubble floating is slower and it is more difficult to break. Thus, the antifoams of filtrated oils are better than KH150BS.

4. Conclusions

In this study, firstly, the floccules were effectively separated from KH150BS base oil and the composition and structure of the floccules were investigated in detail. Then the formation cause of floccules was analyzed from floccules formation mechanism and processing of KH150BS base oil respectively. Finally, the properties of KH150BS and the lubricating oils after removing floccules were investigated. The results indicate that the floccules were some hydrocarbon compounds with large average molecular weight, high paraffinic carbon content, and high freezing point. They were composed of a large amount of naphthenes and some paraffins. The naphthenes had longer side branches and lower ring numbers, and the paraffins had longer chains and lower degrees of branching. This may be due to the pore of catalyst become more and more in the end of hydrogenation catalysts, some naphthenic isoparaffin and long-chain alkyl with large molecular weight cannot enter the pore of cracking catalyst and participate in the reaction, which cause the oil was observed hazy and emerged floccules at low temperatures. During slow cooling under static conditions, these hydrocarbon compounds formed the nuclei of crystals, which had the shape of discs and were one molecule thick. Subsequently, the nuclei of crystals extended and became

continuous lamellas. They formed a colloidal network and embodied the oil. Ultimately, they dispersed throughout the oil and formed the floccules. In addition, compared with KH150BS, the properties of the lubricating oils after removing floccules basically became better.

Analysis of the Seismic Risk of Major-Hazard Industrial Plants and Applicability of Innovative Seismic Protection Systems

1. Introduction




Fig. 1. (a) Areal view of a refinery, (b) Damage in a process furnace (Izmit, 1999).

Industrial plants are complex systems and it is such a complexity, due to numerous connections, equipment and components, together with the complexity of their operations that makes them particularly vulnerable (local vulnerability) to earthquakes (see Figure 1a).

Activities carried out in process plants can also be arranged in series, which means that process activities are realized with specific sequence and boundary conditions. Consequently, the "failure" of a single element can get out of order the entire system. This is of fundamental importance for the seismic vulnerability of a plant (general vulnerability).

Seismic action can cause serious accidents to industrial plants as shown in several occasions. The actual worldwide situation of major-hazard plants against earthquakes should be considered as critical. For instance, in Italy about 30% of industrial plants with major-accident hazards are located in areas with a high seismic risk. In addition, in case of a seismic event, the earthquake can induce the simultaneous damage of different apparatus, whose effects can be amplified because of the failure of safety systems or the simultaneous generation of multiple accidental chains.

A representative example is certainly the Izmit Earthquake in Turkey (Erdik and Durukal, 2000), which induced severe damages to Tupras refinery (area of the plant, farm tanks, and landing place). An example of domino effect caused by a structural collapse was the breakdown of a concrete chimney that caused a big release of dangerous substances and damages to surrounding equipment (see Figure 1b).

In a plant, an earthquake can cause many dead as consequence of components collapses, similarly to what happens to buildings; moreover, the consequences deriving from a seismic event, such as economic losses for interruption of the production, environmental damages due to releases of dangerous substances, damages to persons due to explosions, fires and release of toxic substances, have also to be taken into account. Therefore, the usual safety requirements applied to civil buildings for ultimate and serviceability limit states, together with the consequences of exceptional actions, are generally unsuitable for structures belonging to industrial plants. As a matter of fact, a critical damage for a process safety that can cause even a modest release of inflammable substances, such as a flange opening or a welding breaking, can result unessential under structural point of view, but, at the same time, might cause considerable accidental chains. Consequently, for process industry it is necessary to associate the indirect consequences caused by possible accidents (i.e. a seismic event) to the direct structural damages.

During the last years, in order to increase safety against earthquakes, passive control techniques (PCT) have been developed, which are based on the concept of reducing the seismic action instead of increasing the strength (Housner et al., 1997). These techniques that for civil constructions are nowadays considered a consolidated alternative design tool, can also be used for seismic protection of industrial structures.

Unfortunately a very limited number of applications to industrial plants components have been realized. For this reason, in the present chapter the applicability of such a technique is investigated, aiming at providing general applicability criteria. An example of base isolation of a steel storage tank is also presented, whose effectiveness is investigated by a wide numerical and experimental activity.

2. Structural classification and seismic behavior of oil refinery components

A schematic representation of a refinery is shown in Figure 1(Moulein & Makkee, 1987). The raw material arrives in the refinery by different ways (by train, ship, pipelines, etc..), depending on the location, and then it is stored in big tanks.

The main operation in a refinery is the distillation of raw material in columns, named "topping", that divide the crude oil in a certain number of fractions (5-7) distinguished in 1) light fraction (gasoline and light components), 2) intermediated fraction (Kerosene and light oils) and 3) heavy fraction (residual oils). All these fractions are processed further in other refining units to obtain specific products. For example the heavy fraction is subjected to a specific "thermal cracking" or "Visbreaking" treatment to obtain a certain quantity of more refined material.






Fig. 2. (a) Schematic representation of an oil refinery, (b) Main components of a refinery.

The equipment deputed to these operations are indicated in Figure 2. In particular; (A) tanks for the storage of raw and refined materials, (B) process equipment for the chemical treatment of crude oil and waste material, (C) piping systems for the transferring of the

material and (D) flares, used to eliminate waste gas. For a detailed description of the operation of each component that is beyond the aim of this chapter, the reader can refer to specialized publications (Mayers, 2004).

During a transformation processes many dangerous substances are treated. Consequently, a refinery is equipped with numerous safety systems, some of which imposed by the codes and other adopted by designers. It is worth to highlight that during a seismic event they could fail, becoming useless. Therefore the seismic protection of a refinery must be mainly based on the reduction of the seismic risk of single components.

The experience derived from observing damages caused to industrial plants by past earthquakes can be very useful to identify the most exposed components to the seismic risk and the evaluation of the consequences. Despite the difficulties of obtaining and organizing data, detailed information on the behavior of the refineries in a certain number of earthquakes are available, in particular those listed in Table 1 (Kawasumi, 1968; Nilsen &

Kiremidijian, 1986; Scholl & Thiel, 1986; ATC-25, 1991; Showalter and Myers 1992; Beavers et al., 1993; Erdik & Durukal, 2000; Steinberg et al., 2000; Johnson et al., 2000; Suzuki, 2002; Kilic & Soren, 2003; Sezen & Whittaker, 2004; Hatayama 2008; Suzuki, 2006)

Based on this information, in the following, the main apparatus of process industrial plants are grouped into a restricted number of structural classes and the main observed damages caused by earthquakes are analyzed in detail.

2.1 Slim vessels

Cylindrical vessels with a high ratio height/diameter (between 5 and 30, and even higher) belong to this category. Among them, on the basis of the operation and the system of constraints to which they are subjected, it is possible to identify:

- Vertical cylindrical vessels which are directly anchored to foundations and free along
 the height. This category includes the distillation columns and many other reactors. The
 distribution of the mass along the height is usually rather uniform and it may be
 considered as continuous, even though some internal discontinuities could be present.
- Vertical cylindrical vessels which present additional constraints, besides at their basis, also along the height. This group includes very thin columns such as stacks and flares.
 Their mass is entirely due to the structure, because they contain just atmospheric pressure gas.
- Horizontal cylindrical vessels, supported by two or more saddles connected to a foundation platform. In this category many pressurized storage tanks and shell-andtube heat exchangers are included.

As far as vertical slim vessels are concerned, the most common damages in case of seismic event are the failure at the foundation, due to the excessive stress, and the loss of contained fluids because of failure of connected flanges, due to excessive relative displacements. For example, during the *Loma Prieta* earthquake a refinery was seriously damaged, where the most important effect was on the anchor bolts of about 20 vertical vessels, on a total of 50 vessels. During the *Valparaiso* earthquake in a ventilation-stack with diameter 18" the anchor bolts were subjected to a similar damage, with the yielding of bolts.

The Izmit earthquake induced serious damages in the Tupras refinery. An entire unit was destroyed by the collapse of a chimney of a furnace 105 m high (Figure 3a). The top of the chimney collapsed on the furnace, whereas the bottom part collapsed on a pipe system. Even if the furnace was designed according to ACI-307, it has been subjected to an important damage.

2.2 Above-ground squat equipment

These apparatus have similar dimensions in the principal directions and are characterized by heavy masses; they can be grouped in two main categories:

Large cylindrical steel storage tanks with a height/diameter ratio between 0.2 and 2.
The roof can be welded to the shell (fixed conic roof) or floating over the contained liquid. The operating volume varies from some tens to 200000 m³. The bottom plate is circular and placed directly on a granular backfill. When they are full filled, part of the

mass oscillates under the seismic excitation producing high forces on the tank wall, whereas the remaining part induce a sloshing wave that might produce overtopping phenomena.

 Large process equipment like filters and decanters, or dynamic apparatus like pumps and compressors. They have large masses and are placed directly on high inertial foundations because of the dynamic action produced during the operating conditions.




Fig. 3. (a) Collapse of a chimney at Tupras Refinery, (Itzmit, 1999), (b) Damages to tanks with floating roof (Tokachi-oki, 2003), (c) Elephant foot buckling (Anchorage, Alaska, 1964), (d) Elastic diamond buckling (San Fernando, California, 1971), (e) Collapse of an electric transformer, (f) Overtopping phenomenon in a big tank (Itzmit, 1999).

The typical damages associated to the first category are related to buckling phenomena of the wall (elephant foot buckling, sloshing buckling) or to failure of the wall-bottom plate joint. In Figure 3c and 3d examples of elephant buckling and elastic buckling are shown,

respectively. But other possible damages are also possible, especially due to excessive sloshing motion, even in presence of floating roof, which can cause liquid overtopping and fire due to the crash between roof and wall. As a matter of fact, during the Itzmit and Tokachi-oki earthquakes, most of the tanks were destroyed for excessive sloshing motion (Figure 3b and 3f). Moreover, damages due to the uplift phenomenon of above ground tanks or ground settlements have been also observed during several seismic events, which have been capable to produce serious localized damage between wall and bottom plate.

2.3 Squat equipment supported by columns

In this category it can be included:

- Spherical storage vessels, essentially used for pressure liquefied gases. They are generally elevated with respect to ground by using steel columns placed along the circumference and welded to the shell at the equatorial level and normally linked eachother by diagonal braces (see Figure 4c).
- Vertical large storage vessels for cryogenic liquefied gas (LNG); their configuration is similar to that of the large atmospheric storage vessels for liquids, but their walls are realized by a double shell, in the inner-space of which an efficient thermal insulation is located; their bottom is anchored to a concrete plate, supported by short reinforced concrete columns (Figure 4a).
- Process furnaces and steam boilers. These equipments have the function to heat or vaporize large amounts of liquid products, according to the chemical process demand. Generally process furnaces are large structures, with few standardized shapes, mainly of cathedral type and vertical cylinder (Figure 4b). These furnaces are kept elevated from the ground by means of short reinforced concrete columns, according to the location of burners that requires pipes and space for maintenance. For these apparatus, the collapse is mainly due to the soft-story phenomenon caused by the shear failure of the short columns. The collapse of chimneys is also possible, as well as the detachment of pipes and of the internal wayward covering.

During the Kern Kounty earthquake (California, 1952), at the Paloma Cycling Plant, two of the five spheres of butane collapsed, causing the cut of all the connecting pipes and creating a massive release of the content. The cloud formed quickly found a source of ignition in electrical transformers places a few hundred meters away. The result was a violent VCE (Vapor Cloud Explosion) followed by a fire of considerable proportions, see Figure 5a.

During the Itzmit earthquake some LNG tanks sustained by reinforced concrete columns were subject to important damages followed by the collapse of the basement, due to the insufficient shear strength of the columns (Figure 5b) (Sezen et al., 2007)

2.4 Piping systems

Piping systems connect all equipment involved in the process, transferring fluids within the plant (Figure 6a); as mentioned before, in a large refinery, hundreds kilometers of pipes of different size are installed; they are mainly realized with steel, but in some cases also with ceramics, glass, concrete, etc., if a specific performance against corrosion is required.

Metallic pipes themselves are not particularly vulnerable to seismic actions, but they can suffer the effects of differential displacements, which could not be compatible with the pipe deformations. Moreover, a collapse of the support structure can cause a catastrophic collapse of pipes, as shown in Figure 6b where the breakage of a piping flanged connection is shown.

2.5 Support structures

Piping systems, heaters, pumps, fans and other equipment, require a support structure. The geometrical configuration depends on different factors; consequently, they present different structures with irregular distribution of stiffness and strength. In addition, the structure is often modified according to the production requirements that can be necessary during the life-cycle of the plant. The support structures are mainly realized with steel frames, often stiffened by diagonal bracings. Nevertheless, structures realized with a different material are not rare, especially reinforced concrete and steel-concrete composite structures.

In the several reports dedicated to seismic effects in industrial plants, description of damages suffered by support structures are rare. During the Loma Prieta earthquake service frames of a reactor were subjected to limited damages. On the contrary, the support frame of a group of fans was subjected to severe damage as shown in Figure 7a. The structure was initially designed to support a piping system, but later was used for supporting the fans. Consequently, during the seismic event some of the beams collapsed for elastic instability.

Finally, collapse of the entire supporting structure due to the failure of the surrounding structures cannot be excluded. For example during the Itzmit earthquake in 1999 the chimney of Fig. 3a fallen down on a piping system causing important damages (Figure 7b)

3. Applicability of passive control systems for the seismic protection of oil refinery components

3.1 Passive control techniques (PCT) for the seismic protection of industrial components

Innovative seismic control systems belongs to the world of the vibration control techniques of structures, which includes passive, semi-active, active and hybrid systems (Housner et al., 1997; Spencer, 2003; Christopoulos and Filiatrault, 2007). The experiences acquired during experimental activities and worldwide applications have indicated the passive control techniques as the most suitable solutions for the seismic protection of structures. These systems modify the stiffness and/or the dissipative properties of the structure, favoring the reduction of the dynamic response to seismic actions. They can be classified on the basis of

the physical phenomenon adopted, and specifically: a) Seismic isolation, b) Energy dissipation, c) Tuned mass damper (TMD).




Fig. 8. PCS: a) base isolation, b) dissipative bracings, c) dissipative coupling, d) Tuned mass.

Base isolation systems produce a certain level of uncoupling between structure and ground. At this end, devices named "isolators" are usually placed at the foundation. Consequently, the structure is divided in two distinct parts: substructure and superstructure (Figure 8a); these devices are characterized by a high deformability in the horizontal direction and, at the same time, they are capable to transmit the vertical forces without appreciable deformations

Isolators modify the dynamic characteristics of the structure, obtaining a high reduction of inertia forces. Unfortunately, there is a price to be paid: an appreciable increasing of displacements between substructure and superstructure. This inconvenient can be limited by increasing the energy dissipation capability of the structure using external dissipation devices or by a specific dissipative mechanism included in the isolators.

The isolation systems are usually subdivided in two categories: a) conventional devices, characterized by an elastic behavior, which realizes the elongation of the fundamental period of the structure, b) dissipative isolators, which in addition to the period elongation effect, increase the dissipation capability of the devices.

Dissipation control systems realize an artificial increasing of the structural damping with a consequent reduction of structural forces and displacements. Energy dissipation devices can be placed within the same structure through dissipative bracings (Figure 8b (Ciampi et al, 1995; Renzi et al., 2007), or between adjacent structures (dissipative coupling, Figure 8c) with different dynamic characteristics (Basili et al., 2007a, 2007b; Fraraccio et al., 2006).

Finally, using mass damping systems, namely TMD (Tuned Mass Dampers), the control of the seismic vibrations is carried out by adding auxiliary masses connected to the structure (conventional TMD). The additional damping is due to the transfer of energy form the structure to the auxiliary mass; this energy is then dissipated through dissipative devices placed between the structure and the auxiliary mass (Hoang et al., 2008). A non conventional TMD can also be defined: masses already present on the structure are converted into tuned masses, retaining structural or architectural functions beyond the mere control function (De Angelis et al, 2001).






Fig. 9. a) Cathedral furnace where the seismic isolation can be easily applied, b) Distillation column and adjacent steel frame in which is possible to realize: dissipative bracings in the steel frame, dissipative coupling between column and frame, and Tuned Mass Damper, linking the equipment placed at several levels of the frame with the same frame using proper isolators.

The above techniques cannot be indifferently applied to each type of equipment of a plant, because their effectiveness depends on the characteristics of the structure to be protected. As a matter of fact, for a cathedral-type furnace (Figure 9a) the seismic isolation can be profitably used by inserting isolators between the superstructure and the base columns.

A typical situation to which the techniques of Figure b, c and d can be easily applied is shown in Figure 9b. In fact, dissipative bracings can highly reduce the seismic response of the steel frame. Alternatively, the equipment placed at the several floors of the frame can be used as TMDs connecting them to the frame using dampers. Moreover, being distillation column and frame adjacent structures, they can be coupled using dissipative devices (Paolacci et al., 2009; Paolacci et al., 2010)

Until now, passive control techniques have been used for a very limited number of industrial applications; for example, in Europe the isolation technique has been adopted only in a few cases: the seismic protection of Petrochemical LNG terminal of Revythousa, Greece (Tajirian, 1998) and of ammoniac tanks, at Visp, in Switzerland by means of elastomeric isolators (Marioni, 1998), Figure 20. Friction Pendulm devices have also been used for the seismic isolation of an elevated steel storage tank of the petrochemical plant of Priolo Gargallo in Sicily (Italy) (Santangelo et al., 2007).

It is worth to observe that damages like leakage of a flanged joint or breakage of a welding, usually considered critical for the safety of the transformation process, are instead treated as unessential under structural point of view, even if might generate important accidental chains. Therefore, for the process industry, unlike civil structures, it is necessary to associate the direct damage inflicted by the earthquake, with the indirect consequences of possible incidental chains.

The experience provided by the observation of seismic damages suffered by industrial plants allows recognizing the most vulnerable components. Assuming that one of these components is damaged and considering this as an initiator event, using a classic analysis of "event tree", the risk of the various consequences could be assessed.

The first step is then to identify the most likely initiator events of accidental chains that can lead to serious consequences. Table 2 summarizes the typical observed damage and accidents due to earthquakes of some major industrial equipment together with the suggested passive techniques for their seismic protection. For slim vessels, the most likely damage in case of earthquake is the yielding of anchorage bars at the foundation level and the leakage of fluid due to failure of flanged joints caused by excessive displacements. In this case, the most appropriate passive control technique seems to be the dissipative coupling between vessel and adjacent structures (Ciampi et al., 2006). As far as above ground broad tanks is concerned, typical observed damages (failure of wall-bottom plate welding, elephant foot buckling, elastic buckling of wall, settlements of the ground under the tank) can be eliminated using base isolation technique (De Angelis et al., 2010). Other accidents and possible damages due to sloshing motion in presence of floating roof (overtopping, fire due to impact between the roof and mantle), are neither amplified nor reduced by the isolation. A possible solution to reduce the effects of the impact between floating roof and tank wall can be represented by spacers placed between roof and wall or by inserting a TMD system into the roof (for eg. a Tuned Mass Damper Column, (Sakai and Inoue, 2008).




Fig. 10. a) Base isolation of a LNG tank at Revythousa Island (Grecee), b) Base isolation of an elevated tank ammoniac tanks at Visp, Switzerland, c) Dissipative bracings solution for elevated tanks, d) dissipative coupling solution for elevated tanks.

For squat equipment placed on short columns the base isolation technique appears to be highly effective. The unique drawback is represented by the increasing of relative displacement between the apparatus and the surrounding ones. For this reason proper counter-measures have to be adopted to preserve the integrity of the connected pipes, for example flexible joints.

The use of dissipative bracings can be effective (Figure 10c) (Drosos et al., 2005). These devices reduce stresses and displacements, but can be invasive and limit the operation of the equipment. In some cases, like spherical tanks, the dissipative coupling can also be used in conjunction with auxiliary reaction structures (Figure 10d) (Addessi et al., 2001).

For process furnaces, beyond the base isolation technique, a sophisticated solution may consist in designing the chimney as a TMD system, adding an auxiliary mass at the top (Balendra et al., 1995).

Finally supporting frames can be effectively protected by several control techniques. For example, to reduce forces and displacements, dissipative bracings and dissipative coupling techniques can be profitably used, as for the slim vessels. To avoid damage in the supported equipment (compressors, pumps, tanks, etc..), the TMD technique can also be adopted. In this case, it is possible to reduce the stress level in the frame and contemporarily to protect

the equipment used as TMD. In this case, special dampers like wire-ropes could be profitably used (Paolacci and Giannini 2008).

The innovative technologies for the vibration control are also effective to preserve integrity and operational continuity of equipment.

An effective way to protect seismic vulnerable equipment consists in implementing an isolation system between the internal apparatus and the supporting structure. There are two configurations proposed in literature: the apparatus to be isolated may correspond either to an individual raised floor (Hamidi and El Naggar, 2007), on which a group of several equipment is anchored (isolated raised-floor systems or floor isolation systems, (Alhan and Gavin, 2005), or to a single equipment itself (equipment isolation systems), especially when having a large mass (De Angelis et al., 2011). As a result, the absolute accelerations transmitted to equipment are considerably reduced and the damages due to excessive inertial forces are prevented.

Passive linear and nonlinear isolation systems have been proved to be effective and practical to protect acceleration sensitive equipment from earthquake hazard [Reggio and De Angelis, 2011].

4. Example: Application of two isolation systems for the seismic protection of above-ground steel storage tanks

4.1 Introduction

In this section, the effectiveness of the base isolation on steel storage tanks is investigated through numerical models and then checked by shaking table tests on a reduced scale (1:14) physical model of a real steel tank (diameter 55m, height 15.6 m), typically used in petrochemical plants. In the experimental campaign the floating roof has also been taken into account.

In practice, in order to evaluate the effect of the sloshing, many seismic design codes adopt the formula relative to free surface conditions, (European Committee for Standardization, 2003; American Petroleum Institute 2007). This is justified by theoretical studies (Sakai and Nashimura, 1984), where is shown that the effect of the floating roof has a negligible influence on the frequency and amplitude of the first vibration mode and it is confirmed by the experimental study presented in the following.

The tests have been carried out using the six d.o.f. 4 x 4 m shaking table installed in the laboratory of ENEA (Italian National Agency for New Technologies, Energy and the Environment) Research Centre "La Casaccia" at Rome, Italy. The tests have been performed on the physical model both in fixed and isolated base configurations; in particular two alternative base isolation systems have been used: high damping rubber bearings devices (HDRB) and PTFE-steel sliding isolation devices with c-shaped elasto-plastic dampers (SIEPD).

In the following, after a brief presentation of the dynamic behavior of tanks, with and without base isolation systems, the main results of the experimental tests are shown and discussed. Finally, a comparison between experimental and numerical results has been illustrated. A detailed description of the experimental campaign can be found in (De Angelis et al. 2010).

4.2 Dynamics of liquid storage tanks

4.2.1 Fixed base tanks

The dynamics of cylindrical tanks subjected to a base motion has been extensively studied by several authors. Starting from the earliest work of Housner (1963), the hydrodynamic pressure induced by the liquid on the tank wall due to the base motion has been determined, taking into account the deformability of the tank wall; see for example (Fisher, 1979; Haroun & Housner, 1981; Velestos & Tang 1987).

In brief, the liquid mass can be imagined subdivided in two parts: an impulsive component, which follows the base motion and the deformability of the tank wall, and a convective component, whose oscillations cause superficial wave of different frequency with a very low percentage of mass (\approx 4%) relative to the higher modes; moreover, while in the slender tanks the most part of the liquid moves rigidly with the tank, in the broad tanks most of mass oscillates in the convective modes.

Under the hypothesis of rigid tank, the impulsive and convective part of hydrodynamic pressure can be easily evaluated. On the contrary, the part, which depends on the deformability of the tank wall, can be determined solving a fluid-structure interaction problem, whose solution depends on the geometrical and mechanical characteristics of the tank: radius R, liquid level H, thickness s, liquid density ρ and elastic modulus of steel E. The problem can be uncoupled in infinite vibration modes, but only few of them have a significant mass. Thus, the impulsive mass is distributed among the first vibration modes of the wall.




Fig. 11. (a) Equivalent spring-mass model: (a) general, (b) broad tanks (c) Dynamic model of a base isolated broad tank.

On the basis of the above observations it can be drawn that the study of the hydrodynamic pressure in tanks subjected to a seismic base motion can be easily performed using the simple model shown in Figure 11, in which the liquid mass is lumped and subdivided in three components: rigid, impulsive and convective masses named m_i , m_{ik} (mass of k-th mode of the wall vibrations), m_{ck} (mass of k-th convective mode). The impulsive and

convective masses are connected to the tank wall by springs of stiffness k_{ik} and k_{ck} . The total pressure is given by adding the effects of the mass mi subjected to the base motion acceleration, of the masses m_{ik} subjected to the acceleration of the wall relative to the bottom of the thank, and of the masses m_{ck} subjected to the absolute acceleration.

In case of broad tanks the model of Figure 11(a) can be updated by the simplest model shown in Figure 11(b). In fact, the contribution of the higher order vibration modes is negligible and the entire impulsive mass is practically equal to the mass of the first vibration mode; moreover, because the distributions of the impulsive pressure, with and without wall deformability, are almost coincident, the effects of the impulsive action are simply taken into account by the response in terms of absolute acceleration of a simple oscillator of mass m_i and stiffness k_i . Neglecting the higher convective modes effect, the model becomes a simple two degrees of freedom model. The frequencies of the convective and impulsive modes are generally very different (tenths of a second against tens of seconds). This justifies the usual choice of neglecting the interaction between these two phenomena.

4.2.2 Base isolated tanks

As shown in section 2, the idea of seismic protection of tanks through base isolation technique is not really new, but the important amount of numerical investigation present in literature has proved its high effectiveness. Unfortunately, a limited number of experimental activity has been performed so far (Bergamo et al., 2007; Summers et al., 2004; Calugaru and Mahin, 2009).

On the basis of the observations of the previous section a dynamic model of a base isolated tank can be easily built. For example a simple model of base isolated broad thanks is shown in Figure 11(c).

The vibration period of the impulsive component of pressure generally falls in the maximum amplification field of the response spectrum, whereas the convective period T_c is usually very high and thus associated with a low amplification factor. This implies a high effectiveness of the base isolation system, which can reduce highly the base shear due to the impulsive pressure component. Neglecting the influence of the wall deformation, the period of the isolated structure is approximately given by:

$$T_{iso} \approx 2\pi \sqrt{\frac{m_i + M_s + M_b}{k_{iso}}} \tag{1}$$

in which m_i is the impulsive part of the liquid mass, M_s and M_b are respectively the wall and base tank masses, and k_{iso} is the elastic stiffness of the isolators.

For broad tanks m_i is a relatively small part of the total mass and this allows a significant reduction of the devices dimensions.


Moreover, in the case of big tanks, for which $T_c >> T_{iso}$, the first period of the convective motion is practically unmodified. Consequently, the base isolation system does not show any important mitigation effects on the sloshing pressures. This is not relevant, since the convective pressure is very small because of the long period of the fluid oscillations.

The negative effect of the sloshing is related only to the superficial motion, because either the height of the wave can exceed the upper limit, causing overtopping phenomenon, or the floating roof motion could cause a breaking of the gaskets and the leakage of dangerous vapours of inflammable substances. Unfortunately, the base isolation does not modify this phenomenon. Moreover, the base isolation can cause high displacements between tank and ground, which may induce dangerous damage to the pipes-tank connections.

4.3 Shaking table tests

4.3.1 Description of the physical model




Fig. 12. (a) Tank without floating-roof, (b) Floating roof installed on the mock-up.

The full scale structure is a big steel liquid storage tank typically installed in petrochemical plants. The dimensional characteristics of the tank are the following: radius R=27.5m, height Hs=15.60 m, liquid level H=13.7 m, liquid density ρ =900 kg/m3, and wall thickness variable from 17 to 33 mm. The scale model has radius R=2 m, height Hs=1.45 m and wall thickness s=1 mm (Figure 12a). Thus, the scale ratio is about 13.7.

Because the period of the sloshing mode is a function of the square root of the dimensions (European Committee for Standardization, 2003), the time scale of the convective motion is 3.7. In order to obtain the same scale ratio for the impulsive frequencies it would be necessary to reduce the thickness of 140 times with respect to the real one. This is obviously impossible and only one time scale can be respected. In particular, the convective motion scale has been adopted during the test (De Angelis et al., 2010).

The floating roof of the full scale tank is realized through a truss structure, which sustains steel plates. In order to maintain the mass ratio, the floating roof of the mock-up has been realized with a wood structure (Figure 12b). The gasket, which in the full scale tank is composed by a more complex mechanism, has been here realized with a rubber tube applied along the circumference of the roof.

4.3.2 Design of base isolation systems

For the seismic protection of the tank two isolation systems has been used: high damping rubber bearings (HDRB) and PTFE-steel isolation devices with metallic c-shaped dampers (MD). Both the base isolation systems have been designed by choosing a properly isolation period (T_{iso}) and then evaluating the stiffness k_{iso} using the equation (1). For the high damping rubber bearings the damping ratio ξ has been assumed equal to 10% whereas the yielding force of the metallic dampers has been designed using the method proposed by (Ciampi et al., 2003).




Fig. 13. (a) Sliding bearing with dissipative damper, (b) High Damping Rubber Bearing.

The prototypes of the isolator devices, properly realized for the experimental activity by the Company Alga Spa (Milan), are shown in Figure 13a and 13b. The isolators have been characterized by cyclic imposed displacement tests carried out in the experimental laboratory of the University of Roma Tre. The main characteristics of the devices are summarized in Table 3.

In order to check the effectiveness of the control systems, for each isolator typology four devices have been used, which have been placed at the cross of the bottom metallic beams.

4.3.3 Test set-up

A series of dynamic tests have been carried out on the tank using the shaking table installed at the Research Center of ENEA "La Casaccia" (Rome). The mock-up has been tested in four different configurations: fixed base tank without floating roof (case A), fixed base tank with floating roof (case B), isolated tank with HDRB and floating roof (case C), isolated base tank with SIEPD devices and floating roof (case D).

Six different base motion histories have been used in each configuration (four natural and two synthetic accelerograms, generated by Simqke (Vanmarcke and Gasparini, 1976), according to

the European code spectra (soil C), and scaled to different intensity levels). For all accelerograms the time scale has been changed according to the indications of section 3.1. The natural accelerograms have been selected from the Pacific Earthquake Engineering Research center database, between time histories recorded for soil C and generated by seismic events with magnitude lower than 8 and epicenter distance lower than 50 km. Another more selective criterion, adopted here, consists of a selection of signals filtered using a high-pass filter with cut-off frequency greater than 0.1 Hz. As already seen, this is almost the frequency of the sloshing motion of the full scale tank. The records used during the tests are reported in Table 4. The tank has been also tested using white-noise and harmonic signals with variable frequency (sine-sweep) for the identification of its dynamic characteristics.

The response signals were measured using numerous sensors: pressure transducers, strain-gauges and laser transducers placed on the tank wall. Laser transducers have also been used for the sloshing motion of the liquid or floating roof, whereas the motion of the table has been monitored by several accelerometers. In the isolated base configurations the motion of the structure with respect to the base has been measured by wire LVDT sensors. The arrangement of the sensors has changed between the several series of tests.




Fig. 14. Experimental Set- up.

The response signals were measured using numerous sensors: pressure transducers, strain-gauges and laser transducers placed on the tank wall. Laser transducers have also been used for the sloshing motion of the liquid or floating roof, whereas the motion of the table has been monitored by several accelerometers. In the isolated base configurations the motion of the structure with respect to the base has been measured by wire LVDT sensors. The arrangement of the sensors has changed between the several series of tests. In Figure 14 a sketch of the main sensors used in the isolated base configuration is shown.

4.3.4 Analysis of results

4.3.4.1 Identification of dynamic characteristics

Before evaluating the seismic effects, the main dynamic characteristics of the tank (frequencies and damping) have been identified. The frequencies of the systems have been determined by means of the transfer functions between the input (base acceleration) and output signals (e.g. liquid pressure). The damping ratio has been evaluated using the logarithmic decrement method applied to free vibrations time histories. For each vibration mode, the signal has been filtered using a pass-band filter around its frequency.




Fig. 15. Transfer functions: (a) pressure transducer, case A, White Noise, (b) pressure transducer, case B, White Noise, (c) LVDT, case C, ARC090.

In Figure 15 the transfer functions between the table acceleration and one of the pressure sensors (near the bottom of the tank) are shown for the fixed base configurations (A and B), without (Figure 15a) and with floating roof (Figure 15b). For both cases, the frequency of the sloshing motion does not change and is almost coincident with the theoretical value (0.4 Hz), whereas a resonant frequency of around 18 Hz is also shown, which correspond to the main natural frequency of the motion due to the deformability of the wall.

The damping of the sloshing motion has been measured on the basis of the amplitude decrement of free vibrations. In case of free liquid surface the damping is very low and is not in practice measurable; using the floating roof a 1% of damping has been identified. This value, greater than 0.5%, usually adopted in numerical model, is probably due to the interaction between the liquid surface and the floating roof and the friction between rubber gasket and tank wall-

The free vibrations of the floating roof for the isolated tank are shown in Figures 15c. The signals have been filtered in order to remove the frequencies greater than 1 Hz. Comparison with the results of non isolated case results, a considerable increasing of the sloshing damping, variable in the range 2.5-3.0%, for both isolated configurations has been detected. This increment was expected by numerical models, carried out with non-classical damping theory, but with lower values than the experimental ones.

4.3.4.2 Response of the base isolated tank

The evaluation of seismic effects on the tank wall has been made in terms of both maximum base shear induced by the dynamic pressure and relative impulsive and convective components.

These resultants have been evaluated interpolating the experimental values of the pressure with the relative theoretical functions and then integrating along the height. The separation

of the sloshing and impulsive plus flexible components was obtained by filtering the signals around the corresponding frequencies.

The responses of the table, measured in the different experimental tests, because of some problems with the control system, were different, even if the same accelerograms were used. Because of these differences, comparison was difficult. To overcome this problem the comparison was done in terms of mean spectra accelerations Sa, (5% of damping), calculated in the period range 0.05 and 0.1 s $(10 \div 20 \text{ Hz})$ for the impulsive component, and 2.2-2.8 sec ($\sim 0.35 \div 0.45$ Hz) for the sloshing component. Impulsive and sloshing forces have been represented as functions of the relative spectra acceleration (Figures 16a and 16b).

In the same figures the interpolation curves of the experimental data are shown for the fixed base (case B) and isolated base cases (case C, case D). For the fixed base case the trend is linear, whereas the isolated base cases clearly show a nonlinear behavior of the phenomenon, especially for high values of spectral acceleration.

The total shear has been plotted as function of the same spectra ordinate as that used for the impulsive component, the latter being a significant part of the total one (Figure 16c). The figure clearly shows the high effectiveness of both the isolation systems, which induce considerable reductions of the total shear affecting the tank wall. However, whereas the effectiveness of HDRB isolators does not practically vary with S_a , the effectiveness of SIEPD devices is reduced for low values of spectral acceleration, and it is practically negligible for Sa<0.3g.




Fig. 16. (a) Impulsive base shear versus spectral acceleration of the impulsive motion, (b) convective base shear versus spectral acceleration of the convective motion, (c) total base shear versus spectral acceleration of the impulsive motion, (d) maximum displacements of the floating roof versus spectral acceleration of the convective motion.

This is due to the friction effects, often neglected for this kind of device, but particularly significant for the tanks, in which the gravity mass, represented by the entire liquid volume, is greater than the dynamic mass, which is represented by the impulsive mass only (in the present case only 30% of the total mass). Therefore, to overcome the friction appreciable levels of acceleration are needed. This problem is not present for elastomeric devices.

This behavior, if appropriately controlled, could represent an interesting advantage recognizable to SIEPD devices compared to HDRB devices. In fact, for low levels of seismic intensity, it could be convenient to use an isolation device with a reduced amount of slip, which instead is required for more intense events in order to achieve a full employment of the dissipation capability of the devices.

For the impulsive component (Figure 16a), the reduction is quite important, as already observed for the total base shear, especially for high values of Sa; on the contrary, the sloshing component (Figure 16b) remain practically unchanged for HDRB, whereas a slight increasing has been observed using SIEPD. This increasing has no influence on the stresses of the tank wall, at least for large broad tanks. The negative effects are related to the floating roof oscillations, which could generate, in some cases, the breaking of the gaskets and the leakage of inflammable materials. Unfortunately, the base isolation does not reduce the amplitude of the superficial waves, although the sensible increasing of damping reduces its duration and then probably the risk of failure of the gaskets. However, for case D only an increasing of the convective pressure has been measured, which has induced a rather moderate increasing of the amplitude displacement of the floating roof that does not seem to be not particularly worrying (Figure 16).

Finally, the maximum values of displacements of the tank base, recorded during the tests of case D and here not shown for brevity (De Angelis et al. 2010), are lower than the displacements of case C. This is another advantage for the SIEPD isolation system, since large displacements, which have to be absorbed by the pipes-tank connections, represent a problem, the solution of which is not always easy.

4.3.4.3 Comparison between numerical and experimental results

The numerical model defined in section 3.2 has also been used to carry out step-by-step non linear analyses using as base motion the accelerograms recorder on the shaking table during the tests. The isolator devices have been modeled by the classical Bouc-Wen model. The aim is to confirm the reliability of the analytical and numerical formulation of the problem, also when the floating roof is present, generally missing in the evaluation of the dynamic response of tanks.

As a matter of fact, hereafter a numerical-experimental comparison of the results of cases B, C and D, is presented and discussed. For brevity only the results of the Arcelik accelerogram, scaled to the nominal acceleration nearest to the design value (0.5g) are shown.




Fig. 17. Total base shear. Numerical-Experimental comparison, (a) case B, (b) case C, (c) case D, Arcelik 0.5g.

Figure 17 shows the comparison, in terms of base shear for case B. Firstly, a good agreement between the experimental and numerical response may be noted. A good predictive capacity of the model emerges when the floating roof is present as well.

The numerical-experimental agreement can be better highlighted by analyzing the single components of motion. Figure 17a shows, for case B, the base shear due to impulsive pressure. The agreement is quite good and sufficient to correctly describe the phenomenon.

For the convective component of motion, although the value of the fundamental frequency was very close to the theoretical value (0.4 Hz), the comparison between numerical and experimental results proved unsatisfactory, because of non-zero initial conditions due to a low damping of the liquid motion. The numerical-experimental agreement is improved in the cases C and D. In fact, in these cases the fluid-structure interaction become less important and the high damping of the liquid motion arrests oscillations more rapidly, allowing zero initial conditions.

For the isolated tank Figures 17b and 17c show the comparison between theoretical and experimental results. The good agreement proves the reliability of the model.

To summarize, the comparison between the shaking table test results and the response of simple numerical models described in section 2 shows the suitability of the latter to simulate the behavior of the fluid-structure system, both for fixed base and isolated base tank, also considering the floating roof as well. Actually, the slight discrepancies between numerical and physical models are probably due to some drawbacks in the experimental activity, caused by the high mass of the filled tank and the frequencies range investigated.

5. Conclusions

Recently, the attention paid on the protection of industrial facilities against natural phenomena is increasing, especially for the catastrophic consequences of strong events that induced severe damages to people and environment.

Among the natural phenomena capable to determine serious hazards to industrial plants, earthquakes should be taken into account especially because they are capable to generate multiple sources of releasing of dangerous substances and domino effects within the same plant, determining the complete destruction of the site. The analysis of past accidents induced by earthquakes has shown the high vulnerability of some typical industrial components and the severity of the consequences.

Accordingly, in this chapter, earthquakes effects on major-hazard industrial plants have been analyzed. In particular, typical equipment and components of a refinery were identified and gathered in a limited number of structural typologies; furthermore, their seismic vulnerability was analyzed, looking into historical events, i.e. concerning the damages caused by past earthquakes to several industrial components.

Subsequently, the applicability of some innovative techniques for the seismic protection of industrial equipment was studied and the most suitable passive control techniques were identified for each structural typology. As an example, the main results of a study on the effectiveness of yielding-based and HRDB isolators for the seismic protection of aboveground steel storage tanks were presented. In particular, after a brief introduction to the problem of designing a base isolation system for storage tanks, the outcome of a wide numerical and experimental investigation on a broad tank with floating roof were deeply discussed. Shaking table test results have shown the high efficiency of both the isolation systems and, at the same time, the reliability of lumped mass model for the prediction of the seismic response of isolated above-ground tanks.

New Trends in Hydroprocessing Spent Catalysts Utilization

1. Introduction

The distillate of crude oil is an essential step in the petroleum refining practice. The yield and properties produced distillates depend on the properties of crude oil, distillation conditions and the type of distillation column. Primary distillates are subjected to an additional treatment to meet the environmental requirements and the performance of produced fuels. The schematics of a typical refinery operation processing a conventional crude shown in Fig. 1 lists four catalytic processes, i.e. reforming, hydrocracking, hydrotreating, catalytic cracking and alkylation. The residue from atmospheric distillation may be subjected to additional distillation under a vacuum to obtain valuable lubricant fractions which also require catalytic hydrotreatment. None- conventional refineries can process heavy oils and distillation residues. In this case, the catalytic hydro cracking of the heavy feed is usually the first step, followed by hydrotreating of the synthetic distillates. For the purpose of this review, the hydroprocessing will refer to both hydrocracking and hydrotreating. Light hydrocarbon which is byproducts of several refineries can converted to high octane fractions by catalytic alkylation and polymerization.

1.1 Refining catalysts (2)

Several operations employing a catalyst may be part of the petroleum refinery. The management of catalyst inventory represents an important part of the overall refinery cost. As shown in Fig. 2, the development of refining is closely connected with the growth of the use catalysts. In the past, refining catalysts accounted for more than half of the total worldwide catalyst consumption. Today because of the importance of environmental catalysis, refining catalysts account for about one third of the total catalyst consumption. Future advances in development of more active and stable catalysts may further decrease the overall consumption of refinery catalyst.

The solid catalysts are usually of none noble metal catalysts and noble types. None-noble metal catalysts include base metals and zeolites. Nobel metal catalyst includes a variety of precious metals from the platinum group. In many cases, catalytically active metals are combined with a solid support such as alumina, silica-alumina, zeolites, carbon, etc.

1.2 Catalyst demand worldwide (3-5)

The oil refining industry operation is analyzed in order to estimate the future catalyst market trends. The refining catalyst market corresponding to the main catalytic processes is estimated taking into account the following information: (i) the average refining capacity increases for the main catalytic processes since 1999, (ii) the additional refining capacity due to future plans of construction and expansion of refineries and process units that will be added by 2005, and (iii) the past refining catalyst market behavior. From this information, it has determined for the main catalytic processes a global average factor, expressed as processed oil barrels per dollar of catalyst. According to the catalyst Group Research Co, the global refining catalyst market has grown from \$2.32 billion in 2001 to about \$2.65 billion in 2005 (3.6% annual growth). Hydrotreating, fluid catalytic cracking, hydrocracking and isomerization represent about 74% of the total catalyst market and will grow by about \$34, \$32, \$11 and \$2.5 million per year, respectively. However, naphtha reforming catalyst market will not grow during 2001-2005. Higher catalyst spending growth is expected for the North America region (\$27.5 million per year)

Worldwide refiners need to produce cleaner fuels and operate to meet environmental regulations. Therefore, refineries should convert more heavy feedstock's to satisfy regional fuel market needs, and minimize their profit margins which guides the developments in the refining catalyst market. Refiners require more processing capacity and higher efficiency to satisfy regional fuel market needs., therefore, more catalyst consumption is needed and in the same be more resistant to deactivate under sever operating conditions. Table 1 gives the refining catalyst market in tons and dollars by application for 1999 and 2005.

The refining catalyst market is the most competitive segment of the global catalyst. This market was increased at about 1.9% / year during 2001-2007. Two different catalyst market estimates 1 and 2 (Table 2) were developed according to the increasing refinery capacities or to the added capacities due to revamps, or expansion plans. Table 2 shows the future catalyst markets according to these estimates. The data indicate that the current catalytic processes, hydrotreating, FCC, naphtha reforming, hydrocracking and isomerization, represent about 77% of the total refining catalyst market. The future catalyst market will increase through 2007- 2008 to about \$ 2.58 billion (2.8%/ year). Most growth was occurred

in North America, Asia Pacific, and the Middle East. If the catalytic prices remain unchanged, then the future worldwide catalytic processes consumption will be about:

1.3 Catalysts deactivation (6-10)

In every catalytic operation, the activity of the catalyst gradually decreases. This decrease can be offset by changing some operational parameters. However, at a certain point, catalyst replacement is inevitable. The spent catalysts can be regenerated and returned to the operation. The regeneration of spent hydroprocessing, fluid catalytic cracking (FCC) and reforming catalysts has been performed commercially for several decades. These regeneration processes have been extensively reviewed by Furimsky and Massoth .Hughes and Fug.

Large quantities of catalysts are used in the refining industry for operation and upgrading of various petroleum streams and residues. The catalysts deactivate with time and the spent catalysts are usually discarded as solid wastes. The quantity of spent catalysts discharged from different processing units depends largely on the amount of fresh catalysts used, their life and the deposits formed on them during use in the reactors. In most refineries, a major portion of the spent catalyst wastes come from the hydroprocessing units. This is because the catalysts used in these processes deactivate rapidly by coke and metal (V and Ni) deposits, and have a short life due to fouling of the active catalytic centers by these deposits. Furthermore, technology for regeneration and reactivation of the catalysts deactivated by metal fouling is not available to the refiners.

The volume of spent hydroprocessing catalysts discarded as solid wastes has increased significantly in recent years due to the following reasons:

- rapid growth in the distillates hydro processing capacity to meet the increasing demand for ultra low-sulfur transportation fuels.,
- a steady increase in the processing of heavier feed stocks containing higher sulfur, nitrogen and metal (V&Ni) contents, and

- rapid deactivation and unavailability of a reactivation process for reside hydroprocessing catalysts.

In Kuwait's refineries, over 250 000 barrels of heavy residues higher in sulfur, and metals are upgraded and converted to high quality products by catalytic hydroprocessing, bringing substantial economic returns to the country. These operations generate a substantial amount of deactivated spent catalysts as solid waste every year. Currently, about 6000 tons of spent catalysts are discarded as solid wastes from Kuwait's refineries annually. This will increase further and exceed 10 000 tons/y when a fourth refinery is built to process heavy crudes and residues.

In Egyptian refiners, the solution is different, due to schematic refining processing such as, hydrotrating, isomerization and reforming process. The only full refining system was found is Medor refining which contains, beside the hydrotreting units, a conversion unit (hydrocracker) using less contaminants heavy residues. Therefore, the current discarded spent catalysts have fewer amounts, i.e. nearly 400-700 tons / y, but can be increased due to the future addition of new refining instillations.

1.4 Environmental considerations (10-12)

Environmental laws concerning spent catalyst disposal have becomes increasingly more severe in recent years. Spent hydroprocessing catalysts have been classified as hazardous wastes by the Environmental Protection Agency (EPA) in the USA. The most important hazardous characteristic of spent hydroprocessing catalysts is their toxic nature. Metals such as V, Ni, Mo and Co present in the catalyst can leached by water after disposal and pollute the environment. Besides the formation of leachates, the spent hydroprocessing catalysts, when in contact with water, can liberate toxic gases. The formation of dangerous HCN gas from the coke deposited on hydroprocessing catalysts that contains substantial amount of nitrogen has been reported. The solid spent refinery catalysts will refer to as non-regentable catalysts and the hazardous nature of the spent catalysts is attracting the attention of environmental authorities in many countries and the refiners are experiencing pressures from environmental authorities for safe handling of spent catalysts.

In the USA, the disposal and treatment of spent refinery catalysts is governed by the Resource Conservation and Recovery Act (RCRA), which holds not only the approved dumb-site owner liable. but also the owner of the buried waste. This environmental responsibility continues for the life of the dumb-site. The current RCRA regulations require landfill to be built with double liners as well as with leachate collection and groundwater monitoring facilities. Thus, the landfill option is becoming expensive today. In Addition, it carries with it a continuing environmental liability. Treatment prior to land filling may be necessary in some cases, further increasing the cost.

1.4.1 Hazardous characteristics of spent hydroprocessing catalyst (13-16)

The hazardous nature of hydroprocessining catalysts depends on operating conditions. However, the procedure applied during the catalyst withdrawal from the reactor at the end of the operation can be even more important. If a proper procedure can be applied, the hazardous cane be significantly minimized. For example, if a hydroprocessing catalyst

cane be treated with either an inert gas or steam, and/ or CO_2 in the absence of H_2 and feed, and at a near operating temperature, the amount of the carried over liquids can be substantially decreased. The amount of entrapped volatile gases, which may include even H_2 , can be decreased as well. Without a proper pretreatment prior to the catalyst withdrawal the concentration of flammable vapors above the solid material may reach dangerous levels. In some cases, e.g. when special precautions were not taken during the catalyst withdrawal, it may be appropriate classify the hazardous characteristics of spent hydroprocessing catalysts as that of the corrosive and flammable liquids. One information source indicates catalyst unloading under vacuum. It is stated that this method removes the catalyst without disturbing the operation, however, the type of catalyst and / or operation is not specified.

It a appears that there is no safe catalyst withdrawal procedure which could be generally accepted by all refiners.

Refiners usually apply their own procedure. The need for a commonly accepted and/or approved procedure may develop in the future. In this regards several patents describing the catalyst unloading techniques should be noted. These techniques can significantly reduce or even eliminate the self-heating character of spent catalyst. Otherwise, if spontaneous combustion begins, the inorganic sulphides and organic sulphur which are part of the spent catalysts may also contribute to the uncontrolled burn off. In such case, they will produce large quantities of SO_2 . However, sulfides alone require temperatures exceeding 200°C for spontaneous combustion to occur. Part of nitrogen in coke will be converted to NOx during the spent catalysts burn off. Though the evolution of HCN and NH_3 is also possible. Fig. 3&4 show the formation of HCN and NH_3 during oxidation of spent CoMo, Ni Mo catalysts in 4% O₂.

2. New trends in utalization (17-19)

Several alternative methods such as disposal in land fills, reclamation of metals, regeneration/ rejuvenation and reuse, and utilization as raw materials to produce other useful products are available to the refiners to deal with the spent catalyst problem. The choice between these options depends on technical feasibility and economic consideration.

Nowadays, in order to alleviate the shortage of domestic resources and improve the environmental condition, many countries in the world pay much attention to the comprehensive utilization of the secondary resources. In Japan, recycling of the waste catalysts has been done since 1950s; the turnover of waste catalysts was already up to 500 million dollars in 1996.

Thus, the landfill option is becoming expensive today. In addition, it carries with it a continuing environmental liability. The potential future liability of landfills is estimated at about \$200/ton. Treatment prior to land filling may be necessary in some cases increasing the cost. In the face of lower- sulfur regulations and regulations deterring catalysts from entering landfills, refiners have directed spent- catalysts traffic from disposal options to regeneration and reclamation plants.

2.1 Recovery of metals (20-29)

In recent years, increasing emphasis has been placed on the development of processes for recycling and recovering of the waste catalyst metals, as much as possible. In literature there are many applied researches for spent metals recovery, particularly for catalyst that contain high concentrations of valuable metals (Mo, Ni, V and Al_2O_3) However, fluctuations in the market prices of the recovered metals and their purity, together with the high costs of shipping significantly influence the economics of the metal reclamation process making it less attractive for spent catalysts that contain low metals concentrations.

As the environmental pressure increases, and as the cost of catalyst storage and disposal continues to rise, the utilization of spent refinery catalysts for metal recovery is becoming a viable pollution. Therefore, the refiners are ready to supply spent hydroprocessing catalysts free of charge in order to reduce their costs for storage and disposal. If the market value of the recovered materials is high enough, then it will offset, the processing cost yielding, a net profit to the reclaimer companies.

2.2 Reactivation/rejuvenation and reuse

Many literature review revealed that reactivation of spent catalysts technology did not reach to well developments. Spent catalysts lose their activities, and deactivated by pore blockage and fouling of the active surface with deposition of coke and metal contaminants. Therefore, many efforts were subjected to replace the conventional regeneration procedures in order to reactivate and rejuvenate the spent catalysts. The new procedures are conducted to remove contaminant metals selectively by chemical treatments without significantly affecting the chemical and physical characteristics of the original catalyst.




Fig. 1. Relative hydrodesulfurization (HDS) activity of fresh spent and leached catalysts under variable reactor temperature.

In some experimental works in EPRI (1), we were succeeded in rejuvenating spent catalyst Mo Ni/Al2O3 after re-refining of waste lube oil. Our data revealed that the treated spent catalyst can be restored to nearly the fresh HDS activity levels by application of oxalic acid leaching technique in addition to H2O2 as an oxidizing agent. The most effective leaching agent was 4% oxidized oxalic acid, and the extent of metals recovered was dependent on acid concentrations or the specific reuse of the spent catalyst. The rejuvenation process promotes the formation of a hydroprocessing catalyst due to improvements in surface area and average pore diameter (87% and 63% of fresh catalyst characteristics, respectively) as a result of metals recovery. These improvements caused recovery in the HDS activity of the treated catalyst in the range of 81–96% compared to the activity of the fresh, 95-98%, within reactor temperatures 340iC–380iC figure 1. Therefore, it is clearly possible to reuse the rejuvenated catalyst, especially in the refining processes, as a top-layer guard-bed or mixed with the same fresh catalyst (2-3).




Fig. 2. Effect of reaction temperature on cyclohexene conversion when using catalysts: fresh (A) spent (B) decoked before (D) and after (E) leached by 2%.

Other improvements were also obtained in catalyst activities by leaching, especially prior to decoking, either using 2% or 4% leaching concentration. The results indicate that removing coke from the leached catalysts increases its cyclohexene conversions as well as its hydrogenation and isomerization activities figure 2. These results suggested that coke deposition has less effect than metals in deactivating hydrotreating catalysts. The treatments

developed in the present work appear to be very promising for reactivation (rejuvenation) of hydrotreating spent catalysts in order to recycle the solid spent catalysts and thereby reducing their environmental problems of disposal. (4).

2.3 Utilization of spent catalysts as raw materials

Utilization of spent catalysts as raw materials in the production of other valuable products is an attractive option from environmental and economical points of view. Spent fluid catalytic cracking (FCC) catalysts have been successfully utilized in cement production. In the U.S., cement kilns process about 60,000 tons/year of spent FCC catalysts.

3. Concluion

The volume of spent hydroprocessing catalysts in the Arab countries discarded, as solid wastes, has increased significantly due to:

- 1. Increasing in processing moderate and / or heavier feedstocks.
- 2. Rapid growth in the distillates hydroprocessing capacity.
- 3. Increase the environmental regulations for fuel emissions.
- 4. In Kuwait alone, around 7000-10000 t / y spent catalysts are generated every year more than the other Gulf Countries. In Egypt, the volume of spent catalysts is nearly around 400-700 t / y, depends on the type and volume of the refined feedstock. Therefore, the choice of the Kuwait refiners was focused now on two processes, one for rejuvenation of spent residue hydro treating catalysts, and the other for producing non-leachable synthetic aggregate materials or loaded as front end- reactors (HDM, guard beds).

Handling and utilization has been the subjected of some investigations in the Kuwait (KISR) and Egypt (EPRI) laboratories. In most of the previous studies in both laboratories, rejuvenation of spent hydroprocessing catalysts for reuse was addressed. Up to 70-80% of the spent catalyst was reclaimed, in the applied processes of both laboratories, with HDS activity as high as 94-95 % of fresh catalyst. Therefore, from the economic point of view, the rejuvenation and reuse of the catalyst is feasible with an internal rate of return.

In **KISR**, the researchers have been succeeded in preparing hydride- metallization (HDM) catalysts, by the addition of boehmite.

The resulted catalyst are used in the front-end of reactors used in petroleum residue hydrotreating processes to remove the foulant metals (V and Ni). The catalyst posses high activity for promoting HDM reactions together with some activity for HDS reactions.

Research on Remediation of Petroleum Contaminated Soil by Plant-Inoculation Cold-Adapt Bacteria

1. Introduction

With the rapid development of the petroleum industry, a large number of oil contaminants leaked into the soil in the petrochemical complex areas, gas stations, automobile factory and other places, which resulted in serious soil contamination. Micro-Biological degradation of oil pollution was the focus of the present study. Many hydrocarbon-contaminated environments were characterized by low or elevated temperatures, acidic or alkaline pH, high salt concentrations, or high pressure. Hydrocarbon-degrading microorganisms, adapted to grow and thrive in these environments, played an important role in the biological treatment of polluted extreme habitats.

The biodegradation of many components of petroleum hydrocarbons has been reported in a variety of terrestrial and marine cold ecosystems. Cold-adapted microorganisms are potentially interesting for use in environmental biotechnology applications since a large part of the biosphere has low temperatures during at least parts of the year. Many studies have shown that both oil-contaminated and uncontaminated soils in the Arctic, the Antarctic and the Alps contain microbes that can degrade different hydrocarbons deriving from oils^[1]. For application at cold climate sites, bioremediation approaches are appealing because they have potential to be more efficient and cost-effective than alternative, more energy intensive approaches. Several bioremediation approaches have been reported to be successful for petroleum hydrocarbon-contaminated soils at cold climate sites ^[2]. Two psychrotrophic bacterial strains isolated from Antarctic seawaters were investigated for their capability to degrade commercial diesel oil at 4 and 20°C over a period of two-months. The result suggested the possible exploitation of two bacterial strains in future biotechnological processes, directly as field-released micro-organisms both in cold and temperate contaminated marine environments ^[3].

The cold-adapted bacterial communities were also studied. Some research suggested that geographical origin of the samples, rather than petroleum contamination level, was more

important in determining species diversity within these cold-adapted bacterial communities ^[4]. Predominant populations from different soils often included phylotypes with nearly identical partial 16S rRNA gene sequences (i.e., same genus) but never included phylotypes with identical ribosomal intergenic spacers (i.e., different species orsubspecies)^[5]. Twenty-two polycyclic aromatic hydrocarbon (PAH)-degrading bacterial strains were isolated from Antarctic soils with naphthalene or phenanthrene as a sole carbon source and all these strains showed a high efficiency to degrade naphthalene at 4°C, and some additionally degraded phenanthrene. Phylogenetic analysis showed that all belonged to the genus Pseudomonas except one that was identified as the genus of Rahnella^[6]. 32 cold-adapted, psychrophilic and cold-tolerant, yeast strains isolated from alpine habitats with regard to their taxonomy, growth temperature profile, and ability to degrade phenol and 18 phenol-related mono-aromatic compounds at 10°C ^[7].

Cold-adapted microorganisms inhabit in most parts of the surface of earth and the annual average temperatures of these regions are below 15°C, but these temperatures are far lower than the optimum growth temperatures of mesophilic microorganisms which have been widely used in bioremediation technology at present [8]. In most parts of China, it was cold in winter and cool in spring and autumn, when the microbial survival rate was low and the natural degradation capacity was poor. Cold-adapted microorganisms which had special genetic background and metabolic channels were widely distributed in the nature at low temperatures. The cold-adapted microorganisms could produce a lot of active substances, and show unique characters in many areas at low temperatures [9].

On the other hand, bioremediation was considered to be the most cost-effective and environmental friendly technology to treat oil-contaminated soil currently. And the combination of microbe and plant would be practical and effective.

Plants could be used to remediate organic or inorganic polluted soils. This technique had been applied widely in practice, named as phytoremediation. The plant roots improved the water content in the polluted soil. The increased microbial activities induced by the improved rhizosphere microecosystem could be used to enhance biodegradation of petrochemicals and bioremediation of polluted soil^[10].

In this study, oil-contaminated soil in Tianjin and was used for domestication at different temperatures. Two different communities of bacteria depend on crude oil as sole carbon source were found and the main foundation of temperature on the microbial community screening was researched and revealed. The biodegradation characteristic was studied then. The effect of combined remediation by winter wheat and cold-adapted degrading bacterial was examined. In order to explore the effect of combined remediation by bacterial and plant at low temperature on petroleum hydrocarbons contaminated soil, the TPH removal and the catalase activity were examined at different incubation time in different treatments.

2. Materials and methods

2.1 Domestication and purification of petroleum - Degradation strains

Crude oil and petroleum contaminated soil samples were taken from Dagang oil field (1m deep) in Tianjin. Well drainage was also taken from the well in Dagang oil field. Magnesium sulfate (AR.), Di-hydrogen phosphate ammonia (AR.), Sodium nitrate (AR.), Potassium

nitrate (AR.) and di-Potassium hydrogen phosphate (AR.) were obtained from the Beijing Chemical Factory. All the chemicals were used as received. The restriction endonuclease was purchased from Promega. The nucleic acid electrophoresis apparatus (Bio-Rad) and GDS gel imaging system (Gene company) was prepared.

Inorganic drainage liquid medium: NaCl 5 g/L, K₂HPO₄ 1 g/L, NH₄H₂PO₄ 1 g/L, (NH₄) $_2$ SO₄ 1 g/L, MgSO₄ 7H₂O 0.2 g/L, KNO₃3 g/L. Well drainage was used as solvent and pH adjusted to 7.0. 1mL sterilized crude oil was joined to 100mL inorganic liquid medium to make crude oil inorganic liquid medium. 1g soil sample polluted by petroleum hydrocarbons was dissolved with saline water and cultured in a liquid medium supplemented with petroleum oil as the sole source of carbon and energy for 10 days on 10°C and 25°C respectively. Then a certain amount of the above culture solution was inoculated and cultured in a mineral liquid medium supplemented with petroleum oil as the sole source of carbon and energy for 10 days again. The step was repeated again. The culture solution was diluted (10·1 ~ 10·8) separately. 50ul culture solution was coated to the solid culture medium and cultured for 5 days. The flats of proper concentration were selected in different temperatures. All the colonies were inoculated to flat plate to sieve again. Purified strains were cultured in test-tube and stored in refrigerators at 4°C.

2.2 Polymerase Chain Reaction (PCR) assays

The purified cultivated strains were used as template and the primers used for the PCR were 8F and 1492R [11]. (Table 1).

PCR reaction system contained 2 x PCR mixture 25ul (0.1 U Taq Polymerase/ul, 500uM dNTP, 20mM Tris-HCl [pH8.3]), 100mM KCl, 3 mM MgCl₂, 2ul primer 8F (5uM), 2ul primer 1492R (5uM), 2ul template and 19ul double steamed water in a final volume of 50ul.

The thermal cycling was as follows: initial denaturation at 94 $^{\circ}$ C for 6min, followed by 30 cycles of 30s at 94 $^{\circ}$ C, 40s at 52 $^{\circ}$ C, 1.5 min at 72 $^{\circ}$ C, and a final extension of 10 min at 72 $^{\circ}$ C. The PCR products were analyzed by running 5ul aliquots of the reaction mixtures in 1.2% agarose gels.

2.3 Genotyping of individual isolates by ARDRA (Amplified Ribosomal DNA Restriction Analysis)

Strains were analyzed by ARDRA using two restriction endonuclease enzymes (RsaI and MspI). Restriction analysis of the PCR products was performed in a 10ul reaction containing: 1ul restriction enzyme buffer, 0.3ul restriction endonuclease and 5ul PCR product. Reactions were then incubated at 37°C for 3h and stopped at 60°C. Restriction fragments were separated on 3% agarose gels. Gels were photographed after staining with ethidium bromide with the imaging system Bioprint.

2.4 Biodegradation of petroleum by cold-adapted petroleum-degrading bacteria

Each triangle flask was filled with 200mg sterilized crude oil and 50mL inorganic salt liquid medium (4g/L), pH7.0. Strains were cultured in the beef extract peptone liquid medium for 48h at 25 $^{\circ}$ C and then centrifuged at 4000 r / min for 10 min to prepare suspending solutions. 2mL suspension was inoculated in each triangle bottle. The sample with no suspension was blank sample. All the samples were cultured at 150 r / min at 10 $^{\circ}$ C. Bacteria density was measured at different time. The strains which grew well were chosen and for the next experiments.

60g crude oil was delivered to 1000g clean soil and blended for many times and then the mix was sterilized to prepare petroleum contaminated soil (6%). Different test conditions were set respectively: soil with bacteria D17 added, soil with bacteria D24 added, soil with mixed bacteria (D17 + D24) added and blank contrasts. Petroleum hydrocarbons degradation rate was determined in different conditions at different time. The oil in soil was extracted by accelerated solvent extraction system (APLE, Beijing Titian Instruments Co., Ltd, China) and determined by weight method. The extraction condition by APLE was set as follow: extraction pressure -10 M Pa, heating time- 100 s, static time- 720 s, elution volume- 60%, purge time- 60 s, preheating temperature-170°C, heating temperature-170°C and followed by a cycle. The solvent was hexane/ acetone =1:1 (V/V).

2.5 Combination remediation of petroleum contaminated soil by degrading bacterialD17 and winter wheat

The experimental soils used for this study were collected from an agriculture field in Beijing, China. The soil was dispersed and mixed, then passed through a 5-mm mesh. The soil material was first thoroughly mixed with of oil by different mixing ration and then dried. And the oil content was measured 20 days later while the concentration was 1409.13mg/kg, 2060.26mg/kg and 3273.40mg/kg respectively. The basic soil properties were determined using standard methods recommended by the Chinese Society of Soil science. The basic properties of the soil were shown in table 2. The cold-adapted bacterial used in this study was D17. The experiment condition was showed as Table 3.

The soil of every pollution level was treated as below: first, combined remediation: planted winter wheat and added degrading bacteria. Second, microbial remediation: added the degrading bacteria; Third, the control: no planting and no bacteria. All treatments were shown in Table2.

The study was performed in the incubator which is 1 meter wide, 1.2 meter long and 1meter deep. The soils were put into the incubator and the depth of the soil was 60cm. Transplanted the winter wheat into the incubator with the row spacing of 17cm and added N, P, K slow-release fertilizer to the soil. 360ml bacteria liquid was added to the soil per square meter on February 5, and the OD value was 0.8366. Then 150 ml bacteria liquid was added to the soil per square meter again on April 7th, and the OD value was 0.8433. Simulated conventional irrigation farming conditions during the whole incubation time.

All treatments were incubated in the greenhouse for 126 days, from February 5th to June 10th. The varieties of soil enzymes and oil content with incubation time under different treatments were analyzed. The rhizosphere soil and non-rhizosphere soil of winter wheat

were taken on February 5th, March 4th, April 28th, May 8th and June 10th respectively. Record February 5th the first day of the experiment, then the sampling time were the 1stday, the 53rdday, the 83rd day, the93rd day and the 126thday respectively.

Petroleum Hydrocarbon in soil samples was analyzed by using an APLE-2000 system. Data treatments were performed using Excel 2003 and SPSS 17.0 for windows.

3. Results and discussion

3.1 Microbial community of oil-contaminated soil at different temperature conditions

Strains was analyzed by ARDRA and different genotyping was obtained in different temperature conditions. Each genotyping was conducted as an operational taxonomic unit (OTU). All the strains were analyzed with 16srDNA and the sequence subjected to BLAST GeneBank analysis (Table 4 and Table 5).

Considering from the composition point of view, 8 OTUs has been domesticated at 25 °C. Analyzed and retrieved in GeneBank Database, *Bacillus, Sinorhizobium, Rhizobium, Chryseobacterium* and *Bartonella* were homologous and the dominant bacteria were *Rhizobium* and *Bacillus*. Meanwhile, 11 OTUs has been domesticated at 10 °C, which were *Arthrobacter, Micrococcus, Rhodobacter, Bacterium, Paracoccus, Rhizobium* and *Halomonas* and the dominant bacteria were Arthrobacter and Halomonas. Some studies had showed that parts of Rhizobium strains could survive by using organic sulfur instead of carbon [12] for energy. It was reported that Bacillus had the ability of degrading petroleum hydrocarbon. It was also

reported that lots of *Arthrobacter bergerei* could degrade oil effectively [13, 14]. Some studies suggested that degradation rates could reach 50% after 4d while others found a 90.8% degradation rates after 20d [13, 14]. *Arthrobacter bergerei* were likely to formed biological emulsifier when they used petroleum as carbon sources. The results showed that *Halomonas* was also feasible for high-sodium soil contaminated by petroleum and could be used for bioremediation in future.




Fig. 1. Comparison of microbial community structure of 10°C and 25°C.

It was obvious that the community composition was more diverse under the conditions of 10°C than of 25°C (Fig. 1). The microbial community diversity was significantly higher

under the conditions of 10 °C. The dominant bacteria were different in different temperature conditions and Rhizobium was the only same genus. 40% of the total community composition was Rhizobium at 25°C and the proportion at 10°C was 3%. On the other hand, the total bacterial concentration at 10°C was 6.2×10^5 CFU/mL and which under the conditions of 25°C was 4×10^8 CFU/mL. The bacteria abundances was higher at 25°C. Low temperature condition would inhibit growth of microbes. As a result, the temperature had a strong impact on the composition of soil microbial communities.

3.2 The bacteria growth situation in liquid medium at 10°C

31 strains were domesticated and purified at 10°C and 11 genotypes were obtained. The growth situation of the 11 kinds of bacteria cultured in a liquid medium supplemented with petroleum oil as the sole source of carbon and energy at 10°C was researched. Bacteria density was detected after being cultivated for 4d, 11d and 20d respectively (Table 6). After being cultivated for 20d, crude oil was emulsified by some of the bacteria while D17 and D24 could produce emulsification to a greater degree. Some studies showed that a lot of strains which used petroleum hydrocarbons as the sole source of carbon and energy could secrete various biological emulsifier and biosurfactant [15]. The increment of D2, D9, D17 and D24 was clear in liquid medium while which of D17 and D24 was obvious especially. Therefore, D17 and D24 were selected and their ability of degradation of petroleum was researched then.

3.3 The biodegradation of petroleum by cold-adapted bacteria




Fig. 2. The biodegradation of petroleum by cold-adapted bacteria at 25°C.




Fig. 3. The biodegradation of petroleum by cold-adapted bacteria at 10°C.

As showed in Figure 2 and 3, both of the strains had ability of degrading petroleum at different temperature. The degradation rates were analyzed at 0d, 25d, 50d, 75d, 100d respectively. The degradation rate was 25.8% by D17, 25.3% by D24 and 21.9% by D17+D24 at 25°C while which was 11.3%, 10.2% and 10.3% respectively at 100d. Low temperature would affect the growth and enzyme activity of bacteria .However, it was suggested that the degrading of petroleum by cold-adapted bacteria was feasible at lower temperature.

In the fourth group of experiments, the effect of D17 and D24 on the biodegradation of crude oil was studied. Throughout the course of the experiment, D17 had a better effect not

only at 25°C but also at 10°C. As showed in Figure 3, the trend of degradation rate by the strains D17, D24 and D17+D24 respectively was also similar with which showed in Figure 2. However, the general degradation rate by D17+D24 was lower than which by D17 and D24 respectively. It was concluded that the degradation may be inhibited when the strains existed at the same time.

3.4 The effect of petroleum pollution of soil on growth of the winter wheat

When petroleum pollutant leaked into the soil environment, it would damage the plant ecosystem structure and function of the microbial, soil, the plant growth, seed and fruit quality, etc [16]. The higher the petroleum concentration became, the more rapidly the germination, growth and yield of crops declined[17].




Fig. 4. Height of winter wheat when harvested.

The height of winter wheat was similar when transplanting. After transplanting, the winter wheat grew in the same environment. With the increase of culture time, the height and stem width of wheat varied. The stem width decreased in accordance with the increase of the TPH content. Figure 4 showed the average height of wheat when harvested in different contaminated concentration soil. The figure showed that with the increase of the initial concentration of oil, the height of wheat decreased. All theses indicated that the petroleum pollution had certain inhibition effect on the growth of the winter wheat.

3.5 Changes of soil catalase activities with time

The responses of soil enzymes activities to pollutant exposure could be used to evaluate the soil microbial properties. Enzyme activity was widely used to monitor soil pollution and remediation process [18]. Catalase in the soil can undermine the hydrogen peroxide which was toxic to the organisms. Catalase could be induced by environmental harmful factors, and the activity status reflects the stress situation of the environment to some extent [19].




Fig. 5. Soil catalase activities in different soil samples of combined remediation at each incubation time.

Figure 5 showed the catalase activity of each soil sample at different incubation time in the combined remediation. The figure showed that the catalase activity increased after the combined remediation, however there was a decrease in catalase activity in April. The catalase activity was closely related to the aerobic microorganism quantity and the soil fertility. So the reason for this phenomenon might be related to the decline of the microbe quantity or the shortage of soil fertility. The decline of the microbe quantity might be caused by the competition of the inoculating microbes and the indigenous microorganisms.

3.6 Comparison of degration between combined remediation and microbial remediation

The degradation of petroleum hydrocarbon in soil was the combined effect of physical, chemical and biological processes. In general, the effect of natural process was limited $^{[20]}$. In this study , the natural degradation was limited too.

There were indigenous microorganisms in the soil, the species and quantity of which were larger than the inoculating microbes. In these conditions, the inoculating microbes needed to adapt the complex environment and compete with the indigenous microorganisms [21].




Fig. 6. TPH removal in different treatment after remediation.

The TPH removal after remediation in each treatment was shown in Figure 6. The figure showed that the TPH removal of combined remediation was higher than that of microbial remediation, which indicated that the winter wheat promoted the TPH degradation by microorganism.

3.7 Combined remediation of the petroleum polluted soil




Fig. 7. Changes of TPH content in each treatment at different incubor time.




Fig. 8. Changes of TPH removal rate with time in the combined Remediation.

Figure 7 showed the oil content of each soil sample at different incubation times. From the figure, it could be concluded that the degradation trend of petroleum is similar. And there was positive correlation between the catalase activity and the TPH removal. Figure 8 showed the removal rate of TPH by combined remediation at different time. In the initial month, the ground temperature was low when the enzyme activity and the degradation ability of microorganisms were at a low level. Thus the TPH removal rate was slow. With the increase of the ground temperature, the wheat began to turn green when the wheat root began to active. In the same time the TPH removal rate of the oil increased.

Some studies indicated that root quantity was the minimal in earlier winter stage, latter with the winter wheat grew, to flowering stage, reached the largest. Then the root quantity continuously reduced, and to the ripe stage, achieved roughly the same level with that in the over wintering stage. And there were two times that the root quantity changed fastest. One was the rapid rising period from the reviving stage to the flowering stage, the other was the rapid decline period from the flowering stage to the ripe stage^[22].

Figure 8 showed a sharp decrease in the TPH removal rate in April when the winter wheat was in the jointing stage. According to the variation of root quantity and TPH removal rate, it could be concluded that the TPH removal rate increased in the reviving stage, reduced in the jointing stage, recovered in the flowering stage, and then reduced again in the ripe stage.

The reason for the decline in the jointing stage might be related to the reducing of microorganisms quantity caused by the added of inoculating microorganisms, or the shortage of soil fertility which would influence the degradation of TPH by the microorganisms. The specific reasons couldn't be determined, so a further study was needed to analyze the influencing factors on the TPH removal in the jointing stage of the winter wheat. After the florescence stage, the TPH removal rate was at a low level. It might be related to the reducing of root quantity. From the study, it could be inferred that the main period for the TPH removal was from the turning green stage to the flowering stage.




Fig. 9. Petroleum content in non-rhizophere soil and rhizosphere soil of the winter wheat after combined remediation.

The physical and chemical characteristics in rhizosphere soil were significantly different from that in non-rhizosphere soil. After the combined remediation of 126 days, there was a significant difference between the TPH removal in the rhizosphere soils and that in the non-rhizosphere soils, as showed in figure 9. The TPH removal in the rhizosphere soil was higher than that in the non-rhizosphere soil.

4. Conclusions

The total bacterial concentration at 10°C was 6.2×10^{5} CFU/mL and which under the conditions of 25°C was 4×10^{8} CFU/mL. It was obvious that the community composition was more diverse under the conditions of 10°C than of 25°C . The microbial community diversity was significantly higher under the conditions of 10°C . The dominant bacteria were different in different temperature conditions and Rhizobium was the only same genus. 40% of the total community composition was Rhizobium at 25°C and the proportion at 10°C was 3%. As a result, the temperature had a strong impact on the composition of soil microbial communities.

31 strains had been isolated in the low temperature conditions. With preliminary degradation test at 10°C, D17 and D24 had been selected to be used. D17 was identified as *Paracoccus sp.*, and D24 was identified as *Halomonas sp.* The degradation rate was 25.8% by D17, 25.3% by D24 and 21.9% by D17+D24 at 25°C while which was 11.3%, 10.2% and 10.3% respectively. It was suggested that the degrading of petroleum by cold-adapted bacteria was feasible at lower temperature.

The combination of the winter wheat and the cold-adapted bacterial had great potential ability in the remediation of the petroleum contaminated soil. In the rhizosphere soil system, TPH disappeared faster than that in unvegetated pots soil. The main period for the TPH removal was from the turning green stage to the flowering stage. During the period of combined remediation, the TPH removal rate varied in different stages. And a further study was needed in order to study the influencing factors in different stages of the winter wheat, thus we could take different measures in different stages. As incubation proceeded, the catalase activity in rhizosphere soil was improved by planting winter wheat, which indicated that the microbial growth and the metabolic activity were enhanced. And there was positive correlation between the catalase activity and the TPH removal.

Removal of Effluent from Petrochemical Wastewater by Adsorption Using Organoclay

1. Introduction

Given that environmental policy is increasingly severe, the industries are constantly seeking to establish standards of ever lower concentrations of the pollutants in wastewater, and are gradually adjusting their processes, with new procedures in order to generate less and remove more toxic elements present in their discharges.

The production stages of a petroleum industry, such as extraction and refining, are potentially responsible for generating large volumes of effluent to be discarded in the environment.

Water contaminated with petroleum derivates is produced in large volumes in many stages of refining oil. This mixture should be treated to separate these derivates from water before it can return to the environment. However, treatment with conventional processes is very often not economically feasible, or do not have the appropriate efficiency with regard to separation, or produce large amounts of mud that also need treatment (Almeida Neto et al., 2006).

The waste generated in oil refineries contains many different chemical compositions, depending on the complexity of the refinery, the existing processes and the type of oil used. The effluents are produced mainly by physical separation processes, such as atmospheric distillation and vacuum distillation, deparaffinization, deasphalting and also by processes involving chemical conversions by isomerization, alkylation, etherification, catalytic reform, etc.

The risks of environmental contamination and to human health caused by volatile organic compounds have driven a lot of research designed to eliminate or remedy its deleterious effects. Several of these compounds, such as phenol and BTEX compounds (benzene, toluene, ethyl benzene and the isomers of xylene) are found in effluents from oil refineries, and they are important contaminants due to their high toxicity (Akhtar, 2007).

Volatile organic compounds (VOCs) are usually harmful and carcinogenic and may cause serious environmental problems which affect ecosystems. The VOCs also may cause adverse effects to human health, even in low concentrations (Benmaamar & Bengueddach, 2007). They are known to integrate a group of compounds that most contribute to the formation of photochemical ozone and secondary organic aerosols (SOAs), increasing to global warming (Hu et al., 2008).

Different technologies such as advanced oxidation, biofiltration, separation by membrane, absorption and adsorption have been studied and developed in order to remove these organic compounds. It happens that many of these procedures, due to high operating costs, become unviable.

The phenols appear in the effluents from an oil refinery in the stages of catalytic cracking, production of lubricants and solvents, and in the rinse water of the gasoline. According to a survey, the average concentration of phenol in the effluents was 154 mg L^{-1} (Mariano, 2001). Another study found that the concentrations of phenolic effluents from a refinery were between 0.9 mg L^{-1} and 60.0 mg L^{-1} (Barros Junior, 2004).

Among the organic pollutants present in effluents from oil refineries at higher concentrations, phenol stands out. The phenol is a pollutant that is generated mainly in catalytic cracking and fractioning of crude oil. In addition to these sources, some processes use phenol as a solvent, increasing your concentration in the effluent (Otokunefor & Obiukwu, 2005). This study, based in Nigeria, evaluated the impact caused by the release of effluents from a refinery into a body of water. This study found that the quantity of phenol in the effluent treated released in the river delta showed a level of 1.84 mg L-1, higher than the maximum allowed under Nigerian law which sets it at 0.5 mg L-1. The phenol is one of the most difficult wastes to be removed, usually involving processes that are far from satisfactory and have high operating costs. Moreover, it is a highly toxic substance that can kills fish and other aquatic organisms.

The presence of hydroxyl groups confers to phenols the ability to form hydrogen bonds, which gives the same boiling points above organic compounds of molecular weights close, in addition to presenting high solubility in water. The phenol has solubility 8.3 g per 100 g of water at 25°C, therefore, the phenol may go dissolved in the aqueous industrial waste (Solomons & Fryhle, 2002).

The BTEX compounds are considered organic pollutants with high toxicity. One research found that among organic pollutants common in industrial accidents, leaking storage tanks or organic effluents, the BTEX compounds are present at high frequency, being directly responsible for contamination of waters and soils. These aromatics are extremely harmful to human health, fauna and flora (Sharmasarkar et al., 2000).

Liquid wastes generated by refineries have different chemical compositions including oil and grease, phenols, BTEX, ammonia, suspended solids, cyanide, sulfide, nitrogen compounds and heavy metals such as iron, cadmium, nickel, chromium, copper, molybdenum, selenium, vanadium and zinc. Seeking to evaluate and monitor the environmental impact caused by the discharge of effluents in water bodies, toxicity tests are often used as indicators of damage to the aquatic environment. Tests on fish, invertebrates and seaweeds have revealed that most of

effluents from refineries is toxic, causing in these organisms not only lethal effects as well as changes to their growth and reproduction (Wake, 2004).

Many hydrocarbons, particularly the aromatics, have certain solubility in water, such as benzene, 1800 PPMV, toluene, 470 PPMV, ethyl benzene, 150 PPMV and xylenes, 150 PPMV. The process of desalter was very relevant to the contamination of BTEX in aqueous effluents at refineries studied (Worrall & Zuber, 1998).

Experiments have shown that different formulations of gasoline may affect the fate and transport of BTEX compounds. The use of ethanol as an ingredient in the formulation of gasoline has increased worldwide, in order to minimize atmospheric pollution resulting from combustion. The ethanol is completely miscible with water. The ethanol increases the solubility of BTEX compounds in water due to the effect of co-solvent. The International Agency for Research on Cancer (France) and the National Institute for Occupational Safety and Health (USA) include benzene in their lists of products carcinogens. Among the cancers, leukemia is the most frequent. In Brazil, the carcinogenic action of benzene was officially recognized as of March 1994. Your capacity to cause chromosomal damage and to bone marrow was widely demonstrated in humans and animals (Tiburtius & Zamora, 2004).

By understanding the development compatible with the preservation of natural resources, new techniques for wastewater treatment are needed. The clays have a high technical economic feasibility due to the adsorption potential, which associated with its abundant availability make the material more accessible adsorbents (Rodrigues et al., 2004).

The adsorption using clay constitutes one of the techniques recently applicable for the treatment of contaminated effluents. The material is abundant, has low cost and has large surface area. Moreover, it has high rates of mass transfer (Qu et al., 2009).

The increasing use of compounds and products originating in oil has caused serious problems to human health and the environment. The hydrophilic montmorillonite clay is an ineffective adsorbent for aromatic compounds that move often from contaminated sites. The effect of adsorption is suppressed by the competition of water in relation to non-polar compounds to the surface of the adsorbent material. The adsorption of organic compounds on montmorillonite can be enhanced by replacing the inorganic cations presents in the original structure to surfactant cations, such as: hexa-decile-trimethyl-ammonium, HDTMA, tetra-methyl-ammonium (TMA), tetra-ethyl-ammonium (TEA), tetra-butyl- ammonium (TBA), and tri-benzyl-methyl-ammonium (TBMA). Adsorbents surfactants slow the migration of pollutants in subsurface becoming an effective barrier transport of these (Yasser & Jamal, 2004).

Physical and chemical modifications of clays have been used for the production of materials for practical applications. The properties of clay can also be modified by adsorption and intercalation of organic polymers. The pillarization is a modification method that usually involves the intercalation of cationic species acting as pillars to support the mineral layers, separating them, creating a porous material useful for adsorption of organic compounds and other environmental applications (Bergaya et al., 2006).

The pillared clays (PILCs) are microporous materials obtained by intercalation of inorganic species in natural or synthetic expandable clays. Currently the PILCs are considered promising

materials in various processes of adsorption and catalysis, and in particular in processes that relate to environmental protection. They result from isomorphic substitution of aluminum and silicon atoms by atoms of lower valence. Their applications can be found in the removal of NO_{xy} adsorption of toxic organic compounds, among others (Pires et al., 2000).

The process of pillarization consists in intercalation of cationic complexes, followed by calcination. Inorganic complexes can be obtained by hydrolysis of the metals of group 13 and transition metals, by changing the clay basal spacing of 1.2 nm to 1,8 nm, or more (Leite et al., 2000).

The abundance of world reserves of bentonite makes it impossible to estimate the quantity of these resources in a global context. In Brazil the estimated reserves are approximately 47 million tonnes, of which 47.7% are in the State of Paraná, in the municipality of Quatro Barras, 26.6% are in the State of São Paulo, in the municipalities of Taubaté and Tremembé and 25.3% are in the State of Paraíba, in the municipalities of Campina Grande and Boa Vista. The main consumers of these materials are petroleum companies, to employ the clay as thixotropic agent for use in drilling wells, industries that work with iron ore pellets for use as binding agent, paint and varnish industries, among others (Oliveira, 2004).

2. Fundamentals of adsorptive processes

The phenomenon of adsorption is known since the eighteenth century, when it was observed that a certain kind of coal had retained in their pores large amount of water vapor. Nowadays, the adsorption processes are applied in the purification and separation of substances, presenting itself as an important alternative and economically viable in many cases (Fogler, 2002; Ruthven, 1984).

Adsorption phenomena are classified in two types: physical adsorption and chemical adsorption. In the chemical adsorption exists an effective exchange of electrons between the solid and the adsorbed molecule, causing the following: formation of a single layer on the solid surface, irreversibility, and great force of attraction between the adsorbent and adsorbate. For this reason this type of adsorption is favored by increased temperature and pressure. The physical adsorption is a reversible phenomenon, where usually observed the deposition of more than one layer of adsorbate on the adsorbent surface. The forces acting on the physical adsorption are the Van Der Waals forces. The energy released is relatively low and rapidly reaches equilibrium. In this process, the temperature increase is detrimental to the adsorption efficiency.

The adsorption separation processes are widely used in industry, particularly in oil refineries and petrochemical industries (Ruthven, 1984). Knowledge of physical and chemical principles in which they are inserted adsorptive processes is fundamental to the interpretation of adsorption phenomena. The kinetic aspects and the adsorption equilibrium form the theoretical basis for understanding between the fundamental principles and industrial practices. These parameters are therefore essential to the analysis and interpretation of experimental data serving as a support for the dynamic study of the adsorption columns.

Research involving adsorptive processes between organoclay and organic compounds found their interpretations of experimental data supported according to the Langmuir's model, which assumes the existence of adsorption sites, all energetically equivalent, where only one molecule is adsorbed per site, without any interaction with molecules adsorbed on neighboring sites (Burns et al., 2003; Lin et al., 2005). However, there are studies that point to other adsorptive representative models such as Freundlich's model that considers non-uniformity in terms of surface adsorption sites (Boufatit et al., 2007; Cavalcanti et al., 2009; Irene et al., 1998; Kessaïssia et al., 2004; Ko et al., 2007; Richards & Bouazza, 2007; Sameer et al., 2003; Viraraghavan & Alfaro, 1998). Other studies have used the model of Dubinin-Raduskevich, which represents a more comprehensive model. In this model the surface of the adsorbent is not homogeneous and the interaction energy is not constant (Akçay, 2004, 2005).

2.1 Langmuir's isotherm

The kinetic of adsorption starts from the net adsorption rate r_A (mg g⁻¹ min⁻¹), represented by Equation 1.

Being C_A the concentration of the adsorbate in the liquid phase (mg L-1), k_{AD} the kinetic constant of adsorption, k_D the kinetic constant of desorption and θ_A the fraction of adsorption sites occupied by component A of the total number of sites occupied at saturation.

At equilibrium, the net rate of adsorption is null, so we can rewrite Equation 1 according to Equation 2.

By introducing the constant of equilibrium K_A , which represents the ratio between the kinetic constants of adsorption and desorption, in Equation 2, we have Equation 3.

Reorganizing the terms and rewriting Equation 3 as a function of the fraction of sites occupied θ_A , we obtain Equation 4.

Considering the fraction of sites occupied θ_A as the ratio of the concentration of the adsorbate on the solid phase q_A (mg g⁻¹) and the concentration of adsorbate in solid phase in saturation q^{max} (mg g⁻¹) also known as maximum adsorption capacity, we have Equations 5 and 6, the latter being known as the Langmuir's Equation.

The values of C_A can be obtained experimentally and the values of q_A can be calculated according to the material balance representing in the equation 7.

The Langmuir's equation can be linearized, yielding experimental values of the equilibrium constant K_A and maximum adsorption capacity q^{max} , according to Equation 8.

The Langmuir's isotherm is one of the most common models used to represent equilibrium behavior in the adsorption process. Its main concept proposes the uniformity in terms of surface adsorption sites with adsorption monolayers. Also considered independent interactions of neighboring sites and possibilities of dynamic equilibrium of adsorption and desorption (Fogler, 2002; Ruthven, 1984).

2.2 Freundlich's isotherm

It is an equilibrium model for indicating a greater degree of generalization of the adsorptive process. Now, it is considered the non-uniformity in terms of surface sites and multilayer adsorption (Ruthven, 1984). Its general expression for a single component system is represented by Equation 9, known as the Freundlich's Equation.

The Equation 9 assumes a linear form as shown in Equation 10.

The parameters of Equation 10 will be obtained experimentally. Being K the equilibrium constant feature of the Freundlich's isotherm and 1/n adsorption intensity.

2.3 Dubinin-Raduskevich's isotherm

Another adsorptive equilibrium model was also used in adsorption of phenol and BTEX in organoclay. This is the Dubinin-Raduskevich's model, represented by Equation 11 (Akçay, 2004, 2005).

The Dubinin-Raduskevich's isotherm represents a most comprehensive model, considering that the surface of the adsorbent is not homogeneous and that the interaction energy is not

constant. Being q the concentration of the adsorbate on the solid phase (mg g^{-1}), β the constant related to adsorption energy (mol² kJ-²), q^{max} the maximum adsorption capacity and ε the Polanyi potential, calculated according to Equation 12.

2.4 Kinetic models adsorptive

Some adsorptive kinetic models were used in different works of adsorption of organic compounds in organophilic clays, including models of Lagergren, also called models of pseudo-first order and pseudo-second order, represented by Equations 13 and 14 (Akçay, 2004, 2005; Cavalcanti et al., 2008; Yilmaz & Yapar, 2004).

Which Q_{eq} represents the equilibrium concentration in solid phase and Q the concentration in the solid phase over time, k_{1ads} (min-1) and k_{2ads} (g mg-1 min-1) the kinetic constants adsorptive related to models of pseudo-first order and pseudo-second order.

The analytical solution of Equations 13 and 14 are described by Equations 15 and 16 respectively.

According to the model represented by Equation 15, we can determine the kinetic constant of first-order k_{1ads} through the slope of the straight line plotted between ln (Q - Q_{eq}) versus t, and we can determine the kinetic constant of second-order k_{2ads} through the interception of Equation 16.

3. Utilization of organophilic smectite clays as adsorbents of phenol and BTEX compounds

Below, we highlight the study of the smectites clays, the main procedures to make them organophilic and its application as an adsorbent for phenol and BTEX.


3.1 General structure of smectite clays and their properties

The classic definition refers to clay as a natural material, earthy, fine-grained that when moistened with water features plasticity (Souza Santos, 2002). The clay minerals are hydrated silicates that have layered structure composed of solid sheets formed by

tetrahedral of silicon (or aluminum) and oxygen, and leaves formed by octahedral of aluminum (magnesium, iron), oxygen and hydroxyls. One way of classifying clays is related to the type of cation present in the octahedral sheet. If that is bivalent cation (such as Ca^{2+} or Mg^{2+}) all octahedral are occupied and the clay would be classified as type tri- octahedral. For trivalent ions (such as Al^{3+}), only 2/3 of the sites will be busy, so it is denominated as bioctahedral type clays. The nomenclature for the types of layers is a simple expression of the ratio between the tetrahedral sheets and octahedral sheets. Therefore, a 1:1 layer clay mineral has a tetrahedral and octahedral sheet, while a 2:1 clay mineral type has two tetrahedral sheets and one internal octahedral. The distance d_{001} is called interlayer distance and is also used to classify the different clays exist (Neumann et al., 2000).

The clay minerals are formed mainly of hydrated silicates of aluminum, iron and magnesium, containing certain amount of alkaline and alkaline earth elements (Rianelli & Pereira, 2001). Clays are minerals that have unique physical and chemical characteristics. They are formed by small crystals, usually in the form of hexagonal platelets, which agglutinates to form conglomerates. These platelets are composed of aluminosilicates organized, composed of the elements silicon, aluminum and oxygen, and others in smaller proportions, such as magnesium and iron. When hydrated, allows the separation of lamellar layers and intercalation of ions and molecules. The understanding of the properties of organized systems leads to interest in the study of systems consisting of the structured clays (Pastre et al., 2003). For being generally of sedimentary origin, the clay can contain a large number of other minerals, represented by grains of varying diameters, soluble salts and organic matter.

The clay minerals are subdivided into crystalline silicates with layer lattices or lamelar, and crystalline silicates with fibrous lattice structure, chain lattices. The silicates of lamellar structure can be divided into three groups or families: dimorphic (layer 1:1), trimorphic (layers 2:1) and tetramorphic (layers 2:2). The nomenclature 1:1 and 2:2 refers to the number of layers of SiO₄ tetrahedral and octahedral of hydroxides, respectively, entering the establishment of the unit cell of the crystalline lattice of clay minerals.

The paligorsquita or attapulgite and sepiolite are the only representatives of the fibrous structure of silicates.

The basal interplanar distance, the degree of substitution in the octahedral layer of the unit cell and the possibility of the basal layers to expand with the introduction of polar molecules are structural properties that allow the subdivision of lamellar structure of clay minerals.

The group of smectite clay minerals (montmorillonite, beidelita, nontronite, volconscoíta, saponite, sauconita, hectorita) is composed of two silicate tetrahedral sheets with a central octahedral sheet, joined by common oxygen atoms to the leaves, as shown in Figure 1. The leaves are continuous in the directions of crystallographic axes.




Fig. 2. Polycation not hydrated smectite clays and hydrated with sodium.

Sodium is the predominant exchangeable cation to increase the interlayer of smectite. The increase occurs by adsorption of water molecules by sodium, as shown in Figure 2.




Fig. 3. Development of organoclay treated with quaternary salt (Martins, 2007).

The clay treated with quaternary salts develops the ability to swell by adsorption of organic molecules, resulting in the organoclay, as shown in Figure 3.




Fig. 4. Oil well drilling - real situation (a) and hypothetical situation (b).

Sodium clays can be used as adsorbents of inorganic compounds, and also as a thixotropic agent for drilling of wells water-based. Organoclay can be used as adsorbents of organic compounds, and also as a thixotropic agent for drilling of wells oil-based. The thixotropic property of gels is extremely important in drilling for oil exploration because they promote increased service life of the drill, torque reduction, increased stability and temperature control in the well. In a general way, any outages in polls, the rocky debris produced by the action of the drill are kept in suspension in the fluid, preventing the loss of the pit of debris by sedimentation and subsequent burial of partial probing tools, as shown in Figure 4.

The group of kaolinite is formed by regular stacking 1:1, where each layer consists of a sheet of SiO_4 tetrahedra and a sheet of octahedra $Al_2(OH)_6$ linked together in a single layer through common oxygen.

Replacements of ions Si⁴⁺ leaves tetrahedral by ions of Al³⁺, or Al³⁺ by Mg²⁺ or Ca²⁺ in the leaves octahedral, are called substitutions isomorphic, and do not cause distortion in the structure of the lamellae, being all these atoms of similar size. In contrast, these substitutions generate an excess of negative charge in the layers of clay, which is responsible for some of the interesting properties of them. The excess negative charge is compensated by the adsorption of cations on the external surfaces of the layers, where the amount of adsorbed cations required to neutralize the negative charges in the layers of the material is measured by the cationic exchange capacity (CEC). This property is also related to the extent of isomorphic substitution. The CEC of the montmorillonite clays is between 40 and 150 meq (or mmol currently) per 100 g of clay (Gomes, 1988).

Clays are widely used as adsorbents due to its large surface area. On the other hand, its adsorption capacity for organic molecules, water soluble is very low. This is due to the hydrophilic nature of mineral surfaces. Treatment of clays with organic and inorganic reagents increases its adsorption capacity. The modified clays can be used as adsorbents in treatment systems of wastewater, thus preventing contamination of groundwater. The

potential of organically modified clays as adsorbents for organic contaminants effective in preventing and reducing pollution has stimulated studies on their adsorptive properties. The adsorption of organic compounds in organoclay occurs through several mechanisms, such as ionic reactions and complexation (Vieira et al., 2004).

The natural smectite clays, whose cation for exchange is sodium, produce gels that can be used as thixotropic agents in drilling fluids for oil wells based on water. Due to the hydrophilic environment on the surface, natural smectite is not an effective sorbent for nonionic organic compounds in water even if the clay has a high specific surface area. Reactions of ion exchange may greatly modify the surface properties of natural smectite. When, for example, organic cations of formula (CH₃)₃NR⁺, where R is an alkyl hydrocarbon, occupy the local exchange of smectite, the surface properties transforms from hydrophilic to hydrophobic (Chiou et al., 1983). Once such organic cations are fixed on the surface of smectite, an organic phase is formed which is derived from the alkyl hydrocarbon. This effectively removes the nonionic organic compounds from water with hydrophobic interactions.

The modified clays are normally prepared using a quaternary ammonium cation of general formula: [(CH₃)₃NR]⁺ or [(CH₃)₂NRR']⁺ where R and R' are hydrocarbons. The adsorptive properties of clays depend on the molecular size of the groups R and R' (Bodocsi et al., 1997). When the sizes R and R 'are small, such as: -CH₃ and phenyl, such clays are classified as adsorbents. When R or R' are long-chain, these clays are classified as organophilic clays. Many studies indicate that polar organic compounds such as alcohols, amines and ketones were adsorbed on the clay interlayer spaces, and probably at the edges of clay particles by electrostatic attractions and by ion exchange reactions. Herbicides and insecticides can be also adsorbed by organophilic clays and become inactive.

One research revealed that treatment of smectite clays with quaternary ammonium salts in concentrations higher than their CEC corroborates with the increase in adsorptive capacity due to the setting of quaternary ammonium ions in the interlayer regions and in the external surface of clay minerals, with the possibility of their interlayer regions exceeds 4.0 nm, resulting in delamination of the clay (Menezes et al., 2007).

Researchs confirm the possibility of development of smectite clays in adsorptive properties of the sedimentary watershed of the Araripe-PE, from the establishment of optimal experimental conditions grounded in factorial planning and response surface analysis, as tools of optimization of the process of activation of the clays. These studies proved the existence of calcic smectite clays with potential to develop organophilic properties, present in the sedimentary watershed of various municipalities in the Northeast. These clays have naturally polycations, with a predominance of magnesium and calcium, which, after exchange for sodium, develops thixotropy (Baraúna, 2000). The results of tests conducted on clays of the region showed that: a) these clays are composed of groups of clay minerals smectite and kaolinite; b) the mineral assemblage consists essentially of the smectite group; c) the predominants exchangeable cations are calcium and magnesium; d) clays treated with sodium develops thixotropy, with your plastic viscosity in aqueous suspensions with a concentration equal to 4.86% by mass equal to 3.0 mPas. This result is close to that recommended by Petrobras which recommends, among other analysis, minimum plastic viscosity equal to 4.0 mPas (Petrobras, 1997a, 1997b, 1998a, 1998b).

Another academic work was consisted in the preparation of an organophilic adsorbent material, starting from five different types of clays taken from watershed located in the Northeast of Brazil, as follows: "Verde Lodo", "Bofe" and "Chocolate" taken from the municipality of Campina Grande, State of Paraíba; "Lagoa de Dentro" e "São Jorge", taken from the Plaster Pole of Araripe, Pernambuco's State. The fresh clay were treated with a solution of sodium carbonate in order to exchange the existing polycations in their interlayer regions by sodium in a batch reactor with different concentrations of this cation, contact time and temperature, according experimental design with a 23. As an answer to treatment with sodium carbonate, it was the reading of the viscosities of aqueous suspensions of plastic material with 4.86% by mass. The results showed that the clay Chocolate treated with sodium, in the best condition of the experimental planning, got a plastic viscosity equal to 4 mPas, according to the methodology described in Petrobras 1998a and Petrobras 1998b. Then, there was a treatment with quaternary ammonium salt (chloride hexa-decile-trimethyl-ammonium), and measured up to its apparent viscosity for dispersions in an oily medium containing 336 mL of 5391 Ultra-lub ester of Oxiteno and 84 mL of saturated solution of sodium chloride, with 2.4 g, 6.0 g, 9.6 g and 13.2 g of organoclay, resulting in 8.5, 10.0, 12.5 and 16.0 mPas, respectively, according to the methodology described in Petrobras 1997a and Petrobras 1997b. These results suggested that sodium clay and organoclay could be indicated as thixotropic fluids for drilling wells. Then, a study was conducted for adsorptive removal of phenol in synthetic wastewater using this organoclay produced. The results indicated a more than 80% removal of organic contaminants (Cavalcanti et al., 2009; Cavalcanti et al., 2010; Portela et al., 2008).

3.2 Adsorption of phenols and BTEX onto organoclays

Several physicochemical methods and biological have been used to remove organic compounds in industrial effluents. Application of membrane filtration systems and adsorption processes in water treatment and effluent was used by a group of researchers. They developed a system for removal of phenol from an aqueous solution through a combined process of ultrafiltration and adsorption using kaolinite and montmorillonite. The adsorption experiments were performed in batch with 0.2 g of clay and 100 mL of water contaminated in the range of variable concentration of the organic compound from 20 to 1000 mg L^{-1} , stirred for 12 h at 25°C. The results showed that the phenol removal efficiency was 80% and a maximum adsorption capacity equal to 40 mg g^{-1} (Lin et al., 2005).

Other survey was developed to increase the range of applicability of the clays in the treatment of organic waste present in wastewater. The retention properties by adsorption of volatile organic compounds such as phenol, chlorobenzene and orthoxylene by a geomaterial composed of bentonite, activated carbon, cement and a water-soluble polymer in different operating conditions were evaluated. The operation was performed in batch at 25°C, using phenol, orthoxylene and chlorobenzene, without further treatment. The solutions were prepared in concentrations ranging from 50 to 400 mg L-1 with 0.3 g of the adsorbent material in 50 mL of solution distributed in erlenmeyer flasks. After the equilibrium established, the contaminated samples were centrifuged for 20 min at 2000 rpm. The kinetic results obtained for adsorption of these compounds in geomaterial, an initial concentration of 100 mg L-1 indicated residual concentrations of orthoxylene, chlorobenzene and phenol, respectively 40, 30 and 20 mg L-1 for a balance established in 12 h (Kessaïssia et al., 2004).

Two researches studied the adsorptive properties of montmorillonite clay modified by tetrabutyl ammonium (Akçay, 2004, 2005). The adsorption of p-chlorophenol in this clay was done in batch with 20 mL of pollutant solution to 0.1 g of clay, at 25°C for 16 h. The adsorption isotherms were adjusted according to the models of Freundlich and Dubinin-Radushkevich. The kinetic and thermodynamic parameters pointed to the application of organoclay as adsorbent effective of phenolic compounds in contaminated effluents.

Essays observed the adsorption, in batch, of phenolic compounds such as phenol and the isomers 2, 3 and 4-chlorophenol in smectite clays treated with chloride of tetra-methyl ammonium (TMA) and bromide of tetra-methyl-phosphonium (TMP). The experiments were performed with 100 mg of clay in solutions of adsorbate equal to 0.02 to 0.15 (mmol/100mL) in erlenmeyer of 250 mL, at 20°C. It was found that the smectite clay treated with TMP was better than the same adsorbent treated with TMA (Lawrence et al., 1998).

Other research confirmed the influence of the modification of bentonite in their adsorptive properties. The adsorption isotherms were determined with solutions of phenol in concentrations 50 mg L-1 to 1000 mg L-1, in pH 6.5, at 20°C and 24 h. Structural changes were carried out with tetra-decyl-trimethyl-ammonium bromide (TDTAB) and hexa-decyl-trimethyl-ammonium bromide (HDTAB), with changes in 25%, 50% and 100% of capacity exchange cation. The equilibrium time was approximately 7 h and kinetic results indicated the possible presence of heterogeneous regions on the surfaces of clays modified with 25% and 50% of its cation exchange capacity. The clays modified with TDTAB and HDTAB in 100% obtained the best results for the removal efficiencies (Yilmaz & Yapar, 2004).

Studies evaluating the adsorptive efficiency in modified bentonite to remove aromatic compounds (BTEX) present in aqueous solutions were performed. The results showed that the agent "dimethyl di-hydrogenated" increased the basal spacing of bentonite in 119%. The study demonstrated that the removal efficiency by adsorption to the compounds, benzene, toluene, ethyl benzene and o-xylene was 75%, 87%, 89.5% and 88.5%, respectively (Bodocsi et al., 1997).

In another study were investigated the effects of phenol in adsorptive organoclay with different characteristics. The adsorption experiments were performed in batch with 0.2 g of modified clay with 22 mL of phenol solution at pH 7 for 4 h. The equilibrium time, in preliminary studies pointed 2 h. The results showed the influence of modified clays in adsorptive power. According to the author, a change in the smectite interlayers increased the effectiveness of interactions between the phenol and the organoclay. Therefore, this clay is an effective adsorbent material for removal of nonionic organic compounds (Shen, 2005).

The organoclay dicetyldimethylammonium-bentonite was studied for adsorption of the compounds BTEX (nonionics and nonpolar) and of the compounds 2-chlorophenol, 2,4-dichlorophenol and 2,4,6-trichlorophenol (ionizables and polars). An experiment showed this preference in the adsorptive efficiency order: benzene < toluene < ethyl benzene < ortho-xylene; phenol < 2-chlorophenol < 2,4-dichlorophenol < 2,4,6-trichlorophenol (Irene et al., 2006).

3.3 Factors that can influence the process adsorptive

Some authors investigated physical factors that can interfere with the adsorptive process, such as pH and temperature, interfering on the steady state (Cavalcanti et al., 2009; Irene et al., 1998; Lin et al., 2005; Vianna et al., 2001).

3.3.1 Influence of pH

The rejection of the removal of phenol and o-cresol was related to the increase in pH of the system. For phenol, the rejection at the kaolinite was at pH 8.2, while for montmorillonite at pH 9.1. For o-cresol, the maximum rejection at the kaolinite was at pH 9.2, while for montmorillonite at pH 10.2. This result can be explained by the difference between the pKa of the phenolic compounds and the zeta potential of clays (Lin et al., 2005).

Studying the influence of pH on the adsorptive process, it was observed that changing the pH (5, 7, 9) was not as relevant for changes in the adsorption isotherms of BTEX compounds in "DCDMA-bentonite" (dicetyldimethylamonium-bentonite). The result observed is not due to dependence on pH with the adsorptive process, but the forces of attraction between molecules of BTEX and sites of modified clay. For phenol, this research group concluded that the change of pH (5, 7, 9), leads to a slight change in the adsorption isotherms. The increase in pH decreases the affinity of the clay used with phenol. This is due to the fact that the lower the pH in relation to the p K_a of phenol, there will be smaller fractions of phenol in the ionized form (Irene et al., 1998). This same result was identified in another research that used organophilic clay with chloride-hexadecyl-trimethyl-ammonium. This work used three pH values in the system clay-phenol, and they were 7.0, 8.3 (representing the natural state) and 9.0. The results indicated that at pH 7.0, there was better adsorption efficiency. The pKa of phenol is 9.95 (Teng & To, 2000), so when the pH of the system is below this value, the phenol is not completely disassociated with negative charges. However, the zeta potential of the organoclay was increasingly negative as the pH increases, so it is expected that there is at alkaline pH favoring the desorption process at equilibrium, due to electrostatic repulsion on the surface of the adsorbent (Cavalcanti et al., 2009).

3.3.2 Influence of temperature

It was found that the increased of temperature in the system clay-phenol, using 30°C and 40°C discourages the adsorptive process. At high temperatures there is a greater solubility of phenol in water, shifting the equilibrium towards of dessorption (Cavalcanti et al., 2009). Using organoclay as adsorbent effluent derived from the stillage, such as phenol, dextran, glucose, fructose, glycerin and glycine, it was observed that the phenol appeared as the more adsorbed substance, in more low temperature, comparing 33°C and 43°C (Vianna et al., 2001).

4. Conclusion

According to several studies cited, it is possible to use effective organophilic clays as adsorbents for the removal of organic substances with high toxicity, such as phenols and BTEX compounds.

The smectite clays are formed by a region called interlayer region, endowed with various inorganic cations, giving it a hydrophilic nature. The replacement of inorganic cations by organic cations, through ion exchange, creates the organoclays, which are effective adsorbents of organic compounds, having many environmental and technological applications.

In addition to the structure and size of the quaternary ammonium ion, density and orientation of alkyl groups on the surface of the clays are determining factors in the interactions between modified clays and organic compounds. Consequently, the mechanisms that control these interactions depend on the type of cation that forms. The observations suggest the use of organoclays as adsorbents of organic compounds in contaminated water.

To obtain organophilic clays, the natural clays can be initially treated by replacement of your different cations, by sodium cation. And after, the organoclays can be treated by organic cations, such as quaternary ammonium.

Alterations in physicochemical adsorptive system, such as temperature and pH can to influence the efficiency of the process. It was seen that in some citations the decreased of pH favored the adsorptive process of phenol but did not changed significantly the adsorption of BTEX. In addition to pH, the increased of temperature also seemed to be relevant, shifting the equilibrium towards desorption, decreasing the adsorptive efficiency.

Among the isotherms that portray the adsorptive equilibrium, the Langmuir isotherm, Freundlich and Dubinin-Raduskevich were cited. For the adsorptive kinetic models, stand out the Lagergren, in models of pseudo-first order and pseudo-second order.

Alternative methods for removing harmful substances to the environment should be diffused and increasingly applied, decreasing the concentration of industrial effluents and decreasing costs.

Prediction of the Biodegradation and Toxicity of Naphthenic Acids

1. Introduction

Crude oil is a complex mixture of hydrocarbons, basically composed of aliphatic, aromatic and asphaltene fractions along with nitrogen, sulfur and oxygen-containing compounds. The constituent hydrocarbon compounds are present in varied proportion resulting in great variability in crude oils from different sources (Speight, 1999). There are several reports indicating the recalcitrance and potential health hazards of the different constituents of crude oil (Kanaly&Harayana, 2000). These compounds have been reported to be carcinogenic, mutagenic and have immunomodulatory effects on humans, animals and plant life (van Gestel et al., 2001; Miller& Miller, 1981). The sites contaminated with hydrocarbons are ecologically important locations as one may encounter microbial flora of diverse nature, which may be potential candidates for important industrial processes (Jain et al., 2005).

The microorganisms possess the greatest enzymatic diversity found on earth and metabolize millions of organic compounds to capture chemical energy for growth. This metabolism, called catabolism or biodegradation, is the principal driving force in the degradative half of the earth's carbon cycle (Dagley, 1987). Microorganisms are increasingly used in engineered systems to biodegrade hazardous, xenobiotic compounds, an application commonly known as bioremediation (Alexander, 1994).

There have been numerous efforts to predict both the biodegradability or the pathway(s) of biodegradation for a given compound under a given set of conditions, typically either aerobic or anaerobic (Boethling et al., 1989; Parsons& Govers, 1990; Howard et al., 1991; Klopmann et al., 1995; Damborsky, 1996; Punch et al., 1996). Most of the efforts have been rule based, drawing general conclusions about what structures would or would not be readily biodegraded. Some only address whether a compound will be biodegraded and, if so, will biodegradation proceed slowly or quickly. The expert system projects, META (Klopmann et al., 1995) and BESS (Punch et al., 1996), also seek to determine at least one plausible biodegradation pathway.

Biodegradation pathway prediction requires the use of biochemical knowledge sometimes called metabolic logic. This requires knowledge of:

• organic functional groups to match a new chemical structure to one whose metabolism is already known;

 intermediary metabolism pathways to deduce how a new biodegradation can funnel a metabolite into a common pathway most efficiently;

- microbial enzymatic reactions to match a given reaction with a known enzyme;
- organic chemistry reactions to deduce what new reactions are chemically plausible to decompose a compound when precedents are not available.

Scientists studying biodegradation acquire this knowledge and these skills through many years of study and experimentation. This requires a means of organizing biodegradation reactions in some systematic fashion (Wackett& Ellis, 1999).

The University of Minnesota Biocatalysis/ Biodegradation Database (UM-BBD) began in 1995 and now contains information on almost 1200 compounds, over 800 enzymes, almost 1300 reactions and almost 500 microorganism entries. Besides these data, it includes a Biochemical Periodic Table (UM-BPT) and a rule-based Pathway Prediction System (UM-PPS) that predicts plausible pathways for microbial degradation of organic compounds (Gao et al., 2010). The inherent biodegradability of these individual components is a reflection of their chemical structure, but is also strongly influenced by the physical state and toxicity of the compounds. Therefore, the physical state is that strongly influences their biodegradation (Bartha& Atlas, 1977).

Naphthenic acid are most significant environmental contaminants. They are comprised of a large collection of saturated aliphatic and alicyclic carboxylic acids found in hydrocarbon deposits (petroleum, oil sands bitumen, and crude oils). Moreover, they are toxic components in refinery wastewaters and in oil sands extraction waters. In addition, there are many industrial uses for naphthenic acids, so there is a potential for their release to the environment from a variety of activities. Studies have shown that naphthenic acids are susceptible to biodegradation, which decreases their concentration and reduces toxicity.

They are described by the general chemical formula $C_nH_{2n+Z}O_2$, where n indicates the carbon number and Z is zero or a negative, even integer that specifies the hydrogen deficiency resulting from ring formation. Naphthenic acids have dissociation constants, which is typical of most carboxylic acids. Naphthenic acids are non-volatile, chemically stable, and act as surfactants (Seifert, 1975).

The presence of naphthenic acids in the environment is seldom studied and little is known about their fate. The investigations that used actual naphthenic acids focused on the biodegradation of these compounds as a group, because current analytical methods do not allow the study of individual compounds in the complex mixture. The aim of this study was to predict the biodegradation of the individual naphthenic acids and the possible toxicity of the parent structure and their metabolites. The software used for prediction of the microbial metabolism (biodegradation) of the naphthenic acids is the OECD (Q)SAR Application Toolbox (OECD (Q)SAR Project). The Toolbox is a software application intended to be used by governments, chemical industry and other stakeholders in filling gaps in (eco) toxicity data needed for assessing the hazards of chemicals. Degradation pathways used by microorganism to obtain carbon and energy from 200 chemicals are stored in a special file format that allows easy computer access to catabolic information. Most of pathways are related to aerobic conditions. Single pathway catabolism is simulated using the abiotic and enzyme-mediated reactions via the hierarchically ordered principal molecular transformations extracted from documented metabolic pathway database. The hierarchy of

the transformations is used to control the propagation of the catabolic maps of the chemicals. The simulation starts with the search for match between the parent molecule and the source fragment associated with the transformation having the highest hierarchy.

2. Biodegradation of naphthenic acids

Naphthenic acids are highly toxic, recalcitrant compounds that persist in the environment for many years, and it is important to develop efficient bioremediation strategies to decrease both their abundance and toxicity in the environment. However, the diversity of microbial communities involved in naphthenic acid-degradation, and the mechanisms by which naphthenic acids are biodegraded, are poorly understood. This lack of knowledge is mainly due to the difficulties in identifying and purifying individual carboxylic acid compounds from complex naphthenic acid mixtures found in the environment, for microbial biodegradation studies.

2.1 Microbial degradation of naphthenic acids

Due to the high degree of complexity of the natural naphthenic acid mixtures and a lack of sources of individual naphthenic acid compounds, surrogate naphthenic acids were used in early microbial degradation studies (Herman et al., 1993; Herman et al., 1994, Lai et al., 1996). Naphthenic acids are acutely toxic to a range of organisms (Clemente& Fedorak, 2005; Headley& McMartin, 2004). MacKinnon and Boerger (MacKinnon& Boerger, 1986) demonstrated that with chemical and microbiological treatment approaches, the toxicity of tailings water could be reduced, presumably by removal or biodegradation of Naphtehic acids, although this was not shown directly. Herman et al. (Herman et al., 1994) followed biodegradation of naphthenic acids extracted from Mildred Lake Settling Basin (Syncrude) in laboratory cultures and also observed detoxification, as determined by the Microtox method. Clemente et al. (Clemente, MacKinnon& Fedorak, 2004) used enrichments of naphthenic acid-degrading microorganisms to biodegrade commercially available naphthenic acids (Kodak Salts and Merichem). Microtox analyses of culture supernatants revealed a reduction in toxicity after less than 4 weeks of incubation (Clemente, MacKinnon& Fedorak, 2004).

2.2 Microbial degradation prediction of naphthenic acids

The software used for prediction of the microbial metabolism (biodegradation) of petroleum thiophene is the OECD (Q)SAR Application Toolbox. The Toolbox is a software application intended to be used by governments, chemical industry and other stakeholders in filling gaps in (eco) toxicity data needed for assessing the hazards of chemicals. The Toolbox incorporates information and tools from various sources into a logical workflow (OECD (Q)SAR Project).

Degradation pathways used by microorganism to obtain carbon and energy from 200 chemicals are stored in a special file format that allows easy computer access to catabolic information. The collection includes the catabolism of C1-compounds, aliphatic hydrocarbons, alicyclic rings, furans, halogenated hydrocarbons, aromatic hydrocarbons and haloaromatics, amines, sulfonates, nitrates, nitro-derivatives, nitriles, and compounds containing more than one functional group. Most of pathways are related to aerobic

conditions. Different sources including monographs, scientific articles and public web sites such as the UM-BBD (Ellis, Roe & Wackett, 2006) were used to compile the database.

The original CATABOL simulator of microbial metabolism is implemented in the OECD (Q)SAR Application Toolbox (Jaworska et al., 2002; Dimitrov et al., 2002; Dimitrov et al., 2004). Single pathway catabolism is simulated using the abiotic and enzyme-mediated reactions via the hierarchically ordered principal molecular transformations extracted from documented metabolic pathway database. The hierarchy of the transformations is used to control the propagation of the catabolic maps of the chemicals. The simulation starts with the search for match between the parent molecule and the source fragment associated with the transformation having the highest hierarchy. If the match is not found search is performed with the next transformation, etc. When the match is identified, the transformation products are generated. The procedure is repeated for the newly formed products. Predictability (probability that the metabolite is observed, given that the metabolite is predicted) evaluated on the bases of documented catabolism for 200 chemicals stored in the database of "Observed microbial catabolism" is 83%.

In this work will be researched the possible metabolites (observed and predicted) for some naphthenic acids. For this aim we will use the OECD (Q)SAR Application Toolbox system. Predictions are based on biotransformation rules that, in turn, are derived from reactions found in the UM-BBD and the scientific literature. The UM-PPS most accurately predicts compounds that are similar to compounds with known biodegradation mechanisms, for microbes under aerobic conditions and when the compounds are the sole source of energy, carbon, nitrogen or other essential elements for these microbes. Results in the OECD (Q)SAR Application Toolbox system are presented in Table 1.

3. Toxicity of naphthenic acids

Napthenic acids likely behave as surfactants as they consist of a hydrophilic head and a hydrophobic tail giving them unique solubility properties (Ivanković & Hrenović, 2010). These compounds are commonly found in detergents or cleaning products used in mining, oil, food and textile industries (Sandbacka, Christianson & Isomaa, 2000). Untreated industrial effluents often contain surfactants or surfactant-like compounds in concentrations sufficient to elicit acute toxicity in aquatic organisms (Ankley& Burkhard, 1992). Investigation into the influence that molecular structure exerts on the toxicity of naphthenic acid revealed that the observed acute toxicities for naphthenic acid-like surrogates to aquatic organisms rise with increasing Molecular weight and decreased with greater carboxylic acid content (Frank et al., 2009). These results suggested that the acute toxicity of naphthenic acid was influenced by hydrophobicity, thereby supporting narcosis as the probable mode of action (Kőnemann, 1981). Chemicals acting by a nonpolar narcotic mode of action are biologically unreactive, and their toxicity acts as a function of their concentration at the site of action, typically the cellular membrane (Cronin & Schultz, 1997).

Persistent Organic Pollutants (POPs) and Persistent, Bioaccumulative and Toxic (PBT) substances are carbon-based chemicals that resist degradation in the environment and accumulate in the tissues of living organisms, where they can produce undesirable effects on human health or the environment at certain exposure levels (Pavan & Worth, 2006).

3.1 Toxic prediction of naphthenic acids

Naphthenic acids have been reported to be acutely toxic to various organisms. However, the critical mechanism of toxicity remains largely unknown. Naphthenic acids are persistent in aquatic environments and are acutely toxic to aquatic bacteria, invertebrates, fish, and plants (Clemente & Fedorak, 2005]. Narcosis has been suggested to be the probable mode of acute toxicity by naphthenic acids, particularly for lower molecular weight of naphthenic acids. Higher molecular weight of naphthenic acids are less acutely toxic than lower molecular weight of naphthenic acids. Toxicity of naphthenic acids is inversely proportional to carboxylic acid content within naphthenic acid structures of higher molecular weight of naphthenic acids (Frank et al., 2009). Toxicity of naphthenic acids is also related to the amount of naphthenic acid that can be accumulated into the organisms as well as their inherent toxic potency.

In general, the complex and changing nature of mixtures of naphthenic acids make it difficult to predict toxicity. By determining the critical mechanism of toxicity of naphthenic acids, it might be possible to develop more effective predictive relationships to account for the toxic effects observed in living organisms exposed to naphthenic acids.

3.1.1 Use methods for toxic prediction of naphthenic acids

The PBT Profiler is a screening-level tool that provides estimates of the persistence, bioaccumulation, and chronic fish toxicity potential of chemical compounds. It is designed to be used when data are not available. In order to help interested parties make informed decision on a chemical's PBT characteristics, the PBT profiler automatically identifies chemicals that may persistent in the environment and bioaccumulate in the food chain. These chemicals are identified using thresholds published by the EPA (PBT Profiler).

The PBT Profiler combines the persistence criteria for water, soil, and sediment and highlights chemicals with an estimated half-life ≥ 2 months and < 6 months as persistent and those with an estimated half-life ≥ 6 months as very persistent. The half-life in air is not used in the PBT Profiler's Persistence summary (chemicals with an estimated half-life > 2 days are considered as persistent). The PBT Profiler uses 30 days in a month for its comparisons.

The PBT Profiler combines the bioaccumulation criteria and highlights chemicals with a BCF \geq 1000 and \leq 5000 as bioaccumulative and those with a BCF \geq 5000 as very bioaccumulative.

To highlight a chemical that may be chronically toxic to fish, the PBT profiler uses the following criteria: Fish ChV (Chronic Value) > 10 mg/l (low concern), Fish ChV = 0.1 - 10 mg/l (moderate concern) and Fish ChV < 0.1 mg/l (high concern).

Toxicity values of some naphthenic acids to Tetrahymena pyriformis were obtained from the literature (Schultz, 1997) and reported in Table 3. Population growth impairment was assessed after 40h with the common ciliate *Tetrahymena pyriformis*. The experimental data for rat (oral LD50 values) were collected from the literature (ChemIDplus).

Data for the logarithm of the 1-octanol-water partition coefficient (log P) were obtained from the KOWWIN software (US EPA, KOWWIN). Where possible measured log P values were verified and used in preference to calculated values.

In this study several models were used for non-polar compounds to aquatic and terrestrial species to determine the acute toxicity of selected naphthenic acids (Tables 3).

The property - excess toxicity - was used to define the toxicity of chemicals (reactive or nonrective) (Lipnick, 1991). The extent of excess toxicity was determined as the toxic ratio (TR), which was calculated by the following equations 3-4 (Lipnick, 1991, Nendza & Müller, 2007):

3.1.2 Results and discussion

The results of estimation of naphthenic acids for persistence, bioaccumulation and toxicity are presented in Table 2. The components of naphthenic acids are commonly classified by their structures and the number of carbon atoms in the molecule.

Naphthenic acids are a family of carboxylic acid surfactants, primarily consisting of cyclic terpenoids used in source and geochemical characterisation of petroleum reserves (Brient, Wessner & Doyle, 1995). The compound group is composed predominately of alkyl-substituted cycloaliphatic carboxylic acids with smaller amounts of acyclic aliphatic (paraffinic or fatty) acids. Aromatic olefinic, hydroxyl and dibasic acids are also present as minor components of naphthenic acids. The cycloaliphatic acids include single rings and fused multiple rings.

The PBT profiler uses a well-defined set of procedures to predict the persistence, bioaccumulation, and toxicity of chemical compounds when experimental data are not available. The persistence, bioaccumulation, and fish chronic toxicity values estimated by the PBT profiler are automatically compared to criteria published by the EPA.

Analysis of data in Table 2 reveals that as all naphthenic acids are not persistence, bioacculumative and toxic (Fish ChV), but some compounds are exception about their chronic toxic. The compounds with moderate toxic (0.1-10 mg/l) are decanoic and cyclohexanepentanoic acids.




Fig. 1. Plot of toxicity to Tetrahymena pyriformis vs log P for naphthenic acids showing baseline toxicity.

All organic chemicals have the potential to cause narcosis. Their ability to do so is mainly governed by their concentration and their ability to cause more serious toxic effects, which would mask any narcotic effect the chemical may cause (van Wezel & Opperhuizen, 1995). The toxicity is not observed to be related to hydrophobicity and is in excess of baseline toxicity for the more compounds (Fig. 1 and Table 3).

On the basis of calculated and experimental values for acute toxicity, the toxicity ratio (TR) as the ratio of the calculated baseline toxicity over the experimentally determined value was calculated (Table 3). A TR-value less than one could indicate rapid hydrolysis and/or biotransformation of the parent compound by the organism to non-toxic metabolites (Aptula & Roberts, 2006).

3.2 Toxic prediction of their metabolites

The reactions should be considered as an approximation of the real catabolism by mixed cultures of bacteria. Each chemical transformation includes source fragment (transformation target) and its bidegradation products. Results of possible metabolism (observed and predicted) for some selected naphthenic acids, the EcoSAR classification of their metabolites

and protein binding in the OECD (Q)SAR Application Toolbox system are presented in Table 4.

4. Conclusion

Naphthenic acids can enter the environment from both natural and anthropogenic processes. Naphthenic acids are highly toxic, recalcitrant compounds that persist in the environment for many years, and it is important to develop efficient bioremediation strategies to decrease both their abundance and toxicity in the environment. However, the diversity of microbial communities involved in naphthenic acid-degradation, and the mechanisms by which naphthenic acids are biodegraded, are poorly understood. This lack

of knowledge is mainly due to the difficulties in identifying and purifying individual carboxylic acid compounds from complex naphthenic acid mixtures found in the environment, for microbial biodegradation studies. Further, the persistence and fate of naphthenic acids in the environment is not well documented due to a lack of adequate analytical methods to determine the concentration, composition and extent of these crude-oil based compounds in environmental samples. This lack of knowledge constitutes a critical gap in scientific understanding. Acute toxicity is one of endpoints used in environmental risk assessment to determine the safe use and disposal of organic chemicals.

Degradation by the action of microorganisms is one of the major processes that determines the fate of organic chemicals in the environment. Quantitative Structure-Activity Relationships (QSAR) methods can be applied to biodegradation. Such relationships, often referred to as Quantitative Structure-Biodegradability Relationships (QSBRs), relate the molecular structure of an organic chemical to its biodegradability and consequently aid in the prediction of environmental fate.

1. Introduction

In daily work, employees why always there will be some unsafe behavior, the main reason is enterprise managers in the safety cognition concept is still not aware of the employee behavior of the importance of safety, thus let employees formed "see be used to, dry to, used to" idea, the idea for a good safe for behavior is an advantage, but for unsafe behavior as it may cause an accident. So from safety cognition concept to looking for reasons of the occurrence unsafe behavior, thus looking for breach in behavior safety management, through the application of behavior safety management tools, regulate employee behavior of work.

2. Widespread safety cognitive concept

Thought Analysis of petroleum and petrochemical enterprise field work activities, observe homework personnel work behavior and interview with the staff, using the research methods of system theory, research and get enterprise employees and managers widespread security cognitive concept.

Through the analysis of the safety of the employees and managers cognitive concept, we find inconsistency in the enterprise employees and managers. From the two aspects to this paper discusses enterprise employees and managers of the safety cognitive concept.

- 1. Employees of the cognitive concept generally
 In the enterprise, the staffs exist in the following cognition about unsafe behavior:
 - Unsafe behavior can improve the work efficiency.
 - Unsafe behavior may not cause an accident.
 - If know accident, or should be safety work.

Due to the shortcut and less effort to finish the job is the instinct of a man. In the work it will often be not according to procedures system operating practices, this operations mostly are unsafe behavior. 



Fig. 1. Employee of safety consciousness and time relationship.

In conventional practice, employees of risk in cognitive on one hand is to rely on their own in the process of operation risk know common sense, On the other hand is enterprise managers for enterprise of various kinds of activities of the risk of system analysis and understanding, and through different means told operators, such as shift-overlap before operation, safety identification tips, Into the factory education, etc. But because the employee safety consciousness, they lack the necessary risk cognitive common sense. This is the main causes of the unsafe behavior. Thus, it can come to the employees of safety cognitive mode (see fig 2).

- Managers of the cognitive concept generally
 In the enterprise, the managers exist in the following cognition about unsafe behavior:
 - Unsafe behavior is the key link, mechanical intergrity is the basis of production safety
 - If unsafe behavior gradually spread, it will make the vicious cycle of production safety. If unsafe behavior gradually reduced, it will push the virtuous cycle of production safety.

From the view of the managers, unsafe behavior of accidents will increase enterprise's safety management of pressure and affect the normal operation of the enterprise, further influence enterprise overall efficiency. At the same time, under pressure in the business, some managers will have to take the measures put into lower safety, but if the safety input is reduced, it will affect the equipment of intrinsically safe and safety training, this will cause unsafe behavior and the unsafe condition of the increase. It will lead to the increase of the accidents and form the vicious circle.




Fig. 3. Managers of Cognitive model.

On the contrary, if the managers take measures to reduce unsafe behavior and unsafe condition, it will lower accident rates. The managers can put the energy and resources into equipment of intrinsically safe and employee safety quality improvement. It will further enhance the enterprise the overall level of safety management. Thus, it can come to the managers of safety cognitive mode (see fig 3).

Safety needs the managers and employees involved in. The managers and employees follow the principle of uniform management and form the common perception mode. Eliminate unsafe behavior is the key to prevent accidents. Eliminate unsafe behavior is the enterprise safety development necessary means. Eliminate unsafe behavior is everyone's responsibility. Only in form the correct on the basis of common cognitive mode, the system of safety management can be enforced, the safety management measures can be truly carried out. Through the model the virtuous cycle of their own, it can improve the device of essence safety, it can strengthen and standardize the safety of the employees behavior. It will radically reduce or eliminate unsafe condition of object and the unsafe behavior of the people, so as to achieve the purpose of reducing and put an end to the accidents.

We analysis the concept of the common safety cognitive purpose that is to through the HSE idea infusion, safety culture atmosphere build, formation and strengthen the correct cognition model, standard work behavior, find and eliminate unsafe behavior and unsafe condition. At the same time, it makes enterprise employees and managers know to eliminate unsafe behavior and unsafe condition. It not only need to the employees own safety consciousness and homework habit of ascension, but also need to enterprise managers in the construction of safety culture, safety input, etc to ascend, and take effective measures and means of management, to reduce the man-made accidents. It will promote the enterprise the safety operation level from the whole.




Fig. 4. Common cognitive model.

4. Effective solution

Through the common cognitive model that can be seen, in addition to model their internal circulation outside, the whole cycle graph of the external input have external safety policy, superior management requirements, external market pressure, external accidents and safety culture. For external accidents, it's just a short accident education process, it can't form long-term input to reduce the enterprise employees's unsafebehavior. But safety culture as a stable and effective long-term input, the enterprise through the safety culture construction and propaganda, it can gradually reduce the incidence of enterprise unsafe behavior and effectively reduce the accident rates.

The construction of safety culture of the enterprise is a long process, in the process of how to find and correct the employees of unsafe behavior, to gradually regulate the employees of safety behavior is particularly important. In this respect the effective method is to implement behavior safety management tools. This paper introduced at present in SINOPEC widely applied behavior safety management tool - HSE observation card.

HSE observation card is a method that is to encourage employees voluntarily observed the operating personnel behavior. Its purpose is to encourage safety behavior, stop and correct unsafe behavior. Through the effective communication, it can be to strengthen operation personnel to safety consciousness and standardize safety behavior. At the same time, it will see that the work environment and facilities and the use of tools, and found that and deal with unsafe condition of object, effectively avoid and reduce accident and the occurrence of injury.

5. Conclusion

If we will enhance safety culture and standardize employee safety behavior, it cannot leave the application of behavior-based safety management tools. The behavior-based safety management tools are an important means that is to effectively promote the safety culture of enterprise. At present, in SINOPEC comprehensive application of HSE observation tools, its core is to conduct field observation and analysis and communication, to interfere with the way or intervention, make people know the dangers of unsafe behavior, prevent and eliminate unsafe behavior.

Implementation of behavior safety management and correction employee in the work unsafe behavior, it is at home and abroad common practice in the industry. Through these tools and methods are to implement and promote, it can reduce the frequency of occurrence of employee unsafe behavior, thus it can avoid employees of unsafe behavior which led to the accident, and promote enterprise of safety performance.
